PREFACE

The Legislative Counsel's staff tabulates statistics of certain aspects of legislative activity during sessions of the Legislative Assembly. This report presents, in tabular form, a selected statistical summary of that activity during the 2024 regular session and compares it to similar activity during the 2007 – 2023 regular sessions and selected special sessions.

Some of the totals and percentages in the tables were reconciled when there were discrepancies in the source materials. However, no such adjustment was of a statistically significant nature.

† After 11 days of failing to achieve a constitutional quorum required to do business, on March 5, 2020, the Senate President adjourned the Senate until the call of the President, pursuant to Article IV, section 12, of the Oregon Constitution, and Senate Rule 3.01 (2). After 10 calendar days of failing to achieve a quorum, on March 5, 2020, the Speaker of the House adjourned the House of Representatives until 11:59 p.m. on March 8, 2020, in compliance with Article IV, section 12, of the Oregon Constitution. These actions functionally ended the work of the 2020 regular session, which expired at the end of the 35th calendar day (11:59 p.m., March 8, 2020), pursuant to Article IV, section 10, of the Oregon Constitution.
