Pursuant to the provisions of ORS 291.328, and acting under the authority of ORS 291.326(1)(a), (b), (c), and (d); ORS 291.371; and ORS 291.375; this hereby certifies that the Emergency Board, meeting via remote interface on July 14, 2020, took the following actions:

**1. Oregon Business Development Department
Department of Administrative Services**

Increased the Federal Funds expenditure limitation for the Department of Administrative Services initially established at the April 23, 2020 meeting of the Emergency Board by \$25,600,000, from funding made available to states through the Coronavirus Relief Fund for various COVID 19 response activities, programs, and services; including by \$23,100,000 for transfer to the Oregon Business Development Department and by \$2,500,000 for payment to the Pacific States Marine Fisheries Commission. Established an Other Funds expenditure limitation of \$23,100,000 for the Oregon Business Development Department for funding from the Coronavirus Relief Fund received by the Department of Administrative Services and transferred to the Oregon Business Development Department for business, innovation and trade, and authorized the establishment of five limited-duration positions (1.05 FTE), for providing financial assistance to small businesses affected by economic conditions associated with the COVID 19 pandemic and for administration of agency programs financed by the Coronavirus Relief Fund.

**2. Oregon Business Development Department
Department of Administrative Services**

Increased the Federal Funds expenditure limitation for the Department of Administrative Services initially established at the April 23, 2020 meeting of the Emergency Board by \$50,000,000, from funding made available to states through the Coronavirus Relief Fund for various COVID 19 response activities, programs, and services; including by \$25,984,872 for transfer to the Oregon Business Development Department and by \$24,015,128 for payments to arts organizations, cultural and community venues, and community colleges. Established an Other Funds expenditure limitation of \$25,984,872 for the Oregon Business Development Department for funding from the Coronavirus Relief Fund received by the Department of Administrative Services and transferred to the Oregon Business Development Department for business, innovation and trade, for providing financial assistance to arts organizations and cultural and community venues that have canceled or postponed public programming because of economic conditions and executive orders associated with the COVID-19 pandemic.

3. Department of Administrative Services

Increased the Federal Funds expenditure limitation established for the Department of Administrative Services at the April 23, 2020 meeting of the Emergency Board by \$62,000,000 from funding made available to states through the Coronavirus Relief Fund for a grant to The Contingent, an organization with pre-existing state contract relationships, in partnership with the Black United Fund, to be used for Black relief and resiliency.

**4. Department of Consumer and Business Services
Department of Administrative Services**

Increased the Federal Funds expenditure limitation for the Department of Administrative Services established at the April 23, 2020 meeting of the Emergency Board by \$30,000,000 from funding made available to states through the Coronavirus Relief Fund and established a \$30,000,000 Other Funds expenditure limitation for the Department of Consumer and Business Services, for funding from the Coronavirus Relief Fund received by the Department of Administrative Services and transferred to the Department of Consumer and Business Services to establish a Quarantine Time Loss program providing financial assistance for sick leave to certain workers that were not extended sick leave benefits under the Families First Coronavirus Relief Act.

5. Department of Administrative Services

Increased the Federal Funds expenditure limitation established for the Department of Administrative Services at the April 23, 2020 meeting of the Emergency Board by \$35,000,000 from funding made available to states through the Coronavirus Relief Fund for payments of emergency relief funds in the amount of \$500 on a one-time basis for any Oregon worker who has been impacted by job-related income loss because of the COVID-19 pandemic.

6. Secretary of State

Increased the Federal Funds expenditure limitation established for the Secretary of State by section 3, chapter 672, Oregon Laws 2019, by \$2,500,000, for election security enhancements in county election offices and to install and operate intrusion detection technology in each of the 36 counties.

7. Oregon Business Development Department

Established a General Fund appropriation by allocating \$3,580,000 from the Emergency Fund established by section 1, chapter 644, Oregon Laws 2019, to the Oregon Business Development Department, for infrastructure, for improvements to the Warm Springs Indian Reservation water and wastewater systems.
