### Certificate

Pursuant to the provisions of ORS 291.328, and acting under the authority of ORS 291.326(1)(a), (b), (c), and (d); ORS 291.371; and ORS 291.375; this hereby certifies that the Emergency Board, meeting via remote interface on October 23, 2020, took the following actions:

**2. Department of Administrative Services**

Allocated \$30,000,000 from the Emergency Fund established by section 1, chapter 644, Oregon Laws 2019, to supplement the appropriation established for the Department of Administrative Services at the April 23, 2020 meeting of the Emergency Board, for a grant to the Oregon Community Foundation to support shelter through grants to local organizations for the acquisition, retrofitting, and potential operation of hotel and motel properties in wildfire-affected areas, with the understanding that funds will be returned to the State Treasury by June 30, 2021 if unspent, and that the Department of Administrative Services and Oregon Community Foundation will report to the Legislature with the following information: identification of applicants, including operating partners; the number and location of units to be acquired; estimated costs of rehabilitation; requested grant amounts; payments of commissions and fees; identified matching funds; a summary of estimated operations expenses and sources of operating revenue; and timelines for occupancy.

**3. Housing and Community Services Department**

Allocated \$10,000,000 from the Emergency Fund established by section 1, chapter 644, Oregon Laws 2019, to supplement the appropriation made to the Housing and Community Services Department by section 1, chapter 642, Oregon Laws 2019, to support the provision of shelter and related services for homeless and displaced persons.

**4. Department of Education**

Established a General Fund appropriation by allocating \$7,439,725 from the Emergency Fund established by section 1, chapter 644, Oregon Laws 2019, to the Department of Education to be deposited in the Education Cash Account established in ORS 327.485 and disbursed by the Department of Education to school districts, education service districts, and public charter schools in the form of grants, loans, or other contracts, instruments, or methods; and increased the Other Funds expenditure limitation

established for the Department of Education by section 7(4), chapter 609, Oregon Laws 2019, All other grants, by \$7,439,725 to mitigate the cost of damages caused by recent wildfires and/or help students and their families to recover from the impacts of the wildfire.

**5. Department of Administrative Services**

Established a General Fund appropriation by allocating \$1,400,000 from the Emergency Fund established by section 1, chapter 644, Oregon Laws 2019, to the Department of Administrative Services for the procurement of a Statewide Alert System.

**6. Department of Transportation**

Established a General Fund appropriation by allocating \$50,000,000 from the Emergency Fund established by section 1, chapter 644, Oregon Laws 2019, to the Department of Transportation for Maintenance and emergency relief programs for ash and debris removal in the eight Oregon counties most impacted by the Labor Day wildfires; and increased the Other Funds expenditure limitation established for the Department of Transportation by section 2(2), chapter 614, Oregon Laws 2019, Maintenance and emergency relief programs, by \$295,700,000 for removal of trees burned by the wildfires and that pose a danger to travelers on roads and highways.

**7. Legislative Fiscal Office and Department of Administrative Services**

Acknowledged receipt of reports on the expenditure of funding from the Coronavirus Relief Fund and the CARES Act.
