

such mature stalks (except the resin extracted therefrom), fiber, oil or cake, or the sterilized seed of such plant which is incapable of germination.

(14) The term "isonipecaine" means the substance identified chemically as 1-methyl-4-phenylpiperidine-4-carboxylic acid ethyl ester, or any salt thereof by whatever trade name identified.

(15) The term "amidone" means any substance identified chemically as 4-4-diphenyl-6-dimethylamino-heptanone-3, or any salt thereof, by whatever trade name designated.

(16) The term "isoamidone" means any substance identified chemically as 4,4-diphenyl-5-methyl-6-dimethylaminohexanone-3, or any salt thereof, by whatever trade name designated.

(17) The term "keto-bemidone" means any substance identified chemically as 4-(3-hydroxyphenyl)-1-methyl-4-piperidyl ethyl ketone hydrochloride, or any salt thereof, by whatever trade name designated.

(18) "Narcotic drugs" means coca leaves, opium, Cannabis and every other substance neither chemically nor physically distinguishable from them; and other drugs to which the federal narcotic laws may now or hereafter apply; and any drug found by the State Board of Pharmacy, after reasonable notice and opportunity for hearing, to have addiction-forming or addiction-sustaining liability similar to morphine or cocaine, from the publication of such finding.

(19) "Federal narcotic laws" means the laws of the United States relating to opium, coca leaves and other narcotic drugs.

(20) "Official written order" means an order written on a form provided for that purpose by the United States Commissioner of Internal Revenue, under any laws of the United States making provision therefor, if such order forms are authorized and required by federal law, and if no such order form is provided, then on an official form provided for that purpose by the Board of Pharmacy.

(21) "Dispense" includes distribute, leave with, give away, dispose of or deliver.

(22) "Registry number" means the number assigned to each person registered under the federal narcotic laws.

475.010 As used in ORS 475.010 to 475.160, "narcotic drugs" shall have the meaning provided for such term in ORS 474.010."
