DRAFT

SUMMARY

Directs presiding judges of judicial districts within state to ensure proceedings before grand jury are recorded. Provides for phase-in of recording process based on population of district. Requires audio recording by clerk of court or reporting by shorthand reporter. Specifies matters that must be recorded and matters that may not be recorded.

Creates procedures for release of audio recordings or shorthand reporter reports. Provides process to request and enter protective order prohibiting or restricting access to recordings or reports. Specifies when recording or report, or transcript prepared from recording or report, may be used in court proceedings.

Allows statements of certain persons to be received through testimony of peace officer.

Prohibits release of grand jury proceeding recordings, reports or transcripts as public record.

Declares emergency, effective on passage.

- SECTION 1. (1)(a) The presiding judge of a judicial district with a 6
- population between 150,000 and 300,000 or over 700,000 shall ensure that 7
 - proceedings before the grand jury are recorded in the manner de-
- scribed in this section and section 2 of this 2016 Act. 9
- (b) The court shall provide and maintain suitable audio electronic 10 recording devices to record grand jury proceedings.
 - (c) The Chief Justice of the Supreme Court shall designate the types

- of audio electronic recording devices that are suitable for recording grand jury proceedings.
 - (d) The prosecuting attorney shall provide the court access to the premises in which the grand jury fulfills its obligations and the recording equipment used to carry out the provisions of this section and section 2 of this 2016 Act. The presiding judge of each judicial district may enter into an agreement with the prosecuting attorney that identifies the conditions and terms of access.
 - (2)(a) A clerk of the court shall be permitted to attend all proceedings of the grand jury for the purpose of electronically recording the proceedings described in section 2 of this 2016 Act.
- 12 (b) Notwithstanding paragraph (a) of this subsection, the court may, upon request of the prosecuting attorney or defense attorney, 13 appoint a certified shorthand reporter as defined in ORS 8.415 or a 14 shorthand reporter certified by a national certification association, 15 16 who shall be permitted to attend all proceedings of the grand jury for the purpose of taking accurate notes. The shorthand reporter's ser-17 vices shall be paid for by the party requesting the shorthand reporter. 18 The shorthand reporter shall be sworn to correctly report the pro-19 ceedings of the grand jury described in section 2 of this 2016 Act and 20 21 to keep secret any information concerning the grand jury proceedings.
 - (c) A clerk of the court or shorthand reporter is not subject to subpoena, and may not disclose any information, concerning the grand jury proceedings without prior court authorization.
 - (d) The presiding judge shall ensure that a criminal background check is conducted on a clerk of the court prior to the clerk's assignment to electronically record a grand jury proceeding pursuant to this section.
- (3)(a) A failure of an audio electronic recording device to accurately record all or part of a grand jury proceeding does not affect the validity of any prosecution or indictment.

- (b) A failure of a clerk of the court to operate an audio electronic recording device in a manner that accurately records all or part of a grand jury proceeding, as required, does not affect the validity of any prosecution or indictment.
- (c) A failure of a shorthand reporter to prepare accurate notes or an accurate report of all or part of a grand jury proceeding, as required, does not affect the validity of any prosecution or indictment.
 - (4) This section and section 2 of this 2016 Act do not apply to grand jury proceedings under ORS 132.440 that inquire into the condition and management of correctional facilities and youth correction facilities.
- SECTION 2. (1) Except as provided in subsection (2) of this section, the clerk of the court described in section 1 (2)(a) of this 2016 Act, or the shorthand reporter described in section 1 (2)(b) of this 2016 Act, who is recording grand jury proceedings in a judicial district with a population between 150,000 and 300,000 or over 700,000 shall record all matters that come before the grand jury, including:

- 18 (b) The names of witnesses appearing before the grand jury;
- 19 (c) Each statement made or question asked by the prosecuting at-20 torney;
- 21 (d) Each question asked of, and each response given by, a witness 22 who appears before the grand jury; and
 - (e) Any statements made by a grand juror who is examined as a witness as provided in ORS 132.350.
- 25 (2) The clerk of the court operating the audio electronic recording 26 device or the shorthand reporter reporting the grand jury proceedings 27 may not record or report:
- 28 (a) The deliberations or voting of the grand jury.
- 29 (b) A presentment made pursuant to ORS 132.370.
- 30 (c) A procedure related to the production of records, or the un-31 sealing of records, subpoenaed pursuant to ORS 136.583 and to be pre-

1 sented before the grand jury.

- 2 (d) The contents of confidential records unrelated to a crime alleged 3 in an indictment the grand jury is considering.
- 4 (3) The clerk of the court or the shorthand reporter shall file with 5 the court the audio recordings or the notes or reports of the shorthand 6 reporter.
 - SECTION 3. (1) Audio recordings and shorthand reporter notes and reports produced pursuant to sections 1 and 2 of this 2016 Act in a judicial district with a population between 150,000 and 300,000 or over 700,000 are confidential and may not be released by the court except as described in this section.
- (2) When an indictment resulting from grand jury proceedings is indorsed "a true bill," the audio recording of the grand jury proceedings or the notes or report of a shorthand reporter may be released only in the following manner:
 - (a) When the defendant has been arraigned on the indictment, the prosecuting attorney and the defense attorney may obtain a copy of the audio recording, notes or report:
 - (A) After 10 days have passed since the defendant's arraignment on the indictment and no motion described in paragraph (e) of this subsection has been filed; or
 - (B) In accordance with the court's ruling on the motion described in paragraph (e) of this subsection, if a motion has been filed.
- (b) Unless the court orders otherwise, the prosecuting attorney and 24 the defense attorney may not copy, disseminate or republish the audio 25 recording, notes or report, or a transcript prepared from the audio 26 recording, notes or report released pursuant to this subsection, except 27 to provide a copy to an agent of the prosecuting attorney or defense 28 attorney for the limited purpose of case preparation. Unless a court 29 orders otherwise for good cause shown, in consulting with the de-30 fendant the defense attorney may not disclose: 31

- (A) The address, telephone number, date of birth, driver license or vehicle registration information of a victim, witness or grand juror, obtained from a recording, notes, report or transcript; or
- (B) Any portion of a recording, notes, report or transcript that contains the address, telephone number, date of birth, driver license or vehicle registration information of a victim, witness or grand juror.
- (c) The defense attorney may not provide a copy of the audio recording, notes or report, or a transcript prepared from the audio recording, notes or report, to the defendant.
- (d) When the defendant has been arraigned but is not represented by an attorney, the defendant may request by motion that the court issue an order allowing the defendant access to review the contents of the audio recording, notes or report. A copy of the motion must be provided to the prosecuting attorney. The prosecuting attorney may request a hearing on the motion within seven days of receiving a copy. At the hearing, or in response to receiving the motion, the court may set reasonable conditions on the review of the audio recording, notes or report.
- (e) The prosecuting attorney, the victim or a witness may file a motion for a protective order no later than 10 days after the arraignment on the indictment. The prosecuting attorney may also file a motion for a protective order within 10 days of receiving a motion described in paragraph (d) of this subsection. The court may order that the defense attorney's or defendant's access to a copy of the audio recording, notes or report be denied, restricted or deferred or may make any other order upon a finding of substantial and compelling reasons for the order. In deciding whether to grant the motion and enter a protective order under this paragraph, the court may consider the following:
- 30 (A) Protection of witnesses and others from physical harm, threats 31 of harm, bribes, economic interference, reprisal and other forms of

1 intimidation;

- 2 (B) Maintenance of secrecy regarding informants, as required for 3 effective investigation of criminal activity;
 - (C) Confidential information recognized under law, including the protection of confidential relationships and privileges; and
 - (D) Any other relevant considerations.
 - (f) The court may permit the evidence of substantial and compelling circumstances described in paragraph (e) of this subsection to be made in the form of a written statement to be inspected by the court only or by oral testimony given on the record.
 - (3) When a grand jury inquires into the conduct of a public servant as defined in ORS 162.005 for acts occurring in the performance of the public servant's duties, and an indictment resulting from the grand jury proceedings is indorsed "not a true bill," a person may file a motion requesting a court order releasing all or a portion of the audio recording, notes or report. A copy of the motion must be served on the prosecuting attorney and the public servant's attorney, or the public servant if the public servant is not represented by an attorney. In deciding whether to issue such an order, the court shall determine whether the public interest in disclosure outweighs the interest in maintaining the secrecy of the grand jury proceedings. If the court orders disclosure, the court may place reasonable conditions upon copying, disseminating or republishing the audio recording, notes or report.
 - (4)(a) Except as provided in paragraph (b) of this subsection, when grand jury proceedings do not result in an indictment indorsed as either "a true bill" or "not a true bill," the audio recording or the notes or report of a shorthand reporter, or a transcript prepared from the audio recording, notes or report, produced pursuant to sections 1 and 2 of this 2016 Act may not be disclosed or released.
 - (b) When subsequent grand jury proceedings occur inquiring into

- 1 the same criminal episode as the grand jury proceedings described in paragraph (a) of this subsection, and the subsequent proceedings re-2 sult in an indictment indorsed as "a true bill," the prosecuting attor-3 ney shall provide notice to the person charged in the indictment of the occurrence of the earlier grand jury proceedings. After the person is 5 arraigned on the indictment and the time period described in sub-6 section (2)(a) of this section has passed, the audio recording, notes or 7 report produced during the earlier grand jury proceedings may be ob-8 tained in the manner set forth in subsection (2) of this section. 9
 - (c) As used in this subsection, "criminal episode" has the meaning given that term in ORS 131.505.

- (5) The Chief Justice of the Supreme Court may establish a fee under ORS 21.345 for the cost of providing a copy of any audio recording or shorthand reporter notes or report of a grand jury proceeding to a person requesting a copy under this section.
- (6) An audio recording, notes, report or transcript of a grand jury proceeding obtained pursuant to sections 1 and 2 of this 2016 Act:
- (a) May not be used as evidence in any subsequent proceeding, except as permitted under ORS 40.375, 40.380, 40.450, 40.460 or 40.465.
- (b) May not be used to challenge the indorsement of an indictment 20 "a true bill" or the proceedings that led to the indorsement. 21
- (c) May be used as evidence in a prosecution for perjury or false 22 swearing committed by a witness while giving testimony during the grand jury proceeding or during trial.
- (d) May be used as evidence in a proceeding for contempt of court 25 against a person alleged to have violated the terms of a court order 26 concerning the audio recording, notes, report or transcript. 27
- (7) The release of audio recordings, notes or reports of grand jury 28 proceedings under this section does not affect discovery obligations 29 under ORS 135.805 to 135.873. 30
 - **SECTION 4.** ORS 132.090 is amended to read:

- 132.090. (1) Except as provided in subsections (2) and (3) of this section and sections 1 and 2 of this 2016 Act, no person other than the district attorney or a witness actually under examination shall be present during the sittings of the grand jury.
- (2) Upon a motion filed by the district attorney in the circuit court, the circuit judge may appoint a reporter who shall attend the sittings of the grand jury to take and report the testimony in any matters pending before the grand jury, and may appoint a parent, guardian or other appropriate person 18 years of age or older to accompany any child 12 years of age or younger, or any person with an intellectual disability, during an appearance before the grand jury. The circuit judge, upon the district attorney's showing to the court that it is necessary for the proper examination of a witness appearing before the grand jury, may appoint a guard, medical or other special attendant or nurse, who shall be present in the grand jury room and shall attend such sittings.
- 16 (3) The district attorney may designate an interpreter who is certified under ORS 45.291 to interpret the testimony of witnesses appearing before 17 the grand jury. The district attorney may designate a qualified interpreter, 18 as defined in ORS 45.288, if the circuit court determines that a certified in-19 terpreter is not available and that the person designated by the district at-20 torney is a qualified interpreter as defined in ORS 45.288. An interpreter 21 designated under this subsection may be present in the grand jury room and 22 attend the sittings of the grand jury. 23
 - (4) No person other than members of the grand jury shall be present when the grand jury is deliberating or voting upon a matter before it.
- (5) As used in this section, "intellectual disability" has the meaning given that term in ORS 427.005. Intellectual disability may be shown by attaching to the motion of the district attorney:
- 29 (a) Documentary evidence of intellectual functioning; or
- 30 (b) The affidavit of a qualified person familiar with the person with an 31 intellectual disability. "Qualified person" includes, but is not limited to, a

- **SECTION 5.** ORS 132.320 is amended to read:
- 132.320. (1) Except as provided in subsections (2) to [(12)] (13) of this section, in the investigation of a charge for the purpose of indictment, the grand jury shall receive no other evidence than such as might be given on the trial of the person charged with the crime in question.
 - (2) A report or a copy of a report made by a physicist, chemist, medical examiner, physician, firearms identification expert, examiner of questioned documents, fingerprint technician, or an expert or technician in some comparable scientific or professional field, concerning the results of an examination, comparison or test performed by such person in connection with a case which is the subject of a grand jury proceeding, shall, when certified by such person as a report made by such person or as a true copy thereof, be received in evidence in the grand jury proceeding.
 - (3) An affidavit of a witness who is unable to appear before the grand jury shall be received in evidence in the grand jury proceeding if, upon application by the district attorney, the presiding judge for the judicial district in which the grand jury is sitting authorizes the receipt after good cause has been shown for the witness' inability to appear. An affidavit taken in another state or territory of the United States, the District of Columbia or in a foreign country must be authenticated as provided in ORS chapter 194 before it can be used in this state.
- 23 (4) A grand jury that is investigating a charge of criminal driving while 24 suspended or revoked under ORS 811.182 may receive in evidence an affidavit 25 of a peace officer with a report or copy of a report of the peace officer con-26 cerning the peace officer's investigation of the violation of ORS 811.182 by 27 the defendant.
- (5) A grand jury may receive testimony of a witness by means of simultaneous television transmission allowing the grand jury and district attorney to observe and communicate with the witness and the witness to observe and communicate with the grand jury and the district attorney.

- (6) A grand jury that is investigating a charge of failure to appear under ORS 133.076, 153.992, 162.195 or 162.205 may receive in evidence an affidavit of a court employee certifying that the defendant failed to appear as required by law and setting forth facts sufficient to support that conclusion.
- (7)(a) Except as otherwise provided in this subsection, a grand jury may receive in evidence through the testimony of one peace officer involved in the criminal investigation under grand jury inquiry information from an official report of another peace officer involved in the same criminal investigation concerning the other peace officer's investigation of the matter before the grand jury. The statement of a person suspected of committing an offense or inadmissible hearsay of persons other than the peace officer who compiled the official report may not be presented to a grand jury under this paragraph.
- (b) If the official report contains evidence other than chain of custody, venue or the name of the person suspected of committing an offense, the grand jurors must be notified that the evidence is being submitted by report and that the peace officer who compiled the report will be made available for testimony at the request of the grand jury. When a grand jury requests the testimony of a peace officer under this paragraph, the peace officer may present sworn testimony by telephone if requiring the peace officer's presence before the grand jury would constitute an undue hardship on the peace officer or the agency that employs or utilizes the peace officer.
- (8) A grand jury that is investigating a charge of failure to report as a sex offender under ORS 163A.040 may receive in evidence certified copies of the form required by ORS 163A.050 (2) and sex offender registration forms and an affidavit of a representative of the Oregon State Police, as keepers of the state's sex offender registration records, certifying that the certified copies of the forms constitute the complete record for the defendant.
- (9) The grand jury shall weigh all the evidence submitted to it; and when it believes that other evidence within its reach will explain away the charge, it should order such evidence to be produced, and for that purpose may re-

- 1 quire the district attorney to issue process for the witnesses.
- 2 (10) A grand jury that is investigating a charge of driving while under
- 3 the influence of intoxicants in violation of ORS 813.010 may receive in evi-
- 4 dence an affidavit of a peace officer regarding any or all of the following:
- 5 (a) Whether the defendant was driving.
- 6 (b) Whether the defendant took or refused to take tests under any provision of ORS chapter 813.
- 8 (c) The administration of tests under any provision of ORS chapter 813 9 and the results of such tests.
- 10 (d) The officer's observations of physical or mental impairment of the 11 defendant.
- 12 (11)(a) A grand jury may receive in evidence an affidavit of a represen-13 tative of a financial institution for the purpose of authenticating records of 14 the financial institution.
- (b) As used in this subsection, "financial institution" means a financial institution as defined in ORS 706.008, an entity that regularly issues, processes or services credit cards or any other comparable entity that regularly produces financial records.
- (12)(a) A defendant who has been arraigned on an information alleging a felony charge that is the subject of a grand jury proceeding and who is represented by an attorney has a right to appear before the grand jury as a witness if, prior to the filing of an indictment, the defense attorney serves upon the district attorney written notice requesting the appearance. The notice shall include an electronic mail address at which the defense attorney may be contacted.
- 26 (b) A district attorney is not obligated to inform a defendant that a grand 27 jury proceeding investigating charges against the defendant is pending, in 28 progress or about to occur.
- (c) Upon receipt of the written notice described in paragraph (a) of this subsection, the district attorney shall provide in writing the date, time and location of the defendant's appearance before the grand jury to the defense

- 1 attorney at the indicated electronic mail address. In the event of a schedul-
- 2 ing conflict, the district attorney shall reasonably accommodate the sched-
- 3 ules of the defendant and the defense attorney if the accommodation does
- 4 not delay the grand jury proceeding beyond the time limit for holding a
- 5 preliminary hearing described in ORS 135.070 (2).

This subsection does not apply to cost-of-26 service studies used in the development or review of generally applicable rate 27 schedules. 28
- (28) Personally identifiable information about customers of a municipal electric utility or a people's utility district or the names, dates of birth, driver license numbers, telephone numbers, electronic mail addresses or So-

- 1 cial Security numbers of customers who receive water, sewer or storm drain services from a public body as defined in ORS 174.109. The utility or district 2 may release personally identifiable information about a customer, and a 3 public body providing water, sewer or storm drain services may release the name, date of birth, driver license number, telephone number, electronic mail 5 address or Social Security number of a customer, if the customer consents 6 in writing or electronically, if the disclosure is necessary for the utility, 7 district or other public body to render services to the customer, if the dis-8 closure is required pursuant to a court order or if the disclosure is otherwise 9 required by federal or state law. The utility, district or other public body 10 may charge as appropriate for the costs of providing such information. The 11 12 utility, district or other public body may make customer records available to third party credit agencies on a regular basis in connection with the es-13 tablishment and management of customer accounts or in the event such ac-14 counts are delinquent. 15

- (30) Sensitive business records, capital development plans or financial or commercial information of Oregon Corrections Enterprises that is not customarily provided to business competitors.

- (3) The Judicial Department may take any action before the operative dates specified in subsections (1) and (2) of this section that is necessary to enable the department to exercise the duties, functions and powers conferred on the department by this 2016 Act.

<u>SECTION 16.</u> This 2016 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2016 Act takes effect on its passage.
