Directs Oregon Wine Board to distribute moneys from sale of wine country registration plates as matching grants for tourism promotion.

Permits Department of Transportation to issue wine country registration plate to vehicle operated by board.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to wine country registration plates; creating new provisions; 3 amending ORS 805.045, 805.272 and 805.274; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

- **SECTION 1.** ORS 805.272 is amended to read:
- 6 805.272. (1) After the deduction of the cost of administration of the wine
- 7 country registration plate program, the Department of Transportation shall
- 8 deposit the net proceeds of the surcharge collected by the department under
- 9 ORS 805.266 into the account of the [Oregon Tourism Commission] Oregon
- Wine Board established under ORS [284.131] 182.470. The department shall
- make deposits under this subsection at least quarterly.
- 12 (2) Moneys deposited under subsection (1) of this section are continuously

appropriated to the [Oregon Tourism Commission] Oregon Wine Board for

- 14 the purposes set forth in ORS [284.131] **805.274**.
- 15 (3) As used in this section, "the cost of administration of the wine country
- 16 registration plate program" means the sum of all department expenses for the
- 17 issuance or transfer of wine country registration plates under ORS 805.266
- 18 that are above the normal costs of issuing, renewing and transferring regis-
- 19 tration plates in the normal course of the business of the department. These

- 1 expenses include, but are not limited to, the costs of collecting the wine
- 2 country registration plate surcharge and transferring wine country registra-
- 3 tion plates.
- 4 **SECTION 2.** ORS 805.274 is amended to read:
- 5 805.274. (1) After payment of the cost of production of the wine country
- 6 registration plates including administrative expenses relating to marketing
- 7 the wine country registration plates issued under ORS 805.266, the [Oregon
- 8 Tourism Commission] Oregon Wine Board shall distribute the moneys re-
- 9 ceived from the Department of Transportation [pursuant to ORS 805.272 as
- 10 follows:]
- [(a) One half of the moneys shall be distributed] as matching grants. The
- 12 [commission] board shall develop a matching grant program and shall award
- 13 grants to tourism promotion agencies for tourism promotion of wine and
- 14 culinary tourism. The [commission] board shall establish the maximum grant
- amount in the applicant guidelines prepared for the matching grant program
- 16 in each biennium. [No more than 50 percent of the total cost of a project may
- 17 be paid for with moneys from the program. An applicant must show a mini-
- 18 mum one-to-one match from private or public sources other than Oregon Busi-
- 19 ness Development Department or commission programs. The applicant must
- 20 also show a cash match of at least 50 percent of the amount requested under
- 21 the matching grant program.]
- 22 [(b) One half of the moneys shall be distributed to tourism promotion
- 23 agencies for the purpose of tourism promotion. The commission shall distribute
- 24 the moneys in proportion to the amount of acreage in each region used for wine
- 25 grape production. The commission shall designate a tourism promotion agency
- 26 for each region. The regions shall include the mid-Willamette Valley region
- 27 and each other major wine producing region of the state as determined by the
- 28 commission.]
- 29 (2) The [commission] **board** annually shall submit a report to the Legis-
- 30 lative Assembly in the manner provided in ORS 192.245 on or before October
- 31 1.

- [(a) "Mid-Willamette Valley region" means Marion, Polk and Yamhill 3 Counties.
- [(b)] (a) "Tourism promotion" has the meaning given that term in ORS 5 320.300. 6
- [(c)] (b) "Tourism promotion agency" has the meaning given that term in 7 ORS 320.300. 8
- **SECTION 3.** ORS 805.045 is amended to read: 9
- 805.045. (1) If approval is granted under ORS 283.390, the Department 10 of Transportation may issue: 11
- 12 (a) Registration plates or other evidence of registration from any regular series rather than from any specially designed government series for a vehi-13 cle owned or operated by any state department or institution [if approval is 14 granted under ORS 283.390.]; or 15
 - (b) Wine country registration plates for a vehicle operated by a member of the Oregon Wine Board in discharging the board's duties if requested to do so by the board.
- (2) The registration period for a vehicle described under this section shall 19 be the same as the regular registration period for the type of vehicle regis-20 tered. 21
- (3)(a) The fee for registration or renewal of a regular series registration 22 [of] plate for a vehicle under subsection (1)(a) of this section [shall be] is 23 the fee established under ORS 803.420 for registration or renewal of a state-24 owned vehicle registered under ORS 805.040. 25
- (b) The fee for registration or renewal of a wine country registra-26 tion plate for a vehicle under subsection (1)(b) of this section is the fee 27 established under ORS 803.420 for that type of vehicle, and not for re-28 newal of a state-owned vehicle registered under ORS 805.040. Addi-29 tionally, the applicant shall pay the surcharge described under ORS 30 805.266. 31

1	[(2)] (4) Any vehicle registered under this section and not exempted under
2	ORS 815.300 must meet the requirements for certification of compliance with
3	pollution control under ORS 815.310.
4	SECTION 4. The amendments to ORS 805.272 and 805.274 by sections
5	1 and 2 of this 2016 Act apply to wine country registration plates issued
6	on or after the effective date of this 2016 Act.
7	SECTION 5. This 2016 Act being necessary for the immediate pres-
8	ervation of the public peace, health and safety, an emergency is de-
9	clared to exist, and this 2016 Act takes effect on its passage.
10
