Applies Legislative Branch Personnel Rules and Legislative Branch Contracting Rules, as adopted by Legislative Administration Committee, to each house of Legislative Assembly and to other legislative service agencies.

CONCURRENT RESOLUTION

2 Be It Resolved by the Legislative Assembly of the State of Oregon:

3 (1) This resolution constitutes a rule of proceeding of the Senate and the
4 House of Representatives of the Seventy-eighth Legislative Assembly.

5 (2) The Senate and the House of Representatives shall adhere to the fol-6 lowing schedule and deadlines for the 2016 regular session of the Seventy-7 eighth Legislative Assembly:

8 (a) The Senate and the House of Representatives shall convene in regular
9 session on February 1, 2016.

10 (b) Committee chairpersons shall schedule work sessions for measures in 11 the chamber of origin no later than February 5, 2016. This paragraph does 12 not apply to the Joint Committee on Ways and Means, other joint commit-13 tees, Senate Committee on Finance and Revenue, House Committee on Rev-14 enue, Senate Committee on Rules and House Committee on Rules.

(c) Committees shall consider measures in the chamber of origin no later
than February 11, 2016. This paragraph does not apply to the Joint Committee on Ways and Means, other joint committees, Senate Committee on Finance and Revenue, House Committee on Revenue, Senate Committee on
Rules and House Committee on Rules.

1 (d) Committee chairpersons shall schedule work sessions for measures in 2 the second chamber no later than February 18, 2016. This paragraph does 3 not apply to the Joint Committee on Ways and Means, other joint commit-4 tees, Senate Committee on Finance and Revenue, House Committee on Rev-5 enue, Senate Committee on Rules and House Committee on Rules.

6 (e) Committees shall consider measures in the second chamber no later 7 than February 23, 2016. This paragraph does not apply to the Joint Commit-8 tee on Ways and Means, other joint committees, Senate Committee on Fi-9 nance and Revenue, House Committee on Revenue, Senate Committee on 10 Rules and House Committee on Rules.

(3) The Legislative Branch Personnel Rules and the Legislative Branch Contracting Rules, as adopted by the Legislative Administration Committee on January 15, 2016, shall also apply to each house of the Legislative Assembly and to the Office of the Legislative Counsel, the Office of the Legislative Fiscal Officer, the Office of the Legislative Revenue Officer and the staff of the Commission on Indian Services.
