## SUMMARY

Requires heads of certain state agencies to identify individuals serving in agency division leadership position or in position responding directly to director or division lead of agency. Requires identified individuals to file statement of economic interest.

## A BILL FOR AN ACT

Relating to statements of economic interest; creating new provisions; and amending ORS 244.050.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** ORS 244.050 is amended to read:

244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon Government Ethics Commission a verified statement of economic interest as required under this chapter:

(a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the Bureau of Labor and Industries, district attorneys and members of the Legislative Assembly.

(b) Any judicial officer, including justices of the peace and municipal judges, except any pro tem judicial officer who does not otherwise serve as a judicial officer.

(c) Any candidate for a public office designated in paragraph (a) or (b) of this subsection.

(d) The Deputy Attorney General.

(e) The Deputy Secretary of State.

(f) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the Secretary of the Senate and the Chief Clerk of the House

(s) Every member of the board of commissioners of a port governed by ORS 777.005 to 777.725 or 777.915 to 777.953.

(t) Every member of the board of directors of an authority created under ORS 441.525 to 441.595.

(u) Every member of a governing board of a public university listed in ORS 352.002.

(v) Every member of the board of directors of an authority created under ORS 465.600 to 465.621.

**(w) Each individual identified by the Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the Bureau of Labor and Industries or by a state officer listed in paragraph (h) of this subsection as serving in a division leadership position, or in a position responding directly to the director or division lead, or their administrative equivalent. The identification required by this paragraph must be made to the Oregon Government Ethics Commission not later than February 1 of each year.**

(2) By April 15 next after the date an appointment takes effect, every appointed public official on a board or commission listed in subsection (1) of this section shall file with the Oregon Government Ethics Commission a statement of economic interest as required under ORS 244.060, 244.070 and 244.090.

1 (3) By April 15 next after the filing deadline for the primary election,  
2 each candidate described in subsection (1) of this section shall file with the  
3 commission a statement of economic interest as required under ORS 244.060,  
4 244.070 and 244.090.

5 (4) Within 30 days after the filing deadline for the general election, each  
6 candidate described in subsection (1) of this section who was not a candidate  
7 in the preceding primary election, or who was nominated for public office  
8 described in subsection (1) of this section at the preceding primary election  
9 by write-in votes, shall file with the commission a statement of economic  
10 interest as required under ORS 244.060, 244.070 and 244.090.

11 (5) Subsections (1) to (4) of this section apply only to persons who are  
12 incumbent, elected or appointed public officials as of April 15 and to persons  
13 who are candidates on April 15. Subsections (1) to (4) of this section also  
14 apply to persons who do not become candidates until 30 days after the filing  
15 deadline for the statewide general election.

16 (6) If a statement required to be filed under this section has not been re-  
17 ceived by the commission within five days after the date the statement is  
18 due, the commission shall notify the public official or candidate and give the  
19 public official or candidate not less than 15 days to comply with the re-  
20 quirements of this section. If the public official or candidate fails to comply  
21 by the date set by the commission, the commission may impose a civil pen-  
22 alty as provided in ORS 244.350.

23 **SECTION 2. The amendments to ORS 244.050 by section 1 of this**  
24 **2016 Act apply to statements of economic interest required to be filed**  
25 **on or after the effective date of this 2016 Act.**
