SUMMARY

Updates and clarifies provisions related to regulation of industrial hemp. Makes certain changes to program through which State Department of Agriculture regulates industrial hemp, including requiring any industrial hemp commodity or product intended for human consumption to be tested in accordance with rules adopted by Oregon Health Authority for testing marijuana items.

Declares emergency, effective on passage.

8	SECTION 1. ORS 571.300 is amended to read:
9	571.300. As used in ORS 571.300 to 571.315:
10	(1) "Agricultural hemp seed" means Cannabis sativa seed:
11	[(a) That meets any labeling, quality and other standards set by the Di-
12	rector of Agriculture and that is intended for sale or is sold to, or purchased
13	by, licensed growers for planting; or]
14	[(b) That is not intended for planting, but remains in an unprocessed or
15	partially processed condition capable of germination.]
16	(a) That is sold to or intended to be sold to registered growers for

31 571.305. [(1) Industrial hemp production and possession, and commerce in

- 1 industrial hemp commodities and products, are authorized in this state. In-
- 2 dustrial hemp is an agricultural product that is subject to regulation by the
- 3 State Department of Agriculture.]
- 4 [(2) All growers and handlers must have an industrial hemp license issued
- 5 by the department. Growers and handlers engaged in the production of agri-
- 6 cultural hemp seed must also have an agricultural hemp seed production per-
- 7 mit. The handling of seeds and seed products that are processed in a manner
- 8 or to an extent that makes them incapable of germination does not require an
- 9 agricultural hemp seed production permit.]
- 10 [(3) An application for an industrial hemp license or agricultural hemp
- 11 seed production permit must include:]
- 12 [(a) The name and address of the applicant;]

- 29 ensure that the seed complies with any standards set by the Director of Agri-

- [(6) Subject to department guidelines, a grower may retain seed from each industrial hemp crop to ensure a sufficient supply of seed for that grower for the following year. A grower does not need an agricultural hemp seed production permit in order to retain seed for future planting. Seed retained by a grower for future planting may not be sold or transferred and does not need to meet the department's agricultural hemp seed standards.]
 - (1) To grow or handle industrial hemp, a person must be registered with the State Department of Agriculture as a grower or handler.
 - (2)(a) Only a grower or handler registered under this section may produce agricultural hemp seed. For a grower or handler to produce agricultural hemp seed, the grower or handler must be registered with the department as an agricultural hemp seed producer.

- (A) A grower registered under this section that retains agricultural hemp seed as described in section 7 of this 2016 Act is not required to register with the department as an agricultural hemp seed producer; and
- (B) A grower or handler registered under this section that produces Cannabis sativa seeds that are incapable of germination, or a handler registered under this section that processes Cannabis sativa seeds that are incapable of germination into commodities or products, is not required to register with the department as an agricultural hemp seed producer.
- 24 (3) An applicant for registration under this section must submit to 25 the department, in a form and manner prescribed by the department, 26 the following information:
 - (a) The name and address of the applicant;

14	SECTION 3. Sections 4 to 9 of this 2016 Act are added to and made
15	a part of ORS 571.300 to 571.315.
16	
17	(In General)
18	
19	SECTION 4. Industrial hemp is an agricultural product that is
20	subject to regulation by the State Department of Agriculture.
21	
22	(Growers)
23	
24	SECTION 5. A grower registered under ORS 571.305 may use any
25	propagation method, including planting seeds or starts or the use of
26	clones or cuttings, to produce industrial hemp.
27	SECTION 6. Within 21 days of being registered under ORS 571.305,
28	a grower shall provide the State Department of Agriculture, in a form
29	and manner prescribed by the department, with the global positioning
30	system coordinates and legal description of the property on which the
31	grower's crop is or will be located.

1	SECTION 7. (1) A grower registered under ORS 571.305 may retain
2	agricultural hemp seed for the purpose of propagating industrial hemp
3	in future years.

14	SECTION 8. (1) An agricultural hemp seed producer registered un-
15	der ORS 571.305:
16	(a) Must sell agricultural hemp seed in a manner that complies with
17	any standard established by the Director of Agriculture under ORS
18	633.511 to 633.750; and
19	(b) May sell agricultural hemp seed only if the agricultural hemp
20	seed meets any packaging or labeling requirement, or any quality
21	standard, adopted by the director under subsection (2) of this section.
22	(2) The director may adopt rules establishing packaging require-
23	ments, labeling requirements and quality standards for agricultural
24	hemp seed.

(Testing)

1	SECTION 9. (1) For purposes of this section, "consumption" means
2	to ingest, inhale or topically apply to the skin or hair.
3	(2) A laboratory licensed by the Oregon Liquor Control Commission
4	under ORS 475B.560 and accredited by the Oregon Health Authority
5	pursuant to ORS 475B.565 may test industrial hemp produced or pro-
6	cessed by a grower, handler or agricultural hemp seed producer regis-
7	tered under ORS 571.305.
8	(3) A handler registered under ORS 571.305 may not sell an indus-
9	trial hemp commodity or product that is intended for human con-
10	sumption unless the commodity or product is tested by a laboratory
11	described in subsection (1) of this section to ensure that the commod-
12	ity or product meets the requirements adopted by the Oregon Health
13	Authority under ORS 475B.555 (1)(a) and (b) and (2) for testing
14	marijuana items.
15	(4) For purposes of this section, the State Department of Agricul-

27	SECTION 10. ORS 571.315 is amended to read:
28	571.315. [(1) In addition to any other liability or penalty provided by Oregon
29	law, the State Department of Agriculture may revoke or refuse to issue or re-
30	new an industrial hemp license or an agricultural hemp seed production permit

31 and may impose a civil penalty for violation of:]

- 1 [(a) A license or permit requirement;]
- 2 [(b) License or permit terms or conditions;]
- 3 [(c) Department rules relating to growing or handling industrial hemp; 4 or]
- 5 [(d) A final order of the department that is specifically directed to the 6 grower's or handler's industrial hemp operations or activities.]
- [(2) The department may not impose a civil penalty under this section that exceeds \$2,500. The department shall impose civil penalties under this section in the manner provided by ORS 183.745.]
- [(3) The department may revoke or refuse to issue or renew an industrial hemp license or an agricultural hemp seed production permit for violation of any rule of the department that pertains to agricultural operations or activities other than industrial hemp growing or handling.]
- [(4) A revocation of, or a refusal to issue or renew, an industrial hemp license or an agricultural hemp seed production permit is subject to ORS chapter 183.]
- [(5) The department may not revoke or refuse to issue or renew an industrial hemp license or an agricultural hemp seed production permit on the basis that industrial hemp production or possession, or commerce in industrial hemp commodities or products, is prohibited by federal law.]
- 21 (1) Subject to the provisions of ORS chapter 183, the State Depart-22 ment of Agriculture may revoke the registration of a grower, handler 23 or agricultural hemp seed producer or refuse to register or renew the 24 registration if a grower, handler or agricultural hemp seed producer 25 violates:
 - (a) A provision of ORS 571.300 to 571.315;

- SECTION 12. (1) Subject to the provisions of ORS chapter 183, the State Department of Agriculture may impose a civil penalty not to exceed \$2,500 on a grower, handler or agricultural hemp seed producer for violating:
- 18 (a) A provision of ORS 571.300 to 571.315;
- 19 (b) A rule adopted under a provision of ORS 571.300 to 571.315;
- (c) An order issued by the department pursuant to a provision of ORS 571.300 to 571.315 or a rule adopted under a provision of ORS 571.300 to 571.315; or
 - (d) Any statutory law or department rule related to agricultural activities other than industrial hemp operations.
- (2) The department may not discipline a grower, handler or agricultural hemp seed producer under this section on the basis that possessing, delivering and manufacturing industrial hemp are prohibited by federal law.
- 29 (3) All moneys collected by the department under this section shall 30 be deposited in the General Fund in the State Treasury to the credit 31 of the Department of Agriculture Account. All moneys deposited in

SECTION 13. ORS 475B.005 is amended to read:

475B.005. (1) The People of the State of Oregon declare that the purposes 7 of ORS 475B.010 to 475B.395 are: 8

- (a) To eliminate the problems caused by the prohibition and uncontrolled 9 manufacture, delivery and possession of marijuana within this state; 10
- (b) To protect the safety, welfare, health and peace of the people of this 11 12 state by prioritizing this state's limited law enforcement resources in the most effective, consistent and rational way; 13
- (c) To permit persons licensed, controlled and regulated by this state to 14 legally manufacture and sell marijuana to persons 21 years of age and older, 15 subject to the provisions of ORS 475B.010 to 475B.395; and 16
- [(d) To ensure that the State Department of Agriculture issues industrial 17 hemp licenses and agricultural hemp seed production permits in accordance 18 with state law; and] 19
- [(e)] (d) To establish a comprehensive regulatory framework concerning 20 marijuana under existing state law. 21
 - (2) The People of the State of Oregon intend that the provisions of ORS 475B.010 to 475B.395, together with other provisions of state law, will:
- (a) Prevent the distribution of marijuana to persons under 21 years of age; 24
- (b) Prevent revenue from the sale of marijuana from going to criminal 25 enterprises, gangs and cartels; 26
- (c) Prevent the diversion of marijuana from this state to other states; 27
- (d) Prevent marijuana activity that is legal under state law from being 28 used as a cover or pretext for the trafficking of other illegal drugs or other 29 illegal activity; 30
 - (e) Prevent violence and the use of firearms in association with the cul-

1	tivation and distribution of marijuana;
2	(f) Prevent drugged driving and the exacerbation of other adverse public
3	health consequences associated with the use of marijuana;
4	(g) Prevent the growing of marijuana on public lands and the attendant

- (g) Prevent the growing of marijuana on public lands and the attendant public safety and environmental dangers posed by marijuana production on public lands; and
 - (h) Prevent the possession and use of marijuana on federal property.

MISCELLANEOUS

SECTION 14. The amendments to ORS 571.305 by section 2 of this 2016 Act apply to applications received by the State Department of Agriculture for initial registration and renewal of registration on or after the effective date of this 2016 Act.

SECTION 15. Section 12 of this 2016 Act and the amendments to ORS 571.315 by section 10 of this 2016 Act apply to adjudications commenced by the State Department of Agriculture on or after the effective date of this 2016 Act.

SECTION 16. The unit captions used in this 2016 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2016 Act.

SECTION 17. This 2016 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2016 Act takes effect on its passage.
