## SUMMARY

Requires city to annex territory without vote upon receipt of petition for annexation submitted by all owners of land in territory provided territory is included within urban growth boundary of city or Metro and is, or will be, subject to acknowledged comprehensive plan of city. Provides that territory to be annexed includes additional territory necessary to provide infrastructure and services for development of annexed territory at density planned in acknowledged comprehensive plan. Provides city is not required to hold public hearing and may declare territory annexed by ordinance containing description of territory.

Validates designated urban reserve adopted by Metro and Clackamas County.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to boundary changes; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2016 Act is added to and made a part**  
5 **of ORS 222.111 to 222.180.**

6 **SECTION 2. (1) Notwithstanding a contrary provision of the city**  
7 **charter, upon receipt of a petition proposing annexation of territory**  
8 **that is submitted by all owners of land in the territory, the legislative**  
9 **body of a city shall annex the territory without submitting the pro-**  
10 **posal to the electors of the city if:**

11 (a) **The territory is included within an urban growth boundary**  
12 **adopted by the city or Metro, as defined in ORS 197.015;**

13 (b) **The territory is, or upon annexation of the territory into the**  
14 **city will be, subject to the acknowledged comprehensive plan of the**

1 city; and

2 (c) The proposal conforms to all other requirements of the city's  
3 ordinances.

4 (2) The territory to be annexed under this section includes any ad-  
5 ditional territory described in ORS 222.111 (1) that must be annexed in  
6 order to provide infrastructure and services necessary for development  
7 of the territory described in subsection (1) of this section at the den-  
8 sity planned in the acknowledged comprehensive plan of the city.

9 (3) The legislative body of the city is not required to hold the public  
10 hearing otherwise required by ORS 222.120 for an annexation under  
11 this section. When the legislative body determines that the criteria  
12 described in subsection (1) of this section apply to territory proposed  
13 for annexation, the legislative body may declare that the territory de-  
14 scribed in subsections (1) and (2) of this section is annexed to the city  
15 by an ordinance that contains a description of the territory annexed.

16 SECTION 3. Section 4 of this 2016 Act is added to and made a part  
17 of ORS 195.137 to 195.145.

18 SECTION 4. For the purposes of land use planning in Oregon, the  
19 Legislative Assembly designates as acknowledged urban reserve the  
20 land in Clackamas County that was designated urban reserve in Metro  
21 Resolution No. 10-1238A adopted June 3, 2010, more particularly de-  
22 scribed as the real property in Area 4C on Metro's map denominated  
23 as "2040 Growth Concept Exhibit A to Ordinance 10-1238A," excluding  
24 the area north of Halcyon Road and west of 3645 Halcyon Road.

25 SECTION 5. This 2016 Act being necessary for the immediate pres-  
26 ervation of the public peace, health and safety, an emergency is de-  
27 clared to exist, and this 2016 Act takes effect on its passage.
