SUMMARY

States policy of State of Oregon to pay judges no less than median salary for judges serving in comparable positions in comparable states.

Modifies annual salaries of judges of Supreme Court, Court of Appeals, Oregon Tax Court and circuit courts.

Declares emergency, effective on passage.

2 Relating to compensation of judges; creating new provisions; amending ORS

3 292.406, 292.411, 292.416 and 292.426; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Section 2 of this 2016 Act is added to and made a part 6 of ORS chapter 292.

7 <u>SECTION 2.</u> In order to attract and retain highly qualified people 8 to serve as judges in the Judicial Department and to recognize the 9 trust and responsibilities inherent in those positions, it is the policy 10 of the State of Oregon to pay judges no less than the median salary 11 for judges serving in comparable positions in comparable states.

12 **SECTION 3.** ORS 292.406 is amended to read:
