## SENATE BILLS

**SB 942** By Senators ROSENBAUM, FERRIOLI -- Relating to placement of statues in National Statuary Hall; declaring an emergency.

3-31(S) Introduction and first reading. Referred to President's desk.

Directs Oregon State Capitol Foundation to undertake fund-raising and commission of statues of Chief Joseph and Abigail Scott Duniway, to be placed in National Statuary Hall in United States Capitol.

**HB2232** By Representative NATHANSON; Representative EVANS (Pre-session filed.) -- Relating to support services for certain youth; declaring an emergency.

**HB2334** Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Judiciary) -- Relating to affidavits alleging undue hardship filed in Oregon Tax Court; prescribing an effective date.

Requires affidavit alleging undue hardship to be filed within 30 days after entry of order specially designating complaint for hearing in regular division of Oregon Tax Court.

**HB2837** By Representative GOMBERG -- Relating to certificates of exemption issued by the Director of Transportation.

Directs Director of Transportation to issue certificate of exemption from requirement to use child safety system, safety belt or safety harness if statement is submitted by nurse practitioner or physician assistant on behalf of person requesting exemption.

**HB2880** By COMMITTEE ON HEALTH CARE -- Relating to radiography; declaring an emergency.

Specifies that physician assistant may not practice fluoroscopy on person unless physician assistant holds certificate issued by Board of Medical Imaging authorizing such practice.
