(at the request of Senate Interim Committee on Rules and Executive Appointments) - - Relating to calculation for maintaining status as a minor political party; declaring an emergency.

SB 1513 By Senators GIROD, COURTNEY (Pre-session filed.) – Relating to a property tax exemption for the homesteads of the surviving spouses of certain public safety officers; prescribing an effective date.

(at the request of Senate Interim Committee on Human Services and Early Childhood) – Relating to prescription drugs; declaring an emergency.

(at the request of Senate Interim Committee on Human Services and Early Childhood) – Relating to providers of child care; declaring an emergency.

(at the request of Senate Interim Committee on Environment and Natural Resources) – Relating to land improvement projects.

Requires certain findings by local governing body for creation, restoration or enhancement of wetlands in exclusive farm use zones.

(at the request of Senate Interim Committee on Environment and Natural Resources for Oregon Farm Bureau) – Relating to artificial beaver dams; declaring an emergency.

Requires Department of State Lands to adopt pilot program for voluntary stream restoration and beaver recovery through construction of artificial beaver dams.

SB 1519 By Senator KNOPP; Senators FERRIOLI, HANSELL, THATCHER, WHITSETT (Pre-session filed.) – Relating to public employee retirement; declaring an emergency.

Modifies provisions relating to employee contributions of members of Public Employees Retirement System.

SB 1520 By Senator KNOPP, Representative WITT; Senators BOQUIST, FERRIOLI, GIROD, HANSELL, OLSEN, ROBLAN, THATCHER, THOMSEN, WHITSETT, Representatives DOHERTY, HACK, HOYLE, KOMP, PARRISH, WHISNANT (Pre-session filed.) – Relating to forest resources; prescribing an effective date.

2-1 Introduction and first reading. Referred to President's desk.

Requires Governor, with assistance of State Forestry Department, to attempt state entry into federal Good Neighbor Authority agreement with United States Forest Service.

SB 1521 By Senator COURTNEY (Pre-session filed.) – Relating to taxation; prescribing an effective date.

2-1 Introduction and first reading. Referred to President's desk.
2-8 Public Hearing and Possible Work Session scheduled.

Authorizes mass transit district to impose tax on employees of employers within district if district imposes excise tax on those employers.

SB 1522 By Senator COURTNEY (Pre-session filed.) – Relating to a month to raise awareness for cystic fibrosis; declaring an emergency.

2-1 Introduction and first reading. Referred to President's desk.
2-2 Public Hearing and Work Session scheduled.

Designates May of each year as Cystic Fibrosis Awareness Month.

SB 1523 Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President. (at the request of Senate Interim Committee on Veterans and Emergency Preparedness) – Relating to fuel storage facilities; declaring an emergency.

2-1 Introduction and first reading. Referred to President's desk.
2-2 Public Hearing and Possible Work Session scheduled.

Requires Office of Emergency Management to develop and administer grant program for purpose of installing connectors at certain fuel storage facilities that are compatible with generators used by emergency response personnel.

SB 1524 Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President. (at the request of Senate Interim Committee on Veterans and Emergency Preparedness) – Relating to veterans.

Requires law enforcement unit to train public safety officers in veterans' issues.

SB 1525 By Senator BAERTSCHIGER JR; Senator BEYER, Representatives BARRETO, ESQUIVEL, GILLIAM, KRIEGER, MCLANE, NEARMAN, OLSON, STARK, WILSON (Pre-session filed.) – Relating to definition of "payroll" under Workers' Compensation Law.

Excludes sick leave pay from definition of "payroll" for purpose of workers' compensation calculations.

SB 1526 By Senator BAERTSCHIGER JR; Representatives ESQUIVEL, GILLIAM, KRIEGER, MCLANE, NEARMAN, WILSON (Pre-session filed.) – Relating to financial administration of the Higher Education Coordinating Commission; declaring an emergency.

- 1-27(S) Pre-session Released to the Public.
2-1 Introduction and first reading. Referred to President's desk.

Appropriates moneys from General Fund to Higher Education Coordinating Commission for Office of Community Colleges and Workforce Development for Oregon Employer Workforce Training Program, local workforce investment boards and Oregon Youth Conservation Corps.

SB 1527 By Senator MONROE; Senators BEYER, THOMSEN, Representatives DOHERTY, GORSEK, LIVELY, MCLAIN (Pre-session filed.) – Relating to prepaid transportation cards.

2-1 Introduction and first reading. Referred to President's desk.
2-8 Public Hearing and Possible Work Session scheduled.

Exempts prepaid transportation cards from Uniform Disposition of Unclaimed Property Act and related statutes.

SB 1528 By Senators FERRIOLI, COURTNEY; Senators HANSELL, ROBLAN, Representatives MCKEOWN, STARK (Pre-session filed.) – Relating to the Commission on Indian Services; declaring an emergency.

Requires members of Commission on Indian Services who are not members of Legislative Assembly to be appointed from nominees selected by tribal councils.

SB 1529 By Senator HANSELL (Pre-session filed.) – Relating to community water supply; declaring an emergency.

Prohibits enforcement of residential irrigation requirements by homeowners association following finding or declaration of existing or likely drought conditions.

SB 1530 By Senator BATES (Pre-session filed.) – Relating to mining; declaring an emergency.

Requires certain state agencies to consult with certain federal agencies to determine whether state and federal mining programs can be better coordinated.

Modifies requirements regarding coordinated care organization contracts and for establishing global budgets and required services.

(at the request of Senate Interim Committee on Workforce and General Government) – Relating to minimum wage; declaring an emergency.

Establishes tiered system for determination of minimum wage based on size and geographic location of employer.

(at the request of Senate Interim Committee on Workforce and General Government) – Relating to affordable housing.

Permits local governments to adopt land use regulations or functional plan provisions, or impose conditions for approval of permits, that effectively establish sales or rental price for up to 30 percent of new residential development or limit sales or rental purchase to class or group of purchasers or renters in exchange for one or more developer incentives.

SB 1534 Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President. (at the request of Senate Interim Committee on Workforce and General Government) – Relating to unemployment insurance; declaring an emergency.

- 2-1 Introduction and first reading. Referred to President's desk.
 2-4 Public Hearing and Possible Work Session scheduled.

Provides that certain statutory provisions relating to eligibility of individuals who perform certain services for educational institutions for unemployment insurance benefits during period between two successive academic years or terms or established and customary vacation period or holiday recess do not apply to claim filed by individual who voluntarily left work with good cause.
