SENATE CONCURRENT RESOLUTIONS

SCR211 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Adjourning sine die the 2020 special session of the Eightieth Legislative Assembly.

6-24(S) Introduction and first reading. Referred to President's desk.

Adjourns sine die 2020 special session of Eightieth Legislative Assembly.

SENATE BILLS

SB 5711 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to state financial administration; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

This is an appropriation measure.

Appropriates moneys from General Fund to ____ for biennial expenses.

SB 1601 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to transportation; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

Upon passage, allows Statewide Transportation Improvement Fund moneys to be used to maintain existing public transportation services.

SB 1602 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to forests; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

Requires Governor to facilitate mediation sessions between forest industry and environmental interest representatives.

SB 1603 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to the universal service fund; prescribing an effective date.

6-24(S) Introduction and first reading. Referred to President's desk.

Modifies definitions applicable for purposes of universal service surcharge.

SB 1604 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to arbitration awards; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

Restricts arbitration award from ordering disciplinary action that differs from disciplinary action imposed by law enforcement agency if arbitrator makes finding that misconduct occurred consistent with

agency's finding of misconduct, and disciplinary action imposed by agency is consistent with provisions of discipline guide or discipline matrix adopted by agency as result of collective bargaining and incorporated into agency's disciplinary policies.

SB 1605 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to children; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

Modifies Oregon Promise program to extend eligibility to certain Oregon foster children who attain their highest level of education while in out-of-state placements.

SB 1606 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to health care; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

Prohibits hospital from conditioning admission or treatment, or suggesting that treatment is conditioned, on patient having POLST or executing advance directive or other instruction regarding administration, withholding or withdrawing of life-sustaining procedures or artificially administered nutrition and hydration.

SB 1607 Sponsored by Senator COURTNEY (at the request of Joint Committee on the First Special Session of 2020) -- Relating to State School Fund distributions; declaring an emergency.

6-24(S) Introduction and first reading. Referred to President's desk.

Extends for one year small school district grants and school district funding for foreign exchange students.
