HB4001 Sponsored by Representative RAYFIELD, KROPF, Senator LIEBER, Representative VALDERRAMA, Senator WAGNER; Representatives EVANS, GOODWIN, HOLVEY, MANNIX, NOSSE, SANCHEZ, Senator KNOPP (Pre-session filed.) -- Relating to specialty courts; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act creates the Task Force on Specialty Courts and tells the task force to report to the legislature by September 15, 2024.

HB4002 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Joint Interim Committee on Addiction and Community Safety Response for Representative Jason Kropf, Senator Kate Lieber) -- Relating to the addiction crisis in this state.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act requires the OHA to study the problems in this state caused by drug use and to send a report on its findings to the legislature.

HB4003 Sponsored by Representative WALLAN (Pre-session filed.) -- Relating to medical examiners; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act makes a state agency study the shortage of medical examiners in this state.

HB4004 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Business and Labor for Commissioner of the Bureau of Labor and Industries Christina Stephenson) -- Relating to unlawful employment of minors; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act changes the state law that governs when BOLI can impose civil penalties against a person who violates child labor laws.

HB4005 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Business and Labor for Paul Holvey) -- Relating to an individual's performance of services for an employer; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act makes changes to state law to clarify the meaning of an individual's performance of services.

HB4006 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Business and Labor for Associated General Contractors, Associated Wall and Ceiling Contractors, Sheet Metal and Air Conditioning Contractors of North America, Plumbing and Mechanical Contractors Association) -- Relating to submitting surety bonds in lieu of retainage; declaring an emergency.

2-5(H) First reading. Referred to Speaker's desk.

Digest: Requires state agencies to accept surety bonds from people who perform construction work for the state, instead of holding onto some of the money the agencies owe for the work, in order to make sure the work is done correctly.

HB4007 Sponsored by Representatives CATE, JAVADI, LEVY B, GOODWIN; Representatives BOICE, CONRAD, DIEHL, OWENS, Senator KNOPP (Pre-session filed.) -- Relating to tax treatment of wildfire litigation; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: Exempts awards from and legal fees paid in wildfire suits from income tax.

HB4008 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Joint Interim Committee on Addiction and Community Safety Response for Representative Jason Kropf, Senator Kate Lieber) -- Relating to behavioral health.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act requires the OHA to study the problems in getting mental health care and substance use care in this state.

HB4009 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Joint Interim Committee on Addiction and Community Safety Response for Representative Jason Kropf, Senator Kate Lieber) -- Relating to public safety.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act directs the CJC to study ways to address the use of drugs in public places.

HB4010 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Behavioral Health and Health Care) -- Relating to health care; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: This Act makes changes to laws about prescription drugs, health insurance and some health care providers.

HB4011 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Behavioral Health and Health Care) -- Relating to health care; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act tells health insurance to pay for some cancer exams and devices that people with diabetes use.

HB4012 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Behavioral Health and Health Care) -- Relating to reimbursement of clinician-administered prescription drugs.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act does not allow an insurer to make a person enrolled in a health benefit plan go to a certain pharmacy in some circumstances for certain types of drugs.

Senator SMITH DB (at the request of Oregon Winegrowers Association, Oregon Wine Council) (Presession filed.) -- Relating to wine packaging; declaring an emergency.

Digest: This Act tells the DEQ not to enforce certain laws related to wine packaging.

HB4014 Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Climate, Energy, and Environment for Representative Pam Marsh) -- Relating to fostering coexistence with beavers; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act allows agencies to award moneys under a grant program related to living with beavers on private land.

HB4015 Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Climate, Energy, and Environment for Representative Pam Marsh) -- Relating to battery energy storage systems; prescribing an effective date.

Digest: Permits a person who wants to build a battery energy storage system (BESS) to choose to use EFSC for the siting of the BESS. Permits the ruling body of a local body after talking with the person who wants to build a BESS to choose to use EFSC for the siting of the BESS. Permits a BESS to be built and run without its own site certificate if the BESS is subject to the site certificate of another energy facility.

HB4016 Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Climate, Energy, and Environment for Representative Pam Marsh) -- Relating to natural resources; prescribing an effective date.

Digest: The Act makes certain changes to a program for planned fires.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act makes all people who apply to be a notary public take a course before taking the required test.

HB4021 Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Rules for Representative Julie Fahey) -- Relating to vacancies in the United States Senate.

Digest: The Act requires the Governor to appoint a U.S. Senator when a vacancy happens in the office.

Digest: The Act says that health care workers may not alter a minor's sex or refer the minor to another health care worker to alter the minor's sex.

Digest: The Act would give a credit against taxes to employers whose rate for 2025 is less than their rate for the year before.

Digest: The Act makes district attorneys police officers under PERS. The Act lowers the age at which some police and firefighters can retire.

Digest: The Act relaxes housing standards, establishes a housing office to enforce housing laws, allows a new UGB amendment and limits counties' role in UGB amendments.

HB4049 Sponsored by Representative HELM, Senator SOLLMAN, Representative OWENS (Pre-session filed.) -- Relating to a study of PFAS in biosolids applied to land; declaring an emergency.

2-5(H) First reading. Referred to Speaker's desk.

Digest: This Act directs OSU to study the fate of PFAS in biosolids that are spread on farm fields.

HB4050 Sponsored by Representative BOSHART DAVIS, Senators STEINER, MEEK; Representatives ELMER, LEVY B, Senators BONHAM, WOODS (Pre-session filed.) -- Relating to compensation differentials under pay equity requirements; declaring an emergency.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act removes an exception to the state law concerning pay equity requirements.

HB4051 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Gambling Regulation for Representative John Lively) -- Relating to racing; declaring an emergency.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act makes betting on dog races illegal.

HB4052 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Gambling Regulation for Representative John Lively) -- Relating to racing.

2-5(H) First reading. Referred to Speaker's desk.

Digest: Certain horse racing companies pay a fee to the Oregon Racing Commission.

Digest: The Act tells certain entities to designate sports by gender.

HB4055 Sponsored by Representatives GOODWIN, RESCHKE, HELFRICH, Senator THATCHER; Representatives BOICE, BREESE-IVERSON, CATE, CONRAD, CRAMER, DIEHL, HIEB, LEVY B, LEWIS, MANNIX, OWENS, SCHARF, WALLAN, Senators HAYDEN, KNOPP, SMITH DB (Pre-session filed.) -- Relating to exempt amount under corporate activity tax; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: Raises the exemption and filing thresholds for the CAT tax.

HB4056 Sponsored by Representative CONRAD; Representatives DIEHL, GOODWIN, HELFRICH, HIEB, LEVY B, LEWIS, MANNIX, MCINTIRE, OSBORNE, OWENS, RESCHKE, WRIGHT (Pre-session filed.) -- Relating to property tax foreclosure surplus; prescribing an effective date.

Digest: The Act lets people claim a tax foreclosure surplus.

HB4057 Sponsored by Representatives BREESE-IVERSON, CATE, GOODWIN; Representatives RESCHKE, WALLAN, WRIGHT, Senators KNOPP, LINTHICUM, SMITH DB (Pre-session filed.) -- Relating to unlawful strikes.

Digest: The Act would make it unlawful for teachers to participate in a strike.

HB4058 Sponsored by Representative BREESE-IVERSON, Senators ANDERSON, MEEK; Representatives CATE, GOODWIN, HELFRICH, LEVY B, OSBORNE, OWENS, RESCHKE, WRIGHT, YUNKER, Senator KNOPP (Pre-session filed.) -- Relating to regulated real estate activities.

Digest: The Act adds laws about residential property wholesalers.

HB4059 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Agriculture, Land Use, Natural Resources, and Water for Representative Ken Helm) -- Relating to brassica production in the Willamette Valley Protected District.

Digest: The Act tells a state agency to study issues around a genus of plants in the cabbage and mustard family in an area south of Salem.

HB4060 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Agriculture, Land Use, Natural Resources, and Water for Representative Ken Helm) -- Relating to the Oregon Agricultural Heritage Fund; declaring an emergency.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act gives money to a state agency for uses related to working lands.

HB4061 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Agriculture, Land Use, Natural Resources, and Water for Representative Ken Helm) -- Relating to damage caused by elk; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act directs an agency to create a program related to elk damage.

HB4062 Sponsored by Representative CRAMER (Pre-session filed.) -- Relating to controlled substances; declaring an emergency.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act creates new drug crimes and increases penalties for some drug offenses.

HB4063 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Housing and Homelessness for Representative Maxine Dexter) -- Relating to housing; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act makes counties plan for areas of Metro that are not in a city, lets home builders use updated local rules, lets real estate agents accept love letters, amends middle housing land divisions and mobile home registrations, lets sick or injured tenants pay rent late and lets city staff grant or end tax exemption for single-unit housing.

HB4064 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Housing and Homelessness for Representative Maxine Dexter) -- Relating to housing.

2-5(H) First reading. Referred to Speaker's desk.

Digest: Makes OHCS study and report on housing.

HB4065 Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Housing and Homelessness for Representative Maxine Dexter) -- Relating to financing affordable housing; prescribing an effective date.

2-5(H) First reading. Referred to Speaker's desk.

Digest: The Act would create a fund for grants to developers of affordable housing.

HB4066 Sponsored by Representative OWENS (Pre-session filed.) -- Relating to peer-to-peer car sharing arrangements.

Digest: Requires insurance for cars shared for money and that some information be given to the shared car owner and the shared car driver.

HB4068 Sponsored by Representative HUDSON; Senator WEBER (Pre-session filed.) -- Relating to the funding of public education.
