Designates portion of U.S. Highway 395 as “World War I Veterans Memorial Highway;” Interstate 5 as “Korean War Veterans Memorial Highway,” and “Purple Heart Trail;” and U.S. Highway 101 as “Persian Gulf, Afghanistan, and Iraq Veterans Memorial Highway.” Directs Oregon Department of Transportation (ODOT) to place and maintain markers. Permits acceptance of funds and agreements with Veterans’ groups to that end. Prohibits use of public funds. Declares emergency, effective on passage.  
 (Committee vote: 6-0-1)

Modifies definition of “victim” for restitution purposes to include the estate of person against which an offense was committed Clarifies that right of restitution passes to estate of person entitled to restitution upon death of person. (Committee vote: 8-0-1)

Authorizes use of electronic criminal and violation citations in different size or format than current law permits. Declares emergency, effective on passage. (Committee vote: 9-0-0)

Authorizes Department of State Lands to adopt rules allowing additional exemptions to leasing requirements relating to submersible lands. Declares emergency, effective on passage.

Requires Department of State Lands to maintain electronic copies of all deeds and conveyances of real property belonging to the state. Declares emergency, effective on passage. (Committee vote: 7-0-0)
