<u>HB 2484</u>	REV	dp	02/20/14	
Extends deadlines and eliminates extension for filing certain property tax returns with Department of Revenue. Applies to property tax years beginning on of after July 1, 2016. (Committee vote: 9-0-0)				
<u>HB 2485</u>	REV	dp	02/20/14	
Clarifies that refund made for correction in property taxes owed resulting from appeal is made to individual who filed the appeal. Aligns time limitation for property tax refunds with time limitation for roll corrections (five years). Authorizes refund due to proration of taxes for destroyed or damaged property and clarifies refund is made to applicant of the proration. Extends certain property tax rules currently applicable to manufactured structures to floating homes. Increases threshold for cancelling delinquent property taxes from five to ten dollars, aligning with current threshold for refunds. (Committee vote: 9-0-0)

<u>HB 2415-A</u>	BL	dpa PE	02/20/15	Doherty
Allows Department of Human Services or Oregon Health Authority to request financial institution to release specified information regarding deposit accounts held by deceased person. Creates exception to prohibited release of private financial records. (Committee vote: 10-0-1)

Modifies the definition of “health care interpreter” to include sign language interpreters. Revises the membership of the Oregon Council on Health Care Interpreters to include a health care interpreter. Prohibits the use of the title “Oregon certified health care interpreter” without specific requirements. Clarifies qualifications and certification requirements. Modifies health care data reporting requirements. Changes Oregon Health Policy and Research to Oregon Health Authority. Modifies qualifications for Public Health Officer. Removes references to Blue Mountain Recovery Center. Aligns references relating to screening interviews and treatment programs for alcohol and drug diversion programs. (Committee vote: 8-0-1)
