Modifies list of jurisdictions of incorporation for which income must be included on Oregon corporate excise tax return, if corporation is member of unitary group with Oregon corporation. Directs Department of Revenue to adjust income received in a listed jurisdiction when it does not accurately reflect business activity in Oregon as specified in ORS 314.667. Specifies criteria used to determine listed jurisdictions. Requires Legislative Revenue Office to report to the 2017 Legislature on the cost effectiveness of requiring corporations with subsidiaries in listed jurisdictions to report income in those jurisdictions. **House Amendment Amendment directs Department of Revenue to apply ORS 314.667 in those cases where income reported in listed jurisdiction does not accurately reflect business activity in Oregon.** (House Vote: Ayes, 58; Nays, 1--Nosse; Excused, 1--Barton.)

Abolishes Oregon University System, office of the Chancellor of the Oregon University System and State Board of Higher Education. States that all public universities have institutional governing boards. Abolishes Oregon University System Fund and subaccounts, Higher Education Donation Fund, Higher Education Academic Modernization Account and Oregon University System Capital Construction, Deferred Maintenance and Capital Repair Project Fund. Transfers moneys remaining in accounts or funds to Public University Fund. Limits use of transferred moneys to purposes listed in original funds or accounts. Adds the Higher Education Coordinating Commission to the list of entities authorized to take action with respect to the Western Interstate Commission for Higher Education, and specifies that the Higher Education Coordinating Commission replaces the references to the State Board of Higher Education. Resolves conflicts. **House Amendment The amendment resolves conflicts with SB 215, SB 224, SB 342, SB 493, SB 777, HB 2408, HB 2411, HB 2412, HB 3069, HB 3303, and HB 3524.** (House Vote: Ayes, 56; Nays, 3--Clem, Gomberg, Nosse; Excused, 1--Greenlick.)

Expires terms of office for members of Oregon Education Investment Board (OEIB) upon effective date of Act and dissolves OEIB board. Extends sunset of OEIB agency and Chief Education Officer (CEO) to June 30, 2019. Changes agency name to "Chief Education Office." Specifies that

office is established for purpose of coordinating with education stakeholders to establish unified public education system. Specifies office duties and entities with whom collaboration should take place. Allows office to adopt rules necessary for administration of laws that office is charged with administering. Specifies CEO duties and positions with whom collaboration should take place. Establishes CEO has direction and control over specific positions for matters related to design and organization of multi-agency planning. Requires records and property in possession of CEO be transferred to specified positions as of June 30, 2019. Removes requirements related to achievement compacts. Declares emergency, effective on passage. **House Amendment Resolves conflicts.** (House Vote: Ayes, 52; Nays, 6--Davis, Esquivel, Gilliam, Weidner, Whitsett, Wilson; Excused, 2--Barker, Boone.)

Directs Department of Revenue to retain un-receipted income tax revenue from capital gains income. Defines method of calculating excess capital gains revenue as the deference between the average revenue over the most recent two tax years compared to average revenue in the three previous years. If the most recent revenue exceeds the previous period, the excess is deposited in the Education Stability Fund. Deposit occurs prior to June 30 of odd numbered years. No deposits can be made prior to June of 2019. **House Amendment Sets base period for calculation at three years instead of two. Clarifies that estimate is based on tax liability, not collections. States that no deposit is be made under the bill prior to June of 2019.** (House Vote: Ayes, 37; Nays, 22--Boone, Buckley, Doherty, Evans, Frederick, Gallegos, Gomberg, Gorsek, Holvey, Hoyle, Keny-Guyer, Lininger, Lively, McKeown, McLain, Nathanson, Nosse, Piluso, Taylor, Whitsett, Williamson, Speaker Kotek; Excused, 1--Greenlick.)

Directs Department of Human Services to convene and staff The Task Force on Housing with Services to define housing with services; define consumer rights; set standards for licensure and registration; and define safety standards. Specifies task force membership. Directs DHS to enact six month moratorium on new housing with services facilities. Sunsets task force on December 31, 2015. Requires report to legislature on or before December 31, 2015. (Committee Vote: Aye, 22; Nay, 2 --Whitsett, Whitsett)

Restructures the framework for conducting public health activities and duties in the state and for how public health services are provided to Oregonians. Provides mechanisms by which local health departments may implement provisions of the bill separately and at varying times. Modifies terminology and funding distributions. Becomes operative January 1, 2016. Declares an emergency, effective on passage. **Senate Amendment Resolves conflicts.** (Committee Vote: Aye, 22; Exc., 2 --Rayfield, Thomsen)
