<a href="#"><u>SCR 6</u></a>	<b>Veterans and Emergency Preparedness</b> In memoriam: Army Specialist Nickolas S. Welch, 1987-2013.

<a href="#"><u>SJM 7</u></a>	<b>Finance and Revenue</b> Urges President and Congress to transfer federal lands within Oregon to State of Oregon.

<a href="#"><u>SJR 13</u></a>	<b>Judiciary</b> Proposes amendment to Oregon Constitution to require Legislative Assembly to approve each administrative rule or amendment of administrative rule adopted by executive branch agency before taking effect.
<a href="#"><u>SB 1</u></a>	<b>Health Insurance Transition</b> Abolishes Oregon Health Insurance Exchange Corporation and board of directors of corporation and transfers functions and duties to Department of Consumer and Business Services.
<a href="#"><u>SB 6</u></a>	<b>Rules</b> Extends terms of office of members of Commission for the Blind.
<a href="#"><u>SB 7</u></a>	<b>Health Care</b> Requires Oregon Health Authority to exercise procurement authority under Public Contracting Code and under supervision of Oregon Department of Administrative Services, for specified purposes.
<a href="#"><u>SB 500</u></a>	<b>Human Services and Early Childhood;Ways and Means</b> Appropriates moneys from General Fund to Oregon Department of Administrative Services for construction of Boys & Girls Club in Rockwood neighborhood of Gresham.
<a href="#"><u>SB 501</u></a>	<b>Human Services and Early Childhood;Ways and Means</b> Appropriates moneys from General Fund to Oregon Youth Authority for East Metro Gang Enforcement Team gang intervention services in east Multnomah County.
