Measure	Committee/Catchline
<u>SB 9</u>	Rules Directs Secretary of State to conduct performance audit of state agency public records retention and disclosure practices, including analysis and recommendations on specified criteria.
<u>SB 948</u>	Business and Transportation Permits Department of Transportation to issue vehicle registration plates from regular series for use on county-owned vehicle rather than plates from specially designed government series.
<u>SB 949</u>	Business and Transportation Exempts from property subject to tower's lien contents of towed motor vehicle for which owner or other person with interest in towed vehicle submits to tower affidavit stating that motor vehicle is being used as primary nighttime residence.
<u>SB 950</u>	Education; Ways and Means Appropriates moneys for biennium beginning July 1, 2015, to Higher Education Coordinating Commission for Oregon State University operation of center for manufacturing and design of advanced wood products.
<u>HB 2051</u>	Judiciary Reduces penalty for crime of criminal trespass in the second degree in certain circumstances.
<u>HB 2208</u>	Judiciary Adds civil code enforcement officers to public officials who may request exemption from required disclosure under public records law of specified personal information.
<u>HB 2420</u>	Judiciary Provides that community mental health program director or director's designee shall consult with criminal defendant found unfit to proceed, prior to decision on commitment, to determine availability of treatment in community .
<u>HB 2437</u>	Business and Transportation Permits Oregon Business Development Department to enter into agreements for grants or other assistance, including but not limited to direct purchase of goods or services related to entrepreneurial and industry development.
<u>HB 2596</u>	Judiciary Provides that person who records another person's intimate areas commits crime of invasion of personal privacy.
<u>HB 2629</u>	Human Services and Early Childhood Requires owners of rental property subject to federal rural rental housing loans to provide at least one year's notice of date of maturity of loans to tenants, Housing and Community Services Department, housing authorities and local governments.
<u>HB 2893</u>	Business and Transportation Permits financial institution to conduct savings promotion raffle, subject to specified conditions.

<u>HB 2927</u>	Education;Finance and Revenue Increases amount transferred from State School Fund to High Cost Disabilities Account each fiscal year.
<u>HB 2930</u>	Health Care Requires that hospital rules granting admitting privileges to licensed, certified nurse midwife nurse practitioner meet specified requirements.
<u>HB 2981</u>	Veterans and Emergency Preparedness Directs Department of Transportation to erect and maintain Fallen Hero roadside memorial sign for Specialist Mabry James Anders.
<u>HB 3082</u>	Human Services and Early Childhood Creates alternative definition of "low income" for purposes of nonprofit corporation low income housing.
