<u>HCR 20</u>	Rules Honors civic leader, author, journalist and entrepreneur Gerald "Gerry" Frank.
<u>HCR 22</u>	Veterans and Emergency Preparedness Recognizes and honors Army Specialist Taylor Daniel Marks (1989-2009) for his service to his country.
<u>HB 2127</u>	Finance and Revenue Prohibits recording by county clerk of instrument to convey fee title to real property to tax-exempt government transferee unaccompanied by certificate issued by county assessor attesting that all charges against real property as of date of recording have been paid.
<u>HB 2182</u>	Environment and Natural Resources Requires State Department of Fish and Wildlife to study developing predator management plan for State of Oregon and to report to interim committees of Legislative Assembly on or before September 15, 2016.
<u>HB 2277</u>	Environment and Natural Resources Modifies authority of drainage districts to perform flood control activity.
<u>HB 2288</u>	Business and Transportation Increases membership of Oregon Innovation Council.
<u>HB 2429</u>	Judiciary Repeals sunset on provisions related to relief from prohibition on possessing and purchasing firearms.
<u>HB 2551</u>	Health Care Requires covered entities to report annually on system safeguards for protecting confidentiality of personally identifiable and protected health information.
<u>HB 2664</u>	Workforce Subjects university with governing board, or not-for-profit organization or other entity that university with governing board controls, to certain provisions of Public Contracting Code.
<u>HB 2762</u>	Education Requires school district to eliminate use of polystyrene foam plates, trays, food containers or food packaging in service of any meal unless school district recycles polystyrene foam.
<u>HB 2888</u>	Judiciary Allows action to enjoin or restrain nuisance if place is used for certain activities involving animals.
<u>HB 3257</u>	Human Services and Early Childhood Extends sunset on collection of certain moneys from electric companies or Oregon Community Power for purposes related to low-income electric bill payment assistance.
<u>HB 3414</u>	Business and Transportation Requires certain persons to not drive in far left lane unless passing.
<u>HB 3516</u>	Education Requires each school obtaining approval from Higher Education Coordinating
