<u>SB 964</u>	Implementing Measure 91 Makes changes to Oregon Medical Marijuana Act, including limiting amount of plants that may be grown at addresses where marijuana grow sites are located and requiring registration of marijuana processing sites.
<u>HCR 19</u>	Rules Congratulates 2014 University of Oregon Ducks football team on their Rose Bowl victory.
<u>HCR 23</u>	Rules Honors Ron Post for establishing Medical Teams International and improving lives of Oregonians and millions of others worldwide.
<u>HCR 24</u>	Rules In memoriam: Gretchen Miller Kafoury, 1942-2015.
<u>HB 5010</u>	Ways and Means Appropriates moneys from General Fund to Columbia River Gorge Commission for biennial expenses.
<u>HB 5011</u>	Ways and Means Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Construction Contractors Board.
<u>HB 5014</u>	Ways and Means Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Oregon Board of Dentistry.
<u>HB 5023</u>	Ways and Means Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Mortuary and Cemetery Board, Oregon Board of Naturopathic Medicine, Occupational Therapy Licensing Board, Board of Medical Imaging, State Board of Examiners for Speech-Language Pathology and Audiology and Oregon State Veterinary Medical Examining Board.
<u>HB 5028</u>	Ways and Means Appropriates moneys from General Fund to Land Use Board of Appeals for biennial expenses.
<u>HB 5031</u>	Ways and Means Approves new fee adopted by Board of Medical Imaging.
<u>HB 2083</u>	Finance and Revenue For purposes of homestead property tax deferral program, creates exception to five-year ownership requirement for homestead if claimant for deferral moved to homestead from homestead granted deferral and of greater real market value than new homestead, sells prior homestead within one year of purchasing new homestead, satisfies lien against prior homestead for deferred amounts and provides written attestation that claimant incurred debt for not more than 80 percent of purchase price of new homes

<u>HB 2130</u>	Finance and Revenue Authorizes governing bodies to adopt reasonable maximum periods for holding property for development as low income rental housing, additional criteria for exemption of low income rental housing and additional provisions of low income rental housing program that do not conflict with statutory criteria .
<u>HB 3086</u>	Rules Requires City of Damascus, if city is disincorporated, to notify public of city's obligation to satisfy city's debts and obligations and to encourage creditors to present claims to city to ensure timely payment.
<u>HB 3348</u>	Rules Designates March 10 of each year as "Mighty Oregon" Day.
<u>HB 3497</u>	Education Modifies method by which minimum amount distributed to education service districts is calculated.
<u>HB 3530</u>	Health Care Prohibits specified terms imposed on vision care provider by vision care insurance or vision care discount card.
