| <a href="#"><u>HB 5007</u></a> | <b>Ways and Means</b><br>Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Board of Chiropractic Examiners.                           |
| <a href="#"><u>HB 5013</u></a> | <b>Ways and Means</b><br>Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Oregon Board of Licensed Professional Counselors and Therapists. |
| <a href="#"><u>HB 5027</u></a> | <b>Ways and Means</b><br>Appropriates moneys from General Fund to Department of Land Conservation and Development for certain biennial expenses.  |
| <a href="#"><u>HB 5033</u></a> | <b>Ways and Means</b><br>Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by State Board of Psychologist Examiners.                           |
| <a href="#"><u>HB 5037</u></a> | <b>Ways and Means</b><br>Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Department of State Lands for certain purposes.                  |
| <a href="#"><u>HB 2690</u></a> | <b>Finance and Revenue</b><br>Exempts from property taxation land acquired and held by nonprofit corporation for building residences to be sold to individuals whose income is not greater than 80 percent of area median income.                                     |
| <a href="#"><u>HB 3475</u></a> | <b>Rules</b><br>Enacts Interstate Compact for Agreement Among the States to Elect the President by National Popular Vote.   |
| <a href="#"><u>HB 3483</u></a> | <b>Rules</b><br>Adds secular organizations and members and former members of Legislative Assembly to list of persons and entities authorized to solemnize marriages.  |
| <a href="#"><u>HB 3510</u></a> | <b>Rules</b><br>Requires legislative measures to contain brief and impartial statement of problem measure is intended to solve.   |
