SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Allows landscaping business to arrange for construction work on certain projects involving both construction contracting and landscaping work.

Allows State Landscape Contractors Board to place landscaping business license or landscape contractor license in inactive status. States responsibilities and restrictions for inactive licensees.

Changes definitions for landscape contractor, licensee and nursery stock. Changes exemptions from landscape contracting laws.

Expands grounds for levying of civil penalties. Allows board to place landscaping business and associated landscape contractor on probation if board receives three or more claims against landscaping business.

Expands board authority to suspend or refuse to renew license. Authorizes board to require continuing education for landscape contractors.

Changes bond amount for landscaping businesses working on certain projects. Requires landscaping businesses to increase bond amount as necessary for compliance.

Limits amount paid from landscaping business's bond, letter of credit or deposit for nonowner

(2) The board may place a landscaping business or landscape contractor on probation under this section only if the board determines after investigation of the complaints that a significant likelihood exists that continued activity by the landscaping business or landscape contractor without board supervision will result in additional claims against the landscaping business.

(3) The board may require as a condition of probation imposed under this section that
the landscape contractor take a board-approved education course in one or more subjects
relating to landscape contracting.

(4) The board may require as a condition of probation imposed under this section that
 the owner or officer of the landscaping business take a board-approved education course in
 one or more subjects relating to landscaping business or general business practices.

(5) The board may take action to suspend, revoke or refuse to renew the license of the
 landscaping business or landscape contractor if the contractor or business fails to fulfill the
 terms of the probation.

36 <u>SECTION 6.</u> In addition to any other remedy available, if the State Landscape Contrac-37 tors Board believes that a person has engaged in, is engaging in or is about to engage in any 38 act, practice or transaction that violates ORS 671.510 to 671.710, the board may direct the 39 Attorney General to apply to the court for an injunction to restrain the person from engag-30 ing in the act, practice or transaction.
