**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Expands crime of murder to include death committed with criminal negligence by person driving under influence of intoxicants if person has specified record.]* **Creates crime of aggravated vehicular homicide. Punishes by mandatory minimum sentence of imprisonment of 20 years, maximum fine of \$375,000, or both.**

Expands crime of assault in first degree to include injury caused with criminal negligence by person driving under influence of intoxicants if person has specified record.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. (1) Criminal homicide constitutes aggravated vehicular homicide when it is**  
7 **committed with criminal negligence by a person while the person is operating a vehicle under**  
8 **the influence of intoxicants as described in ORS 813.010 and the person has been convicted:**

9 **(a) Of driving while under the influence of intoxicants in violation of ORS 813.010 or its**  
10 **statutory counterpart in another jurisdiction at least one time previously and, as a result**  
11 **of that act, caused the death of, or serious physical injury to, another person; or**

12 **(b) Previously of manslaughter in the first or second degree under ORS 163.118 or 163.125,**  
13 **criminally negligent homicide under ORS 163.145, assault in the first, second or third degree**  
14 **under ORS 163.165, 163.175 or 163.185 or its statutory counterpart in another jurisdiction, in**  
15 **which the death or serious physical injury was the result of the defendant's state of**  
16 **intoxication while driving.**

17 **(2) Aggravated vehicular homicide is a Class A felony.**

18 **SECTION 2. ORS 163.005 is amended to read:**

19 163.005. (1) A person commits criminal homicide if, without justification or excuse, the person  
20 intentionally, knowingly, recklessly or with criminal negligence causes the death of another human  
21 being.

22 (2) "Criminal homicide" is murder, manslaughter, [*or*] criminally negligent homicide **or aggra-**  
23 **ated vehicular homicide.**

24 (3) "Human being" means a person who has been born and was alive at the time of the criminal  
25 act.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.  
New sections are in **boldfaced** type.

**SECTION 3.** ORS 137.700 is amended to read:

137.700. (1) When a person is convicted of one of the offenses listed in subsection (2)(a) of this section and the offense was committed on or after April 1, 1995, or of one of the offenses listed in subsection (2)(b) of this section and the offense was committed on or after October 4, 1997, **or of the offense described in subsection (2)(c) of this section and the offense was committed on or after the effective date of this 2005 Act**, the court shall impose, and the person shall serve, at least the entire term of imprisonment listed in subsection (2) of this section. The person is not, during the service of the term of imprisonment, eligible for release on post-prison supervision or any form of temporary leave from custody. The person is not eligible for any reduction in, or based on, the minimum sentence for any reason whatsoever under ORS 421.121 or any other statute. The court may impose a greater sentence if otherwise permitted by law, but may not impose a lower sentence than the sentence specified in subsection (2) of this section.

42 137.707. (1)(a) Notwithstanding any other provision of law, when a person charged with aggra-

43 vated murder, as defined in ORS 163.095, or an offense listed in subsection (4)(a) of this section is

44 15, 16 or 17 years of age at the time the offense is committed, and the offense is committed on or

45 after April 1, 1995, or when a person charged with an offense listed in subsection (4)(b) of this sec-

tion is 15, 16 or 17 years of age at the time the offense is committed[,] and the offense is committed on or after October 4, 1997, or when a person charged with the offense described in subsection (4)(c) of this section is 15, 16 or 17 years of age at the time the offense is committed and the offense is committed on or after the effective date of this 2005 Act, the person shall be prosecuted as an adult in criminal court.

The person is not, during the service of the term of imprisonment, eligible for release on post-prison supervision or any form of temporary leave from custody. The person is not eligible for any reduction in, or based on, the minimum sentence for any reason under ORS 421.121 or any other provision of law. ORS 138.012, 163.105 and 163.150 apply to sentencing a person prosecuted under this section and convicted of aggravated murder under ORS 163.095 except that a person who was under 18 years of age at the time the offense was committed is not subject to a sentence of death.

 8 (5) If a person charged with an offense under this section is found guilty of a lesser included  
 9 offense and the lesser included offense is:

10 (a) An offense listed in subsection (4) of this section, the court shall sentence the person as  
 11 provided in subsection (2) of this section.

12 (b) Not an offense listed in subsection (4) of this section:

13 (A) But constitutes an offense for which waiver is authorized under ORS 419C.349, the court,

14 (b) **With criminal negligence violates ORS 163.175 (1)(a) or (c) while the person is oper-**  
15 **ating a vehicle under the influence of intoxicants as described in ORS 813.010 and the person**  
16 **has been convicted:**

17 (A) **Of driving while under the influence of intoxicants in violation of ORS 813.010 or its**  
18 **statutory counterpart in another jurisdiction:**

19 (i) **At least three times previously; or**

29 181.085. (1) The Department of State Police is authorized to:

30 (a) Store blood and buccal samples received under authority of this section, ORS 137.076, 161.325  
31 and 419C.473 (1) and section 2, chapter 852, Oregon Laws 2001, and other physical evidence obtained  
32 from analysis of such samples;

33 (b) Analyze such samples for the purpose of establishing the genetic profile of the donor or  
34 otherwise determining the identity of persons or contract with other qualified public or private  
35 laboratories to conduct that analysis;

36 (c) Maintain a criminal identification database containing information derived from blood and  
37 buccal analyses;

38 (d) Utilize such samples to create statistical population frequency databases, provided that ge-  
39 netic profiles or other such information in a population frequency database shall not be identified  
40 with specific individuals; and

41 (e) Adopt rules establishing procedures for obtaining, transmitting and analyzing blood and  
42 buccal samples and for storing and destroying blood and buccal samples and other physical evidence  
43 and criminal identification information obtained from such analysis. Procedures for blood and buccal  
44 analyses may include all techniques which the department determines are accurate and reliable in  
45 establishing identity, including but not limited to, analysis of DNA (deoxyribonucleic acid), antigen

1 antibodies, polymorphic enzymes or polymorphic proteins.

2 (2) If the department is unable to analyze all samples due to lack of funds, the department shall  
3 analyze samples in the following order:

4 (a) The department shall first analyze samples from persons convicted of:

5 (A) Rape, sodomy, unlawful sexual penetration, sexual abuse, public indecency, incest or using  
6 a child in a display of sexually explicit conduct, as those offenses are defined in ORS 163.355 to  
7 163.427, 163.465 (1)(c), 163.525 and 163.670;

8 (B) Burglary in the second degree, as defined in ORS 164.215;

9 (C) Promoting or compelling prostitution, as defined in ORS 167.012 and 167.017;

25 the department shall analyze samples from persons convicted of any other felony.

26 (3) Notwithstanding subsection (2) of this section, the department may analyze a sample from a  
27 lower priority before all samples in higher priorities are analyzed if required in a particular case  
28 for law enforcement purposes.

29 (4) The department may not transfer or disclose any sample, physical evidence or criminal  
30 identification information obtained, stored or maintained under authority of this section, ORS  
31 137.076, 161.325 or 419C.473 (1) except:

32 (a) To a law enforcement agency as defined in ORS 181.010, a district attorney or the Criminal  
33 Justice Division of the Department of Justice for the purpose of establishing the identity of a person  
34 in the course of a criminal investigation or proceeding;

35 (b) To a party in a criminal prosecution or juvenile proceeding pursuant to ORS 419C.005 if  
36 discovery or disclosure is required by a separate statutory or constitutional provision; or

37 (c) To a court or grand jury in response to a lawful subpoena or court order when the evidence  
38 is not otherwise privileged and is necessary for criminal justice purposes.

39 (5) The department may not transfer or disclose any sample, physical evidence or criminal  
40 identification information under subsection (4) of this section unless the public agency or person  
41 receiving the sample, physical evidence or criminal identification information agrees to destroy the  
42 sample, physical evidence or criminal identification information if notified by the department that  
43 a court has reversed the conviction, judgment or order that created the obligation to provide the  
44 blood or buccal sample.

45 (6) Any public agency that receives a sample, physical evidence or criminal identification in-



1 formation under authority of subsection (4) of this section may not disclose it except as provided in  
2 subsection (4) of this section.

3 (7) Notwithstanding subsections (4) and (6) of this section, any person who is the subject of a  
4 record within a criminal identification database maintained under the authority of this section may,  
5 upon request, inspect that information at a time and location designated by the department. The  
6 department may deny inspection if it determines that there is a reasonable likelihood that such in-  
7 spection would prejudice a pending criminal investigation. In any case, the department is not re-  
8 quired to allow the person or anyone acting on the person's behalf to test any blood or buccal  
9 sample or other physical evidence. The department shall adopt procedures governing the inspection  
10 of records and samples and challenges to the accuracy of records. The procedures shall accommo-  
11 date the need to preserve the materials from contamination and destruction.

12 (8)(a) Whenever a court reverses the conviction, judgment or order that created an obligation  
13 to provide a blood or buccal sample under ORS 137.076 (2), 161.325 or 419C.473 (1), the person who  
14 provided the sample may request destruction of the sample and any criminal identification record  
15 created in connection with that sample.

16 (b) Upon receipt of a written request for destruction pursuant to this section and a certified  
17 copy of the court order reversing the conviction, judgment or order, the department shall destroy  
18 any sample received from the person, any physical evidence obtained from that sample and any  
19 criminal identification records pertaining to the person, unless the department determines that the  
20 person has otherwise become obligated to submit a blood or buccal sample as a result of a separate  
21 conviction, juvenile adjudication or finding of guilty except for insanity for an offense listed in ORS  
22 137.076 (1). When the department destroys a sample, physical evidence or criminal identification  
23 record under this paragraph, the department shall notify any public agency or person to whom the  
24 sample, physical evidence or criminal identification information was transferred or disclosed under  
25 subsection (4) of this section of the reversal of the conviction, judgment or order.

26 (c) The department is not required to destroy an item of physical evidence obtained from a blood  
27 or buccal sample if evidence relating to another person subject to the provisions of ORS 137.076,  
28 161.325, 181.085, 419A.260 and 419C.473 (1) would thereby be destroyed. Notwithstanding this sub-  
29 section, no sample, physical evidence or criminal identification record is affected by an order to set  
30 aside a conviction under ORS 137.225.

31 (9) As used in this section, "convicted" includes a juvenile court finding of jurisdiction based  
32 on ORS 419C.005.

33 **SECTION 7.** ORS 419A.260 is amended to read:

34 419A.260. (1) As used in this section and ORS 419A.262:

35 (a) "Contact" means any instance in which a person's act or behavior, or alleged act or behav-  
36 ior, which could result in a juvenile court's assumption of jurisdiction under ORS 419B.100 (1)(a) to  
37 (c) and (f) or 419C.005 comes to the attention of an agency specified in paragraph (d) of this sub-  
38 section.

39 (b) "Expunction" means:

40 (A) The removal and destruction or sealing of a judgment or order related to a contact and all  
41 records and references; and

42 (B) Where a record is kept by the Department of Human Services or the Oregon Youth Au-  
43 thority, either the sealing of such record by the department or the Oregon Youth Authority or, in  
44 a multiperson file, the affixing to the front of the file, by the department or the youth authority, a  
45 stamp or statement identifying the name of the individual, the date of expunction and instruction

1 that no further reference shall be made to the material that is subject to the expunction order ex-  
2 cept upon an order of a court of competent jurisdiction.

3 (c) "Person" includes a person under 18 years of age.

4 (d) "Record" includes a fingerprint or photograph file, report, exhibit or other material which  
5 contains information relating to a person's contact with any law enforcement agency or juvenile  
6 court or juvenile department and is kept manually, through the use of electronic data processing  
7 equipment, or by any other means by a law enforcement or public investigative agency, a juvenile  
8 court or juvenile department or an agency of the State of Oregon. "Record" does not include:

9 (A) A transcript of a student's Youth Corrections Education Program academic record;

10 (B) Material on file with a public agency which is necessary for obtaining federal financial  
11 participation regarding financial assistance or services on behalf of a person who has had a contact;

12 (C) Records kept or disseminated by the Department of Transportation, State Marine Board and  
13 State Fish and Wildlife Commission pursuant to juvenile or adult order or recommendation;

14 (D) Police and court records related to an order of waiver where the matter is still pending in  
15 the adult court or on appeal therefrom, or to any disposition as an adult pursuant to such order;

16 (E) Records related to a support obligation;

17 (F) Medical records;

18 (G) Records of a proposed or adjudicated termination of parental rights and adoptions;

19 (H) Any law enforcement record of a person who currently does not qualify for expunction or  
20 of current investigations or cases waived to the adult court;

21 (I) Records and case reports of the Oregon Supreme Court and the Oregon Court of Appeals;

45 (g) **Aggravated vehicular homicide.**

1 (2) A person's driving privileges shall be revoked as a habitual offender if the person, within a  
2 five-year period, has been convicted of 20 or more of any one or more of the following offenses as  
3 evidenced by the records maintained by the department or by a similar agency of another state:

4 (a) Any offenses enumerated in subsection (1) of this section.

5 (b) Any offense specified in the rules of the department adopted under ORS 809.605.
