

HOUSE AMENDMENTS TO HOUSE BILL 2932

9 Delete lines 4 through 7 and insert:

10 **"SECTION 1. (1) The Department of Veterans' Affairs is established.**

11 **"(2) The department is under the supervision and control of a director appointed as pro-**
12 **vided in ORS 406.020.**

13 **"(3) The department is responsible for the administration of federal and state laws re-**
14 **lating to veterans.**

15 **"SECTION 2. The transfer of duties, functions and powers to the Department of Veter-**
16 **ans' Affairs by the amendments to statutes and laws in sections 5 to 75 of this 2005 Act does**
17 **not affect any action, proceeding or prosecution involving or with respect to the duties,**
18 **functions and powers begun before and pending at the time of the transfer, except that the**
19 **Department of Veterans' Affairs is substituted for the Director of Veterans' Affairs in the**
20 **action, proceeding or prosecution.**

21 **"SECTION 3. (1) Nothing in the amendments to statutes and laws by sections 5 to 75 of**
22 **this 2005 Act relieves a person of a liability, duty or obligation accruing under or with respect**
23 **to the duties, functions and powers transferred by the amendments to statutes and laws by**
24 **sections 5 to 75 of this 2005 Act. The Department of Veterans' Affairs may undertake the**
25 **collection or enforcement of any such liability, duty or obligation.**

26 **"(2) The rights and obligations of the Director of Veterans' Affairs legally incurred under**
27 **contracts, leases and business transactions executed, entered into or begun before the ef-**
28 **fective date of the amendments to statutes and laws by sections 5 to 75 of this 2005 Act are**
29 **transferred to the Department of Veterans' Affairs. For the purpose of succession to these**
30 **rights and obligations, the Department of Veterans' Affairs is a continuation of the Director**
31 **of Veterans' Affairs and not a new authority.**

32 **"SECTION 4. Notwithstanding the transfer of duties, functions and powers by the**
33 **amendments to statutes and laws in sections 5 to 75 of this 2005 Act, the rules of the Di-**
34 **rector of Veterans' Affairs in effect on the effective date of the amendments to statutes and**
35 **laws by sections 5 to 75 of this 2005 Act continue in effect until superseded or repealed by**

1 **rules of the Department of Veterans' Affairs. References in rules of the Director of Veter-**
2 **ans' Affairs to the Director of Veterans' Affairs are considered to be references to the De-**
3 **partment of Veterans' Affairs.**

4 **"SECTION 5.** ORS 406.020 is amended to read:

5 "406.020. The *[office of]* **Department of Veterans' Affairs shall be under the supervision and**
6 **control of the** Director of Veterans' Affairs. *[is created and shall be filled by appointment of the*
7 *Governor]* **The Governor shall appoint the director** subject to confirmation by the Senate in the
8 manner provided in ORS 171.562 and 171.565. *[Such]* **The** appointment *[shall]* **may** not be made
9 without the written approval of the Advisory Committee provided for in ORS 406.210. The director
10 shall be a war veteran, chosen on the basis of executive and administrative ability.

11 **"SECTION 6.** ORS 406.030 is amended to read:

12 "406.030. (1) The Director of Veterans' Affairs, in the performance of the duties of the director,
13 shall organize and coordinate the administration of all present and future federal and state laws
14 pertaining to war veterans and their dependents in this state. *[For such purpose the director may*
15 *establish such units or divisions as in the opinion of the director will enhance the efficiency of the*
16 *administration and promote the welfare of war veterans and their dependents. Any unit or division so*
17 *established shall be directly responsible to the director and shall be under the supervision of the di-*
18 *rector.]*

19 "(2) The *[director]* **Department of Veterans' Affairs**, with the advice of the Advisory Commit-
20 tee provided for in ORS 406.210, shall promulgate such rules and adopt such forms as the *[director]*
21 **department** considers necessary and expedient to carry out the provisions of ORS chapter 407 and
22 ORS 88.710 to 88.740, 174.105, 406.010 to 406.090, 406.210 to 406.340, 406.410, 406.420, 408.010 to
23 408.090, 408.360, 408.365, 408.370, 408.375, 408.380 and 408.385.

24 **"SECTION 7.** ORS 406.040 is amended to read:

25 "406.040. The powers, authority and duties relating exclusively to war veterans' affairs now or
26 hereafter imposed by law upon any officer or agency of this state, are hereby also granted to and
27 imposed upon the *[Director]* **Department** of Veterans' Affairs. Subject to ORS 406.090, the
28 *[director]* **department** shall be responsible for and shall supervise the administration of all such
29 laws. The *[director]* **department** may employ such personnel as may be necessary to carry into ef-
30 fect the purposes of this chapter and may prescribe the duties and responsibilities of all such em-
31 ployees.

32 **"SECTION 8.** ORS 406.050 is amended to read:

33 "406.050. In addition to other powers and duties, the Director of Veterans' Affairs **or the De-**
34 **partment of Veterans' Affairs** is authorized:

35 "(1) To cooperate with officers and agencies of the United States in all matters affecting veter-
36 ans' welfare.

37 "(2) To accept grants, donations and gifts on behalf of this state for veterans' welfare from any
38 person, corporation, government or governmental agency. Grants, donations and gifts so received
39 shall be deposited with the State Treasurer and credited to a trust fund. Moneys in the trust fund
40 are continuously appropriated to the *[director]* **department** and expendable for the purposes speci-
41 fied in subsections (3) and (4) of this section. Interest earned on the moneys in the trust fund cre-
42 ated under this subsection shall accrue to the trust fund.

43 "(3) To expend all or any portion of a grant, donation or gift for the purposes specified in the
44 grant, donation or gift.

45 "(4) To expend all or any portion of a grant, donation or gift in the trust fund created under

1 subsection (2) of this section for the administration of ORS 406.010 to 406.070, 406.090, 406.210,
2 406.220 and 406.340 and for the administration and purposes of ORS 408.368 when:

3 “(a) The [*director*] **department** determines that the purpose specified in the grant, donation or
4 gift has been satisfied, or is not feasible or appropriate; or

5 “(b) The grant, donation or gift specifies no purpose.

6 “(5) To donate or otherwise transfer all or any portion of a grant, donation or gift to other
7 persons, corporations or entities engaged in serving veterans if the [*director*] **department** deter-
8 mines that the nature of the grant, donation or gift makes use by the [*director*] **department** or
9 conversion to cash for use by the [*director*] **department** not feasible or appropriate.

10 “(6) To act as agent or attorney in fact for any war veteran and the dependents or beneficiaries
11 of any war veteran relating to rights under any federal or state law.

12 “(7) To act without bond as conservator of the estate of:

13 “(a) A person who qualifies for benefits from the United States Department of Veterans Affairs.

14 “(b) A dependent, an immediate family member, a survivor or a former spouse who has not re-
15 married of a person who qualifies for benefits, or who qualified for benefits while alive, from the
16 United States Department of Veterans Affairs, as those persons are defined by rule by the director.

17 “(8) On behalf of the State of Oregon to extend such assistance as the [*director*] **Department**
18 **of Veterans’ Affairs** shall determine to be reasonably required to any war veteran and to the de-
19 pendents of any such war veteran, in the prosecution of any claim or claims before the United States
20 Department of Veterans Affairs, or any other federal or state agency, the securing of employment
21 or relief and any other benefits to which they might be entitled. The [*director*] **Department of**
22 **Veterans’ Affairs** may adopt rules and regulations with respect to all matters of administration to
23 carry into effect the purposes of this section.

24 “(9) To require and collect such reasonable service charges as the [*director*] **Department of**
25 **Veterans’ Affairs** deems necessary and expedient to carry out a duty, or to exercise a power or
26 authority, conferred on the [*director*] **department** by law.

27 “**SECTION 9.** ORS 406.060 is amended to read:

28 “406.060. The [*Director*] **Department** of Veterans’ Affairs may utilize the services and facilities
29 of any state agency in the course of administration of any law of this state enacted for the benefit
30 and welfare of war veterans and their dependents. All such agencies shall cooperate fully with the
31 [*director*] **department** in that regard and furnish such services and facilities when called upon by
32 the [*director*] **department** to do so. Neither the authority nor the duties referred to in this section
33 shall be so exercised or performed as to impair the efficient administration of the laws applicable
34 to any state agency.

35 “**SECTION 10.** ORS 406.085 is amended to read:

36 “406.085. The Conservatorship Revolving Account is created, separate and distinct from the
37 General Fund, to provide for disbursement of funds for the beneficiary. Funds may also be disbursed
38 from the Conservatorship Revolving Account to the Conservatorship Services Account in compen-
39 sation for claims arising under ORS 406.100. The Conservatorship Revolving Account shall consist
40 of all money received by the [*Director*] **Department** of Veterans’ Affairs as conservator or personal
41 representative herein. Disbursement from the account shall be made by the [*director*] **department**,
42 and the Secretary of State shall post audit all the disbursements. Interest earned by the account
43 shall be credited to the account.

44 “**SECTION 11.** ORS 406.090 is amended to read:

45 “406.090. The administration of ORS 273.035 to 273.051, 273.071, 273.161 to 273.175 and 408.710

1 to 408.750 shall in no way be affected by ORS 406.010 to 406.070, 406.210, 406.220 and 406.340, and
2 such laws are excepted from the operation thereof. The [Director] **Department** of Veterans' Affairs
3 shall cooperate with the person or agency responsible for the administration of such laws, and shall
4 render such reasonable assistance in that regard as may be requested by any such person or agency.

5 "**SECTION 12.** ORS 406.100 is amended to read:

6 "406.100. If the [Director] **Department** of Veterans' Affairs is appointed as a conservator under
7 ORS 406.050 or a personal representative under ORS 113.085, the [director] **department** shall have
8 a claim against the estate of the protected person or the decedent, as the case may be, for all of the
9 following:

10 "(1) Reasonable expenses incurred by the [director] **department** in the execution or adminis-
11 tration of the estate.

12 "(2) After the appointment of the [director] **department** as conservator, compensation for ordi-
13 nary services in an amount not to exceed five percent of income to the estate, and reasonable
14 compensation for unusual services as set forth by rule by the [director] **department**.

15 "(3) After the appointment of the [director] **department** as personal representative, compen-
16 sation as provided in ORS 116.173.

17 "(4) With prior approval by the court having probate jurisdiction over the estate, fees charged
18 to the [director] **department** by the Attorney General for advice or assistance in the performance
19 of the [director's] **department's** duties as conservator or personal representative of the estate.

20 "**SECTION 13.** ORS 406.120 is amended to read:

21 "406.120. (1) The Conservatorship Services Account is established as a separate account within
22 the Oregon War Veterans' Fund. The Conservatorship Services Account shall consist of all moneys
23 received by the [Director] **Department** of Veterans' Affairs as payment of claims arising under ORS
24 406.100.

25 "(2) The moneys in the Conservatorship Services Account are continuously appropriated to the
26 [director] **department** for payment of expenses incurred while serving as conservator under ORS
27 406.050 or personal representative under ORS 406.085.

28 "(3) Moneys in the Conservatorship Services Account shall be held and set aside separately from
29 the other moneys in the Oregon War Veterans' Fund, but such account may be accounted for as part
30 of the Oregon War Veterans' Fund.

31 "**SECTION 14.** ORS 406.130 is amended to read:

32 "406.130. There hereby is established in the General Fund of the State Treasury an account to
33 be known as the Veterans' Services Account. Moneys in the Veterans' Services Account are con-
34 tinuously appropriated to the [Director] **Department** of Veterans' Affairs and shall be used by the
35 [director] **department** for grants and services supplied to veterans by the [director] **department**
36 under ORS chapters 406 and 408, and for expenses of administration of such grants and services.

37 "**SECTION 15.** ORS 407.085 is amended to read:

38 "407.085. (1) As used in Article XI-A, Oregon Constitution, and this chapter, for the purposes
39 of administration:

40 "(a) 'Acquisition' means:

41 "(A) Purchase and improvement of a home or farm.

42 "(B) Payment of the balance of the purchase price and interest on a purchase contract, and the
43 improvement of property thereby acquired.

44 "(C) Refinance of an existing purchase-money mortgage or mortgage in the nature thereof, and
45 the improvement of property thereby purchased.

1 “(D) Improvement of a home or farm.

2 “(b) ‘Bonds’ includes, but is not limited to, serial bonds, term bonds, notes, obligations, lines of
3 credit, revolving credit agreements, loans, financing agreements or other evidence of indebtedness
4 determined by the [Director] **Department** of Veterans’ Affairs, with the approval of the State
5 Treasurer, to be necessary or desirable to provide funds for the purposes expressed in Article XI-A
6 of the Oregon Constitution.

7 “(2) As used in this chapter:

8 “(a) ‘Committee’ means the Advisory Committee provided for by ORS 406.210.

9 “[*b*] ‘Director’ means the Director of Veterans’ Affairs.]

10 “[*c*] (b) ‘Home’ means any residential-type structure, including outbuildings and the real prop-
11 erty in connection with it, if any, including long-term leaseholds, which is established, maintained
12 and used primarily as a principal residence by the veteran.

13 “[*d*] (c) ‘Improvement’ means new construction or any necessary or beneficial additions, alter-
14 ations or changes appurtenant to the home or farm which protect or improve the basic livability or
15 energy efficiency of the premises.

16 “[*e*] (d) ‘Mobile home’ means a structure, transportable in one or more sections, which is 10
17 feet or more in width, and contains more than 500 square feet of living space figured on exterior
18 dimensions of the structure, exclusive of any hitch and is designed to be used as a dwelling by one
19 family, and which remains as personal property under the laws of this state.

20 “**SECTION 16.** ORS 407.095 is amended to read:

21 “407.095. (1) It is the policy of the State of Oregon to make every reasonable attempt to keep
22 a veteran in the home purchased under the loan program when the veteran is unable to make re-
23 quired loan payments because of illness, injury, death, involuntary job loss or economic stress due
24 to factors beyond individual control. The [Director] **Department** of Veterans’ Affairs, by rule, shall
25 implement such state policy. Rules adopted by the [*director*] **department** under this section:

26 “(a) May provide for a temporary reduction of loan payment.

27 “(b) May provide for any other solution jointly agreed to by the borrower and the [*director*]
28 **department**.

29 “(c) Shall provide for repayment of the amount of any loan payments reduced under the rules
30 in accordance with terms and conditions agreed upon by the borrower and the [*director*] **depart-**
31 **ment**.

32 “(2) In reducing loan payments under this section, the [*director*] **department** must consider the
33 effect of such reduction on the solvency of the program as a whole, on estimates of the most prob-
34 able financial position of the program for one or more future periods, the condition of the tax ex-
35 empt bond market, and the effect on other borrowers in the program.

36 “**SECTION 17.** ORS 407.115 is amended to read:

37 “407.115. The [Director] **Department** of Veterans’ Affairs shall administer the provisions of ORS
38 407.125, 407.165, 407.205, 407.275, 407.415, 407.495 and 407.515 to 407.565. The [*director*] **department**
39 may adopt [*and promulgate*] all necessary rules [*and regulations*] not inconsistent with those sections
40 to carry into effect their provisions. The [*director*] **department** may appoint assistants and agents
41 necessary to expeditious and efficient administration and fix their compensation.

42 “**SECTION 18.** ORS 407.125 is amended to read:

43 “407.125. All moneys in the Oregon War Veterans’ Fund created by ORS 407.495 may be ad-
44 vanced by the [Director] **Department** of Veterans’ Affairs as loans to any person qualified for loans
45 under the provisions of section 3, Article XI-A, Oregon Constitution, for the acquisition of farms and

1 homes, as provided in ORS 407.115, 407.165, 407.205, 407.275, 407.415, 407.495 and 407.515 to 407.565
2 and not otherwise.

3 “**SECTION 19.** ORS 407.131 is amended to read:

4 “407.131. The [*Director*] **Department** of Veterans’ Affairs, by rule, may discount a portion of the
5 principal payable to the [*director*] **department** in connection with a home or farm loan or in con-
6 nection with a purchase contract for a home or farm if such action results in economic benefit to
7 the home and farm loan program after considering the time value of money.

8 “**SECTION 20.** ORS 407.135 is amended to read:

9 “407.135. The [*Director*] **Department** of Veterans’ Affairs is authorized and empowered, in the
10 name and in behalf of the state to commence and prosecute to judgment all suits, actions and pro-
11 ceedings necessary to protect the interest of the state; to bid in property offered for sale under such
12 proceedings and to acquire title to property for and in behalf of the state as a result of such pro-
13 ceedings; to accept deeds from borrowers in lieu of foreclosure; to sell, transfer, convey, lease or
14 assign any property acquired by the [*director*] **department** for and in behalf of the state; to make
15 repairs and improvements or alterations; to pay taxes, liens and charges of every kind superior to
16 the lien of the state; and otherwise to administer such property in such manner as the [*director*]
17 **department** deems to the best interest of the state. All money received by the [*director*] **depart-**
18 **ment** from the sale, leasing or other disposition of any property shall be paid over to the State
19 Treasurer and deposited in the Oregon War Veterans’ Bond Sinking Account.

20 “**SECTION 21.** ORS 407.145 is amended to read:

21 “407.145. (1) The [*Director*] **Department** of Veterans’ Affairs may acquire property by purchase
22 when the acquisition of such property is necessary to protect the interest of the state because of
23 default in repayment of loans made in accordance with ORS 407.125 or statutes supplementary
24 thereof. The **department shall exercise** control of all [*such*] **the** property while the title remains
25 vested in the state [*shall be exercised by the director*].

26 “(2) The [*director*] **department** may take [*such*] **any** action and make [*such*] disbursements as
27 may be necessary to protect the securities for loans acquired under this chapter. Any disbursement
28 so made shall be added to the amount due from the borrower and shall bear interest at the rate then
29 fixed for home improvement loans under ORS 407.325 or at the rate on the existing loan, whichever
30 is higher. Any such disbursement shall be made only upon order of the [*director*] **department**.

31 “(3) Funds for the protection of security may be disbursed from the Oregon War Veterans’ Fund
32 including the Oregon War Veterans’ Bond Sinking Account as the [*director*] **department** shall de-
33 termine.

34 “**SECTION 22.** ORS 407.155 is amended to read:

35 “407.155. All deeds, leases, contracts, releases of mortgages and other instruments necessary or
36 proper in the administration of this chapter shall be executed in behalf of the state by the
37 [*Director*] **Department** of Veterans’ Affairs and shall be acknowledged by the [*director*]
38 **department**; and all deeds, mortgages, notes, insurance policies, abstracts and other instruments,
39 documents and papers delivered to the [*director*] **department** in the administration of those sections
40 shall be kept in the custody of the [*director*] **department**.

41 “**SECTION 23.** ORS 407.165 is amended to read:

42 “407.165. The [*Director*] **Department** of Veterans’ Affairs may receive and hold for future dis-
43 position conditional payments from borrowers who have executed mortgages and security instru-
44 ments under authority of ORS 407.225, indemnities for fire losses on secured property, and such
45 other sums as must be held by the [*director*] **department** in suspense pending further or final dis-

1 position thereof. Said funds shall be deposited in the State Treasury in the revolving account au-
2 thorized by ORS 407.565 until they can be properly applied to the purposes for which they were paid
3 to and received by the [director] **department**.

4 “**SECTION 24.** ORS 407.169 is amended to read:

5 “407.169. (1) The [Director] **Department** of Veterans’ Affairs shall make escrow accounts avail-
6 able to current and future borrowers and contract purchasers in connection with loan agreements
7 and purchase contracts made under this chapter.

8 “(2) Escrow accounts established under this section shall be consistent with general lending and
9 servicing standards for real estate loan agreements in this state and with the standards used by the
10 United States Department of Veterans Affairs and the Federal Housing Administration.

11 “(3) Notwithstanding ORS 86.245 (5) and (7), the [director] **Department of Veterans’ Affairs**
12 shall pay interest to a borrower or contract purchaser on funds deposited in the escrow account for
13 the borrower or contract purchaser in the manner and at the rate of interest described in ORS
14 86.245 (1) to (4).

15 “(4) The [director] **department** shall adopt such rules as the [director] **department** considers
16 necessary to establish criteria for implementation of this section.

17 “(5) As used in this section, ‘escrow account’ means any account which is part of a real estate
18 loan agreement or purchase contract, whether incorporated into the agreement or contract or as
19 part of a separately executed document, whereby the borrower makes periodic prepayment to the
20 [director] **department** of estimated property taxes, and the [director] **department** pays the charges
21 out of the account at the due dates.

22 “**SECTION 25.** ORS 407.177 is amended to read:

23 “407.177. (1) When the [Director] **Department** of Veterans’ Affairs considers such contracts
24 necessary to improve the financial condition of the loan program conducted under this chapter, the
25 [director] **department** is authorized to enter into contracts with lending institutions under which the
26 lending institutions may provide any of the following services:

27 “(a) Processing of new loans and purchase contracts; and

28 “(b) Management and servicing of new loans and purchase contracts.

29 “(2) Contracts entered into by the [director] **department** under this section may provide that the
30 lending institution:

31 “(a) Receive applications for loans for the acquisition of homes or farms under this chapter;

32 “(b) Immediately investigate and process an application for a loan as provided by law; and

33 “(c) For approved loans or contracts, if requested by the [director] **department**, service the loan
34 or purchase contract for a period of time specified by the [director] **department**.

35 “(3) When a lending institution, pursuant to a contract authorized by this section, receives an
36 application for a loan for the acquisition of a manufactured home, as defined in ORS 197.295, the
37 lending institution shall investigate and process the application in the manner prescribed in the
38 contract between the lending institution and the [director] **department**.

39 “(4) When a lending institution, pursuant to a contract authorized by this section, investigates
40 and processes a loan application that it considers eligible for approval under this chapter, the
41 lending institution shall notify the [director] **department** and state the reasons why the loan may
42 be approved under this chapter. The [director] **department** shall retain final authority to approve
43 or disapprove the loan. If the [director] **department** disapproves the loan, the [director] **department**
44 shall notify the lending institution and the applicant of the disapproval and shall indicate the rea-
45 sons for the disapproval. When the [director] **department** is satisfied that all requirements for ap-

1 proval of a loan have been met by the applicant and the lending institution and that the property
2 offered as security for the loan protects the interests of the state, the [director] **department** shall
3 transfer to the lending institution an amount of money from the Oregon War Veterans' Fund equal
4 to the loan amount approved by the [director] **department**. The lending institution shall disburse the
5 money in the manner prescribed by the [director] **department**. The lending institution shall record
6 the mortgage, trust deed, contract or other security agreement relating to the loan and then shall
7 forward all the original loan documents to the [director] **department**.

8 “(5) All moneys received by a lending institution as payments on principal and interest for loans
9 made under this chapter shall be paid to the [director] **department** in accordance with the terms
10 of the contract between the [director] **department** and the lending institution.

11 “(6) The [director] **department** and lending institution shall mutually agree upon the compen-
12 sation to be paid to the lending institution for services performed under a contract authorized by
13 this section. Such compensation may be a fixed annual payment or a percentage of the amount of
14 each loan or purchase contract processed or serviced by the lending institution under the contract.

15 “(7) Contracts entered into under this section are exempt from the requirements of the pro-
16 visions of ORS chapter 279 regarding personal service contracts.

17 “(8) As used in this section, ‘lending institution’ means an entity that is licensed to conduct
18 business in the State of Oregon exclusively or in part as a mortgage lender or a conduit for mort-
19 gage loans and that, in the judgment of the [director] **department**, is capable of meeting the needs
20 of the [director] **department** in carrying out this chapter.

21 “**SECTION 26.** ORS 407.177, as amended by section 273, chapter 794, Oregon Laws 2003, is
22 amended to read:

23 “407.177. (1) When the [Director] **Department** of Veterans' Affairs considers such contracts
24 necessary to improve the financial condition of the loan program conducted under this chapter, the
25 [director] **department** is authorized to enter into contracts with lending institutions under which the
26 lending institutions may provide any of the following services:

27 “(a) Processing of new loans and purchase contracts; and

28 “(b) Management and servicing of new loans and purchase contracts.

29 “(2) Contracts entered into by the [director] **department** under this section may provide that the
30 lending institution:

31 “(a) Receive applications for loans for the acquisition of homes or farms under this chapter;

32 “(b) Immediately investigate and process an application for a loan as provided by law; and

33 “(c) For approved loans or contracts, if requested by the [director] **department**, service the loan
34 or purchase contract for a period of time specified by the [director] **department**.

35 “(3) When a lending institution, pursuant to a contract authorized by this section, receives an
36 application for a loan for the acquisition of a manufactured home, as defined in ORS 197.295, the
37 lending institution shall investigate and process the application in the manner prescribed in the
38 contract between the lending institution and the [director] **department**.

39 “(4) When a lending institution, pursuant to a contract authorized by this section, investigates
40 and processes a loan application that it considers eligible for approval under this chapter, the
41 lending institution shall notify the [director] **department** and state the reasons why the loan may
42 be approved under this chapter. The [director] **department** shall retain final authority to approve
43 or disapprove the loan. If the [director] **department** disapproves the loan, the [director] **department**
44 shall notify the lending institution and the applicant of the disapproval and shall indicate the rea-
45 sons for the disapproval. When the [director] **department** is satisfied that all requirements for ap-

1 proval of a loan have been met by the applicant and the lending institution and that the property
2 offered as security for the loan protects the interests of the state, the *[director]* **department** shall
3 transfer to the lending institution an amount of money from the Oregon War Veterans' Fund equal
4 to the loan amount approved by the *[director]* **department**. The lending institution shall disburse the
5 money in the manner prescribed by the *[director]* **department**. The lending institution shall record
6 the mortgage, trust deed, contract or other security agreement relating to the loan and then shall
7 forward all the original loan documents to the *[director]* **department**.

8 “(5) All moneys received by a lending institution as payments on principal and interest for loans
9 made under this chapter shall be paid to the *[director]* **department** in accordance with the terms
10 of the contract between the *[director]* **department** and the lending institution.

11 “(6) The *[director]* **department** and lending institution shall mutually agree upon the compen-
12 sation to be paid to the lending institution for services performed under a contract authorized by
13 this section. Such compensation may be a fixed annual payment or a percentage of the amount of
14 each loan or purchase contract processed or serviced by the lending institution under the contract.

15 “(7) Contracts entered into under this section are exempt from the requirements of the pro-
16 visions of ORS chapters 279, 279A, 279B and 279C regarding personal services contracts.

17 “(8) As used in this section, ‘lending institution’ means an entity that is licensed to conduct
18 business in the State of Oregon exclusively or in part as a mortgage lender or a conduit for mort-
19 gage loans and that, in the judgment of the *[director]* **department**, is capable of meeting the needs
20 of the *[director]* **department** in carrying out this chapter.

21 “**SECTION 27.** ORS 407.179 is amended to read:

22 “407.179. In addition to the powers described in ORS 407.177, the *[Director]* **Department** of
23 Veterans' Affairs also may delegate by contract to a lending institution any of the powers granted
24 to the *[director]* **department** in ORS 407.165 and 407.225. The *[director]* **department** shall retain
25 final authority to approve or disapprove loans and interpret the duties and responsibilities of bor-
26 rowers under this chapter.

27 “**SECTION 28.** ORS 407.185 is amended to read:

28 “407.185. In addition to, and not in lieu of, the audit required by ORS 297.210 the *[Director]*
29 **Department** of Veterans' Affairs may contract with an independent public accountancy organiza-
30 tion for a review of the cash flow projection for the loan program established under this chapter
31 and Article XI-A of the Oregon Constitution and of the assumptions used in developing that
32 projection. The review shall be conducted in accordance with the review guidelines developed by the
33 American Institute of Certified Public Accountants (AICPA). Such contract shall require a written
34 report, copies of which shall be provided to the Governor, the Secretary of State, the State Treas-
35 urer, the President of the Senate, and the Speaker of the House of Representatives by the
36 *[director]* **department** no later than December 31 of each year. Payment for the services required
37 under the contract shall be paid from funds appropriated for the administration of the department
38 *[of Veterans' Affairs]*.

39 “**SECTION 29.** ORS 407.201 is amended to read:

40 “407.201. (1) When making a loan or otherwise extending credit under this chapter with moneys
41 from the Oregon War Veterans' Fund, the *[Director]* **Department** of Veterans' Affairs shall comply
42 with Title I (Truth in Lending Act) of the Consumer Credit Protection Act, as amended (15 U.S.C.
43 1601 et seq.) in the same manner required for a bank or national bank, as defined in ORS 706.008,
44 when the bank extends credit in a transaction in which a security interest in real property is or
45 will be acquired.

1 “(2) In addition to the requirements of subsection (1) of this section, the [*director*] **department**
2 shall notify each person seeking to acquire a home or farm under this chapter, prior to the signing
3 of a loan agreement or contract, of the variable interest rate provisions of ORS 407.275, 407.315,
4 407.325 and 407.335. Information required to be disclosed under this subsection includes a history
5 of the interest rate increases on loans during the preceding 10 years and an estimate of the financial
6 effect that an increase of one percent in the interest rate will have on the borrower’s obligation
7 under the mortgage, contract or other security agreement.

8 “**SECTION 30.** ORS 407.205 is amended to read:

9 “407.205. (1) Applications for loans for acquisition of a home or farm under this chapter shall
10 be made to the [*Director*] **Department** of Veterans’ Affairs. Loans exclusive of funds disbursed un-
11 der ORS 407.145 (2) and 407.275 (4) shall not exceed the maximum original principal balance per-
12 mitted on a single-family first mortgage loan by the Federal National Mortgage Association, as
13 published in its announcements and subsequently included in its Selling Guide, for a home or
14 \$185,000 for a farm at a rate of interest provided by ORS 407.325. Except as provided in subsection
15 (2) of this section, an eligible individual shall not receive or, under ORS 407.305, assume more than
16 two loans under this chapter. No applicant is entitled to borrow more than the maximum amount
17 allowed under this section, except that [*where*] **when** a loan is made on property which is destroyed
18 by fire or other natural hazard, taken through condemnation or lost or disposed of for a compelling

41 “407.225. (1) When the [*Director*] **Department** of Veterans’ Affairs receives an application pur-
42 suant to ORS 407.205, the [*director*] **department** shall immediately investigate and process it as
43 provided by law. The security for the loan shall consist of the property to be acquired by the vet-
44 eran as a home or a farm. The security shall be secured by a mortgage or security agreement in the
45 full amount of the loan which mortgage or security agreement shall be either a first lien or a lien

1 insured by mortgagee's title insurance against loss from any prior encumbrance. The [*director*] **de-**

21 “407.275. (1) Loans may be made bearing interest at the rate per annum prescribed as provided
22 by ORS 407.325. Loans may be amortized over a period of not more than 30 years for homes other

35 “(3) Ownership of property that constitutes security for a loan made under this chapter and
36 Article XI-A of the Oregon Constitution [*shall*] **may** not be transferred by deed or otherwise to
37 anyone other than the surviving spouse, unremarried former spouse, surviving child or stepchild of
38 the original borrower, or a veteran eligible for a loan under this chapter and Article XI-A of the
39 Oregon Constitution, who assumes the previous loan as described in ORS 407.305, unless the prop-
40 erty is used primarily as the principal residence of the transferee for at least two years after the
41 transfer or such shorter period of time as the [*director*] **department** for good cause may allow.

42 “(4) Mortgages, trust deeds or security agreements on property given to secure any loan made
43 under ORS 407.125 or statutes supplementary thereof may provide that the taxes and insurance
44 premiums may be paid by the [*director*] **department** from the Oregon War Veterans' Bond Sinking
45 Account. The amount so paid may be added to and become part of the principal of the loan and be

1 repaid as prescribed by the [*director*] **department**. The [*director*] **department** may prescribe any
2 method or period for repayment of the amount so paid that is not in conflict with the mortgage, trust
3 deed or security agreement. The [*director*] **department** may prescribe any method or period for re-
4 payment of interest on the amount so paid that is not in conflict with the mortgage, trust deed, se-
5 curity agreement or a separate agreement with the borrower.

6 “**SECTION 33.** ORS 407.285 is amended to read:

7 “407.285. (1) Notwithstanding the repeal of section 5, chapter 11, Oregon Laws 1982 (first special
8 session), during the term of a loan for which the interest rate was initially fixed under section 5,
9 chapter 11, Oregon Laws 1982 (first special session), the [*Director*] **Department** of Veterans’ Affairs
10 may periodically prescribe the interest rate to be paid by the transferee. However, the interest rate
11 for such loans [*shall*] **may** not at any time be less than the rate initially fixed under section 5,
12 chapter 11, Oregon Laws 1982 (first special session), nor exceed a rate per annum which is one
13 percent higher than the rate initially fixed under section 5, chapter 11, Oregon Laws 1982 (first
14 special session).

15 “(2) The [*director*] **department** may prescribe the interest rate to be paid by the transferee at
16 a rate greater than the rate described in subsection (1) of this section, but only to the extent nec-
17 essary to avoid invoking the provisions of section 4, Article XI-A of the Oregon Constitution.

18 “**SECTION 34.** ORS 407.295 is amended to read:

19 “407.295. When an ownership interest or possession of a home or farm securing a loan received
20 under this chapter is transferred to the spouse or former spouse of the original borrower as a result
21 of any judicial order or judgment, the [*Director*] **Department** of Veterans’ Affairs shall be notified
22 in writing of the transfer by the transferee not later than 30 days after the transfer occurs. If the
23 original borrower remains obligated under the order or judgment to make the payments on the
24 principal and interest of the loan, the [*director*] **department** shall notify the transferee when any
25 such loan payment is not received by the 30th day after the payment is due.

26 “**SECTION 35.** ORS 407.315 is amended to read:

27 “407.315. (1) When a veteran assumes a previous loan under ORS 407.305, the interest rate to
28 be paid by the veteran from the date of assumption shall be the rate per annum prescribed period-
29 ically by the [*Director*] **Department** of Veterans’ Affairs, taking into consideration the solvency of
30 the loan program and the interest rates currently prevailing in this state for loans secured by
31 owner-occupied residential property.

32 “(2) The [*director*] **department** shall make a cash flow projection to determine if assumptions
33 at the interest rate established under subsection (1) of this section are among the causes of a neg-

38 “(a) Loans or purchase contracts made after September 27, 1987, for acquisition of homes or
39 farms.

40 “(b) Obligations on loans or purchase contracts made on or before September 27, 1987, where
41 ownership of the property subject to the loan or purchase contract is transferred after September
42 27, 1987.

43 “(2) The [*director*] **department** may modify loan agreements or purchase contracts made before
44 September 27, 1987, by changing fixed interest rates to variable or variable interest rates to fixed,
45 if all the parties to such loan agreements or contracts agree in writing to such modification.

1 “**SECTION 38.** ORS 407.335 is amended to read:

2 “407.335. (1) The rate of interest referred to in ORS 407.275 (2) shall be prescribed periodically
3 by the [*Director*] **Department** of Veterans’ Affairs, taking into consideration the solvency of the
4 loan program and the interest rates currently prevailing in this state for loans secured by residen-
5 tial property. However, a transfer [*shall*] **may** not be made at a rate lower than the interest rate
6 existing on the loan immediately prior to the transfer.

7 “(2) When the [*director*] **department** considers it necessary to change the rate of interest under
8 subsection (1) of this section, the [*director*] **department**, after 30 days’ notice to the public, may
9 prescribe a new rate under this section.

26 “407.349. When a periodic installment payment due under a loan agreement or purchase contract
27 made pursuant to this section and ORS 407.169 or under a prior agreement or contract authorizing
28 a late charge is not received by the [*Director*] **Department** of Veterans’ Affairs by the due date, the
29 [*director*] **department** may impose a late charge with respect to any such payment as prescribed in
30 ORS 86.160 to 86.185.

31 “**SECTION 40.** ORS 407.375 is amended to read:

32 “407.375. (1) When the [*Director*] **Department** of Veterans’ Affairs offers for sale a home or farm
33 obtained for and in behalf of the state under ORS 407.135 and 407.145 (1), the [*director*] **department**
34 shall provide notice of the proposed sale to prospective purchasers. The notice shall state the min-
35 imum bid that will be accepted.

36 “(2) Subject to subsection (3) of this section, the [*director*] **department** shall accept the highest
37 such bid or offer received during the 15-day period after a home or farm acquired under ORS 407.135
38 or 407.145 (1) is first offered for sale unless the person making the highest bid or offer is disqualified
39 from such purchase based on prior credit history, inadequate income or other grounds for refusal
40 established in rules adopted by the [*director*] **department**. Prior to such refusal, the person making

34 “(C) The Public Employees Retirement System;

35 “(f) An agency, department or instrumentality of any municipality in the state, including but not
36 limited to such agencies as the Portland Development Commission;

37 “(g) An insurer as defined in ORS 731.106;

38 “(h) A private mortgage insurance company;

39 “(i) A pension plan or fund or other retirement plan; and

40 “(j) A broker-dealer or investment adviser as defined in ORS 59.015.

41 “(5) ‘Forfeiting agency’ means the State of Oregon or a political subdivision thereof that has
42 accepted for forfeiture property seized by a seizing agency or that is processing a forfeiture case.

43 “(6) ‘Forfeiture counsel’ means an attorney designated to represent a forfeiting agency in
44 forfeiture actions or proceedings.

45 “(7) ‘Law enforcement agency’ means any agency which employs police officers or prosecutes

1 criminal cases.

2 “(8) ‘Official law enforcement use’ or ‘official law enforcement activity’ means uses or activities
3 which may reasonably be expected to result in the identification, apprehension or conviction of
4 criminal offenders.

5 “(9) ‘Police officer’ has the meaning given that term in ORS 133.525.

6 “(10) ‘Proceeds of prohibited conduct’ means property derived directly or indirectly from, main-
7 tained by or realized through an act or omission, and includes any benefit, interest or property of
8 any kind without reduction for expenses of acquiring or maintaining it or incurred for any other
9 reason.

10 “(11) ‘Prohibited conduct’ includes violation of, solicitation to violate, attempt to violate or
11 conspiracy to violate any provisions of ORS 475.005 to 475.285 and 475.805 to 475.999 when the
12 conduct constitutes either a felony or misdemeanor as those terms are defined in ORS 161.525 and
13 161.545.

14 “(12) ‘Property’ means any interest in anything of value, including the whole of any lot or tract
15 of land and tangible and intangible personal property, including currency, instruments or securities
16 or any other kind of privilege, interest, claim or right whether due or to become due.

17 “(13) ‘Seizing agency’ means a law enforcement agency that has seized property for forfeiture.

18 “(14) ‘Weapon’ means any instrument of offensive or defensive combat or anything used, or de-
19 signed to be used, in destroying, defeating or injuring a person.”.
