

SENATE AMENDMENTS TO B-ENGROSSED HOUSE BILL 3481

1 On page 1 of the printed B-engrossed bill, line 2, after “ORS” insert “276.212,”.

2 In line 4, delete “468.183,” and after “469.320” insert “, 646.905” and after “1993” insert “, and
3 sections 9, 15 and 17, chapter 918, Oregon Laws 2001”.

4 Delete lines 7 through 20 and delete pages 2 through 26 and insert:

“BIOFUEL, ETHANOL AND VERIFIED FUEL ADDITIVE FACILITIES

8 “**SECTION 1.** ORS 307.701 is amended to read:

9 “307.701. (1) As used in this section:

10 “(a) **‘Biofuel’ means liquid or gaseous fuel produced from a biological source, including**
11 **but not limited to waste and residue from agriculture, forestry or related industries or other**
12 **industrial or municipal waste.**

13 “(b) **‘Ethanol’** has the meaning given the term under ORS 646.905.

14 “(c) **‘Production facility’ means a facility that is used to produce ethanol, biofuel or ver-**
15 **ified fuel additives.**

16 “(d) **‘Verified fuel additive’ means a fuel additive that:**

17 “(A) **Has been verified under the United States Environmental Protection Agency’s En-**
18 **vironmental Technology Verification Protocol or the California Air Resources Board verifi-**
19 **cation programs; and**

20 “(B) **Is at least 90 percent renewable materials.**

21 “(2) Upon compliance with subsection (4) of this section, the real and personal property of [*an*
22 *ethanol*] a production facility that meets the requirements of subsection (3) of this section is exempt
23 from taxation. The exemption shall be 50 percent of the assessed value of the property determined
24 under ORS 308.146. The exemption under this section may be claimed for five assessment years.

25 “(3) [*An ethanol*] **A** production facility may qualify for exemption from taxation under this sec-
26 tion if the facility:

27 “(a) Is [*first*] in the process of construction, erection or installation as a new facility after July
28 1, 1993;

29 “(b) Is or will be placed in service to produce ethanol, **biofuel or verified fuel additives** within
30 [*four*] **five** years after January 1 of the first assessment year for which [*the*] **an** exemption [*under this*
31 *section*] is claimed **under this section or ORS 285C.170 or 285C.175; [*and*]**

32 “(c) **Consists of newly constructed, installed or acquired property, including property that**
33 **was previously owned by a different owner and used at a different location, that is first**
34 **placed in service during the calendar year preceding the assessment year for which an ex-**
35 **emption listed in paragraph (b) of this subsection is claimed; and**

1 “[(c)] **(d)** Within *[four]* **five** years after January 1 of the first assessment year for which *[the]*
2 **an** exemption *[under this section]* **listed in paragraph (b) of this subsection** is claimed, is or will
3 be certified by the State Department of Agriculture as a facility that produces:

4 **“(A)** Ethanol capable of blending or mixing with gasoline. The blend or mixture shall meet the
5 specifications or registration requirements established by the United States Environmental Pro-
6 tection Agency pursuant to section 211 of the Clean Air Act, 42 U.S.C. 7545 and 40 C.F.R. Part
7 79[.];

8 **“(B) Biofuel; or**

9 **“(C) Verified fuel additives.**

10 **“(4)(a)(A)** In order to claim an exemption from taxation under this section for any assessment
11 year, the owner of *[an ethanol]* **a** production facility shall file with the county assessor, on or before
12 April 1 of the year for which exemption is claimed, a statement verified by the oath or affirmation
13 of the owner listing all real and personal property claimed to be exempt and showing the purpose
14 for which the property will be or is used.

15 **“(B) In the case of a biofuel production facility or a verified fuel additive production fa-**
16 **ility, in addition to the requirements of subparagraph (A) of this paragraph, the application**
17 **for exemption must include all of the following:**

18 **“(i) A list of the taxing districts in which the property is located; and**

19 **“(ii) A copy of a written notice mailed to each taxing district. The notice must:**

20 **“(I) State that the applicant is seeking a property tax exemption under this section;**

21 **“(II) State that a taxing district may elect not to participate in the exemption, in which**
22 **case taxes of the district will continue to be imposed on the property of the applicant; and**

23 **“(III) Comply with any other requirements established by the Department of Revenue.**

24 **“(b)** If the ownership and use of the **production facility** property included in the statement
25 **described in paragraph (a)(A) of this subsection and** filed for a prior year remain the same, a
26 new statement *[shall not be]* **is not** required. However, if the ownership or use changes, or if the
27 facility property is added to or retired, a new statement is required and the property *[shall]* **may**
28 not be exempt under this section if the statement is not filed. The new statement *[shall]* **must** be
29 filed no later than December 31 of the year to which the statement pertains.

30 **“(5)** If the **production** facility property is not placed in service within the time required under
31 subsection (3) of this section, or if the certification required under subsection (3) of this section is
32 not obtained within the required time, then the facility property *[shall]* **may** not be exempt for any
33 year under this section. For any year for which the property has been granted exemption under this
34 section, the county assessor shall add the property to the assessment and tax roll as omitted prop-
35 erty in the manner provided under ORS 311.216 to 311.232.

36 **“SECTION 2. (1) A city, county or other local taxing district with property tax authority**
37 **may elect not to participate in an exemption for a biofuel production facility or a verified fuel**
38 **additive production facility granted under ORS 307.701.**

39 **“(2) A taxing district may make the election by filing written notification of the election**
40 **with the county assessor of the county in which the taxing district is located before July 1**
41 **of the first tax year for which the election is to be effective.**

42 **“(3) An election made under this section shall be valid for all tax years following the year**
43 **for which the election is first made, until the election is revoked by the taxing district.**

44 **“(4) A taxing district may revoke an election made under this section by filing written**
45 **notification of the revocation with the county assessor of the county in which the taxing**

1 district is located before July 1 of the first tax year for which the revocation is to be effective.
2

3 “(5) The written notifications of election and revocation described in this section shall
4 contain the information and be in the form prescribed by the Department of Revenue.

5 “(6) An election or revocation made under this section applies to all biofuel production
6 facility property or verified fuel additive production facility property within the taxing district:
7

8 “(a) For which an application has been filed under ORS 307.701; and

9 “(b) That qualifies for exemption under ORS 307.701.

10 “**SECTION 3.** The amendments to ORS 307.701 by section 1 of this 2005 Act apply to pro-
11 duction facilities for which an application for exemption under ORS 307.701 is first filed on
12 or after January 1, 2006, for tax years beginning on or after July 1, 2006.

13 “**SECTION 4.** Section 4, chapter 475, Oregon Laws 1993, is amended to read:

14 “**Sec. 4.** [(1) *An ad valorem property tax exemption provided by section 2 of this Act is first ap-
15 plicable to the tax year beginning July 1, 1994.*]

16 “[2) *Section 2 of this Act is repealed on July 1, 2008. The repeal applies to tax years beginning
17 on or after July 1, 2008. Notwithstanding that an ethanol production facility has not received five
18 years of exemption under section 2 of this Act, no exemption for the facility shall be granted under
19 section 2 of this Act for a tax year beginning on or after July 1, 2008.*] **An exemption for a pro-
20 duction facility may not be granted under ORS 307.701 for any production facility that has
21 not qualified for at least one year of exemption as of July 1, 2012.**

22 “POLLUTION CONTROL FACILITIES 23 24

25 “**SECTION 5.** ORS 468.155 is amended to read:

26 “468.155. (1)(a) As used in ORS 468.155 to 468.190, unless the context requires otherwise, ‘pol-
27 lution control facility’ or ‘facility’ means any land, structure, building, installation, excavation, ma-
28 chinery, equipment or device, or any addition to, reconstruction of or improvement of, land or an
29 existing structure, building, installation, excavation, machinery, equipment or device reasonably
30 used, erected, constructed or installed by any person if:

31 “(A) The principal purpose of such use, erection, construction or installation is to comply with
32 a requirement imposed by the Department of Environmental Quality, the federal Environmental
33 Protection Agency or regional air pollution authority to prevent, control or reduce air, water or
34 noise pollution or solid or hazardous waste or to recycle or provide for the appropriate disposal of
35 used oil; or

36 “(B) The sole purpose of such use, erection, construction or installation is to prevent, control
37 or reduce a substantial quantity of air, water or noise pollution or solid or hazardous waste or to
38 recycle or provide for the appropriate disposal of used oil.

39 “(b) Such prevention, control or reduction required by this subsection shall be accomplished by:

40 “(A) The disposal or elimination of or redesign to eliminate industrial waste and the use of
41 treatment works for industrial waste as defined in ORS 468B.005;

42 “(B) The disposal or elimination of or redesign to eliminate air contaminants or air pollution
43 or air contamination sources and the use of air cleaning devices as defined in ORS 468A.005;

44 “(C) The substantial reduction or elimination of or redesign to eliminate noise pollution or noise
45 emission sources as defined by rule of the Environmental Quality Commission;

1 “(D) The use of a material recovery process which obtains useful material from material that
2 would otherwise be solid waste as defined in ORS 459.005, hazardous waste as defined in ORS
3 466.005, or used oil as defined in ORS 459A.555; or

4 “(E) The treatment, substantial reduction or elimination of or redesign to treat, substantially
5 reduce or eliminate hazardous waste as defined in ORS 466.005.

6 “(2)(a) As used in ORS 468.155 to 468.190, ‘pollution control facility’ or ‘facility’ includes a
7 nonpoint source pollution control facility **that meets the requirements of subsection (1)(a) of**
8 **this section.**

9 “(b) As used in this subsection, ‘nonpoint source pollution control facility’ means a facility that
10 the Environmental Quality Commission has identified by rule as reducing or controlling significant
11 amounts of nonpoint source pollution.

12 “(3)(a) As used in ORS 468.155 to 468.190, ‘pollution control facility’ or ‘facility’ includes
13 **any of the following that meet the requirements of subsection (1)(a) of this section:**

14 “(A) **A biofuel processing plant;**

15 “(B) **A biofuel production plant;**

16 “(C) **A farm storage facility that is used exclusively for storing crops used to produce**
17 **biofuel and that was not used for any other purpose prior to the date on which an application**
18 **for certification under ORS 468.165 is filed;**

19 “(D) **A biomass conversion plant that uses forest materials, thinnings, slash, brush,**
20 **waste or by-products from manufacturing activities to produce electric energy, direct appli-**
21 **cation heat, transportation fuel or a substitute for a petroleum-based product;**

22 “(E) **Equipment used in biofuel processing or biofuel production; or**

23 “(F) **Equipment used for growing crops that are harvested for biofuel purposes.**

24 “(b) **As used in this subsection, ‘biofuel’ means liquid or gaseous fuel produced from a**
25 **biological source, including but not limited to waste and residue from agriculture, forestry**
26 **or related industries or other industrial or municipal waste.**

27 “[3] (4) As used in ORS 468.155 to 468.190, ‘pollution control facility’ or ‘facility’ does not in-
28 clude:

29 “(a) Air conditioners;

30 “(b) Septic tanks or other facilities for human waste;

31 “(c) Property installed, constructed or used for moving sewage to the collecting facilities of a
32 public or quasi-public sewerage system;

33 “(d) Any distinct portion of a pollution control facility that makes an insignificant contribution
34 to the principal or sole purpose of the facility including the following specific items:

35 “(A) Office buildings and furnishings;

36 “(B) Parking lots and road improvements;

37 “(C) Landscaping;

38 “(D) External lighting;

39 “(E) Company or related signs; and

40 “(F) Automobiles;

41 “(e) Replacement or reconstruction of all or a part of any facility for which a pollution control
42 facility certificate has previously been issued under ORS 468.170, except:

43 “(A) If the cost to replace or reconstruct the facility is greater than the like-for-like replacement
44 cost of the original facility due to a requirement imposed by the department, the federal Environ-
45 mental Protection Agency or a regional air pollution authority, then the facility may be eligible for

1 tax credit certification up to an amount equal to the difference between the cost of the new facility
2 and the like-for-like replacement cost of the original facility; or

3 “(B) If a facility is replaced or reconstructed before the end of its useful life then the facility
4 may be eligible for the remainder of the tax credit certified to the original facility;

5 “(f) Asbestos abatement; or

6 “(g) Property installed, constructed or used for cleanup of emergency spills or unauthorized re-
7 leases, as defined by the commission.

8 “**SECTION 6.** ORS 468.165 is amended to read:

9 “468.165. (1) Any person may apply to the Environmental Quality Commission for certification
10 under ORS 468.170 of a pollution control facility or portion thereof erected, constructed or installed
11 by the person in Oregon if:

12 “(a) The air or water pollution control facility was erected, constructed or installed on or after
13 January 1, 1967.

14 “(b) The noise pollution control facility was erected, constructed or installed on or after January
15 1, 1977.

16 “(c) The solid waste facility was under construction on or after January 1, 1973, the hazardous
17 waste or used oil facility was under construction on or after October 3, 1979, and if:

18 “(A) The facility’s principal or sole purpose conforms to the requirements of ORS 468.155 (1) and
19 (2);

20 “(B) The facility will utilize material that would otherwise be solid waste as defined in ORS
21 459.005, hazardous waste as defined in ORS 466.005 or used oil as defined in ORS 459A.555 by me-
22 chanical process or chemical process or through the production, processing including presegre-
23 gation, or use of, materials which have useful chemical or physical properties and which may be
24 used for the same or other purposes, or materials which may be used in the same kind of application
25 as its prior use without change in identity;

26 “(C) The end product of the utilization is an item of real economic value;

27 “(D) The end product of the utilization, other than a usable source of power, is competitive with
28 an end product produced in another state; and

29 “(E) The Oregon law regulating solid waste imposes standards at least substantially equivalent
30 to the federal law.

31 “(d) The hazardous waste control facility was erected, constructed or installed on or after Jan-
32 uary 1, 1984, and if:

33 “(A) The facility’s principal or sole purpose conforms to the requirements of ORS 468.155 (1) and
34 (2); and

35 “(B) The facility is designed to treat, substantially reduce or eliminate hazardous waste as de-
36 fined in ORS 466.005.

37 “(e) **The biofuel production facility was erected, constructed or installed on or after**
38 **January 1, 2006, and the facility’s purpose conforms to the requirements of ORS 468.155 (1)(a)**
39 **and (3).**

40 “(2) The application shall be made in writing in a form prescribed by the Department of Envi-
41 ronmental Quality and shall contain information on the actual cost of the facility, a description of
42 the materials incorporated therein, all machinery and equipment made a part thereof, the existing
43 or proposed operational procedure thereof, and a statement of the purpose of prevention, control or
44 reduction of air, water or noise pollution or solid or hazardous waste or recycling or appropriate
45 disposal of used oil served or to be served by the facility and the portion of the actual cost properly

1 allocable to the prevention, control or reduction of air, water or noise pollution or solid or hazard-
2 ous waste or to recycling or appropriately disposing of used oil.

3 “(3) The Director of the Department of Environmental Quality may require any further infor-
4 mation the director considers necessary before a certificate is issued.

5 “(4) The application shall be accompanied by a fee established under subsection (5) of this sec-
6 tion. The fee may be refunded if the application for certification is rejected.

7 “(5) By rule and after hearing the commission may adopt a schedule of reasonable fees which
8 the department may require of applicants for certificates issued under ORS 468.167 and 468.170.
9 Before the adoption or revision of any such fees the commission shall estimate the total cost of the
10 program to the department. The fees shall be based on the anticipated cost of filing, investigating,
11 granting and rejecting the applications and shall be designed not to exceed the total cost estimated
12 by the commission. Any excess fees shall be held by the department and shall be used by the com-
13 mission to reduce any future fee increases. The fee may vary according to the size and complexity
14 of the facility. The fees may not be considered by the commission as part of the cost of the facility
15 to be certified.

16 “(6) The application shall be submitted after construction of the facility is substantially com-
17 pleted and the facility is placed in service and within one year after construction of the facility is
18 substantially completed. Failure to file a timely application shall make the facility ineligible for tax
19 credit certification. An application may not be considered filed until it is complete and ready for
20 processing. The commission may grant an extension of time to file an application for circumstances
21 beyond the control of the applicant that would make a timely filing unreasonable. However, the
22 period for filing an application may not be extended to a date beyond December 31, 2008.

23 “**SECTION 7.** ORS 468.170 is amended to read:

24 “468.170. (1) The Environmental Quality Commission shall act on an application for certification
25 before the 120th day after the filing of the application under ORS 468.165. The action of the com-
26 mission shall include certification of the actual cost of the facility and the portion of the actual cost
27 properly allocable to the prevention, control or reduction of air, water or noise pollution or solid
28 or hazardous waste or to recycling or appropriately disposing of used oil. The actual cost or portion
29 of the actual cost certified may not exceed the taxpayer’s own cash investment in the facility or
30 portion of the facility. Each certificate shall bear a separate serial number for each such facility.

31 “(2) If the commission rejects an application for certification, or certifies a lesser actual cost
32 of the facility or a lesser portion of the actual cost properly allocable to the prevention, control or
33 reduction of air, water or noise pollution or solid or hazardous waste or to recycling or appropri-
34 ately disposing of used oil than was claimed in the application for certification, the commission shall
35 cause written notice of its action, and a concise statement of the findings and reasons therefor, to
36 be sent by registered or certified mail to the applicant before the 120th day after the filing of the
37 application.

38 “(3) If the application is rejected for any reason, including the information furnished by the ap-
39 plicant as to the cost of the facility, or if the applicant is dissatisfied with the certification of actual
40 cost or portion of the actual cost properly allocable to prevention, control or reduction of air, water
41 or noise pollution or solid or hazardous waste or to recycling or appropriately disposing of used oil,
42 the applicant may appeal from the rejection as provided in ORS 468.110. The rejection or the cer-
43 tification is final and conclusive on all parties unless the applicant takes an appeal therefrom as
44 provided in ORS 468.110 before the 30th day after notice was mailed by the commission.

45 “(4)(a) The commission shall certify a pollution control, solid waste, hazardous waste or used

1 oil facility or portion thereof, for which an application has been made under ORS 468.165, if the
2 commission finds that the facility:

3 “(A) Was erected, constructed or installed in accordance with the requirements of ORS 468.165
4 (1);

5 “(B) Is designed for, and is being operated or will operate in accordance with the requirements
6 of ORS 468.155; and

7 “(C) Is necessary to satisfy the intents and purposes of ORS 454.010 to 454.040, 454.205 to
8 454.255, 454.505 to 454.535, 454.605 to 454.755, ORS chapters 459, 459A, 466 and 467 and ORS chap-
9 ters 468, 468A and 468B and rules thereunder.

10 “(b) No determination of the proportion of the actual cost of the facility to be certified shall be
11 made until receipt of the application.

12 “(c) If one or more facilities constitute an operational unit, the commission may certify such
13 facilities under one certificate.

14 “(d) A certificate under this section is effective for purposes of tax relief in accordance with
15 ORS 307.405 and 315.304 if, *on or before December 31, 2007,*] erection, construction or installation
16 of the facility is completed, the facility is placed in service and the application for certification is
17 filed with the commission under ORS 468.165.

18 “(5) A person receiving a certificate under this section may take tax relief only under ORS
19 315.304, depending upon the tax status of the person’s trade or business except that:

20 “(a) A corporation organized under ORS chapter 65 or any subsequent transferee of the corpo-
21 ration shall take tax relief only under ORS 307.405; and

22 “(b)(A) A corporation organized under ORS chapter 62 or any predecessor to ORS chapter 62
23 relating to the incorporation of cooperative associations or the subsequent transferee of the corpo-
24 ration may make an irrevocable election to take the tax relief under either ORS 315.304 or 307.405.
25 The corporation shall make the election at the time of applying for the certificate, except that a
26 corporation receiving a certificate prior to December 31, 1995, may make the election at any time
27 on or before December 31, 1995. If a corporation elects on or before December 31, 1995, to take the
28 tax relief under ORS 315.304, any income taxes, penalties or interest otherwise payable by the cor-
29 poration for improperly taking the tax relief under ORS 315.304 in a taxable year prior to making
30 the election shall be waived.

31 “(B) In the case of a corporation making the election under subparagraph (A) of this paragraph,
32 the election applies to:

33 “(i) All existing or future facilities that are certified under this section, if the corporation
34 claimed a credit under ORS 315.304 for a tax year beginning prior to December 31, 1995; or

35 “(ii) All future facilities that are certified under this section, if the corporation did not claim a
36 credit under ORS 315.304 for a tax year beginning prior to December 31, 1995.

37 “(6) If the person receiving the certificate is a partnership, each partner shall be entitled to take
38 tax credit relief as provided in ORS 315.304, based on that partner’s pro rata share of the certified
39 cost of the facility.

40 “(7) Certification under this section of a pollution control facility qualifying under ORS 468.165
41 (1) shall be granted for a period of 10 consecutive years which 10-year period shall begin with the
42 tax year of the person in which the facility is certified under this section, except that if ad valorem
43 tax relief is utilized by a corporation organized under ORS chapter 62 or 65 the facility shall be
44 exempt from ad valorem taxation for a period of 20 consecutive years.

45 “(8) Portions of a facility qualifying under ORS 468.165 (1)(c) may be certified separately under

1 this section if ownership of the portions is in more than one person. Certification of such portions
2 of a facility shall include certification of the actual cost of the portion of the facility to the person
3 receiving the certification. The actual cost certified for all portions of a facility separately certified
4 under this subsection may not exceed the total cost of the facility that would have been certified
5 under one certificate. The provisions of ORS 315.304 [(8)] (9) apply to any sale, exchange or other
6 disposition of a certified portion of a facility.

7 “(9) A certificate issued under this section shall state the applicable percentage of the certified
8 cost of the facility, as determined under ORS 468.173.

9 “(10) If the construction or installation of a facility is commenced after December 31, 2005, the
10 facility may be certified only if the facility or applicant is described in ORS 468.173 (3). A facility
11 described in ORS 468.173 (2) for which construction or installation is commenced after December
12 31, 2005, may not be certified under this section.

13 **“SECTION 8.** ORS 468.173 is amended to read:

14 “468.173. For purposes of ORS 315.304, the applicable percentage of the certified cost of a fa-
15 cility shall be one of the following:

16 “(1) If the facility is certified under ORS 468.155 to 468.190 (1999 Edition) or if construction or
17 installation of the facility is commenced prior to January 1, 2001, and completed prior to January
18 1, 2004, 50 percent.

19 “(2) Except as provided in subsection (1) or (3) of this section, if the facility is certified pursuant
20 to application for certification filed on or after January 1, 2002, and:

21 “(a) Construction or installation of the facility is commenced on or after January 1, 2001, and
22 on or before December 31, 2003, 25 percent; or

23 “(b) Construction or installation of the facility is commenced after December 31, 2003, and on
24 or before December 31, 2005, 15 percent.

25 “(3) If certified pursuant to application for certification filed on or after January 1, 2002, 35
26 percent if:

27 “(a) The applicant is certified under International Organization for Standardization standard ISO
28 14001;

29 “(b) A Green Permit that applies to the facility has been issued under ORS 468.501 to 468.521;

30 “(c) The facility is a nonpoint source or is regulated as a confined animal feeding operation
31 under ORS 468B.200 to 468B.230;

32 “(d) The facility is used for material recovery or recycling, as those terms are defined in ORS
33 459.005;

34 “(e) The facility is used in an agricultural or forest products operation and is used for energy
35 recovery, as defined in ORS 459.005;

36 “(f) The certified cost of the facility does not exceed \$200,000;

37 “(g) Construction or installation of the facility is entirely voluntary and no portion of it is re-
38 quired in order to comply with a federal law administered by the United States Environmental
39 Protection Agency, a state law administered by the Department of Environmental Quality or a law
40 administered by a regional air pollution authority;

41 “(h) The facility is, at the time of certification, located within an enterprise zone established
42 under ORS 285C.050 to 285C.250 or within an area that has been designated a distressed area, as
43 defined in ORS 285A.010, by the Economic and Community Development Department; [or]

44 **“(i) The facility is a facility described in ORS 468.155 (3); or**

45 **“[(i)] (j) The applicant demonstrates to the Department of Environmental Quality that the ap-**

1 plicant uses an environmental management system at the facility. In order for the department to
2 determine that the applicant uses an environmental management system at the facility:

3 “(A) The applicant must have the environmental management system used at the facility re-
4 viewed by an independent third party familiar with environmental management systems and submit
5 a report to the department stating that the provisions of this paragraph have been met. The report
6 shall be accompanied by supporting materials that document compliance with the provisions of this
7 paragraph. The report shall include certification from a registered or certified environmental man-
8 agement auditor employed by, or under contract with, the independent third party that reviewed the
9 environmental management system; or

10 “(B) The department shall contract with an independent third party familiar with environmental
11 management systems to review the environmental management system employed at the facility. The
12 third party shall review the environmental management system, and, if the third party determines
13 that the environmental management system meets the provisions of this paragraph, a registered or
14 certified environmental management system auditor employed by, or contracted with, the third party
15 shall certify that determination to the department. The department shall recover from the applicant
16 the costs incurred by the department as prescribed in ORS 468.073. An applicant shall be liable for
17 the costs of the department under this subparagraph without regard to whether the department
18 certifies the facility as a pollution control facility. The department may not certify a facility to
19 which this subparagraph applies until the department has received full payment from the applicant.

20 **“SECTION 9. The amendments to ORS 468.155, 468.165, 468.170 and 468.173 by sections 5**

26 **“SECTION 10. Section 11 of this 2005 Act is added to and made a part of ORS chapter 315.**

27 **“SECTION 11. (1) As used in this section:**

28 **“(a) ‘Agricultural producer’ means a person engaged in farming or livestock operations**
29 **that produce the plant or animal matter that is used by a biodiesel or ethanol producer to**
30 **produce biodiesel or ethanol, or a person engaged in farming or forestry operations that**
31 **produce the green biomass used to produce electric energy, direct application heat, trans-**
32 **portation fuel or a substitute for a petroleum-based product.**

33 **“(b) ‘Biodiesel’ means the monoalkyl esters of long-chain fatty acids derived from plant**
34 **or animal matter that meet the registration requirements for fuels and fuel additives es-**
35 **tablished under 42 U.S.C. 7545, as amended and in effect on the effective date of this 2005**
36 **Act, and regulations adopted thereunder.**

37 **“(c)(A) ‘Biomass’ means any organic matter that is available on a renewable or recurring**
38 **basis from wood, forest or field residues or dedicated energy crops that do not include:**

39 **“(i) Wood pieces that have been treated with chemical preservatives such as creosote,**
40 **pentachlorophenol or inorganic arsenical compounds;**

41 **“(ii) Municipal solid waste;**

42 **“(iii) Tires; and**

43 **“(iv) Black liquor.**

44 **“(B) As used in this paragraph, ‘black liquor’ means the liquid material remaining from**
45 **the manufacturing of wood pulp using the soda pulping or kraft pulping process.**

1 “(d) ‘Ethanol’ has the meaning given that term in ORS 646.905.

2 “(2) An agricultural producer shall be allowed a credit against the taxes that would oth-
3 erwise be due under ORS chapter 316 or, if the taxpayer is a corporation, under ORS chapter
4 317 or 318, for the production in this state of plant or animal matter that is used to produce
5 biodiesel or ethanol in this state or that is forest or rangeland vegetative biomass that is
6 used as described in subsection (3)(c) of this section.

7 “(3) The amount of the credit shall equal:

8 “(a) Five cents per gallon of biodiesel produced in this state from plant or animal matter
9 produced in this state;

10 “(b) Four cents per gallon of ethanol produced in this state from plant or animal matter
11 produced in this state; and

12 “(c) Ten dollars per green ton of forest or rangeland vegetative biomass that is delivered
13 to a purchaser to produce, or is used to produce, electric energy, direct application heat,
14 transportation fuel or a substitute for a petroleum-based product.

15 “(4)(a) Each biodiesel producer or ethanol producer shall report to an agricultural pro-
16 ducer the quantity, in gallons, of biodiesel or ethanol produced from plant or animal matter
17 sold to the producer by the agricultural producer. The report shall be made in writing within
18 30 days of the date of sale of the plant or animal matter to the biodiesel or ethanol producer.

19 “(b) Each producer that uses biomass to produce electric energy, direct application heat,
20 transportation fuel or a substitute for a petroleum-based product shall maintain records of
21 the quantity of biomass obtained and the identity of the agricultural producer from whom
22 the biomass was obtained. The producer shall maintain the records for the length of time
23 prescribed by the Department of Revenue.

24 “(5) Except as provided in subsection (7) of this section, the amount of the credit may
25 not:

26 “(a) Exceed the tax liability of the taxpayer; and

27 “(b) Exceed the amount stated on the tax credit certification issued under subsection (9)
28 of this section.

29 “(6) The credit shall be claimed on a form prescribed by the department that contains
30 the information required by the department.

31 “(7) Any tax credit otherwise allowable under this section that is not used by the tax-
32 payer in a particular tax year may be carried forward and offset against the taxpayer’s tax
33 liability for the next succeeding tax year. Any credit remaining unused in the next succeed-
34 ing tax year may be carried forward and used in the second succeeding tax year, and likewise
35 any credit not used in that second succeeding tax year may be carried forward and used in
36 the third succeeding tax year, and any credit not used in that third succeeding tax year may
37 be carried forward and used in the fourth succeeding tax year, but may not be carried for-
38 ward for any tax year thereafter.

39 “(8) In the case of a credit allowed under this section:

40 “(a) A nonresident shall be allowed the credit under this section in the proportion pro-
41 vided in ORS 316.117.

42 “(b) If a change in the status of the taxpayer from resident to nonresident or from non-
43 resident to resident occurs, the credit allowed by this section shall be determined in a man-
44 ner consistent with ORS 316.117.

45 “(c) If a change in the taxable year of the taxpayer occurs as described in ORS 314.085,

1 or if the department terminates the taxpayer's taxable year under ORS 314.440, the credit
2 allowed under this section shall be prorated or computed in a manner consistent with ORS
3 314.085.

4 “(9)(a) Prior to the close of the calendar year in which begins the tax year for which a
5 credit under this section is to be claimed, a taxpayer that seeks to claim a tax credit under
6 this section shall apply to the department for tax credit certification. The application shall
7 be on a form prescribed by the department that contains the information required by the
8 department, including the amount of tax credit the taxpayer intends to claim.

9 “(b) The department shall process applications in the order in which the applications are
10 filed and shall certify the amount stated on the application, or a lesser amount that the de-
11 partment determines is within the annual limit set forth in paragraph (c) of this subsection.
12 The department shall give written notice of the certified amount to the taxpayer.

13 “(c) The department may not certify more than \$500,000 as eligible for tax credits under
14 this section in any calendar year.

15 “(d) The department may deny an application for tax certification if the application is
16 incomplete or if the department determines that the application does not state a reasonable
17 basis for the allowance of any tax credit under this section.

18 “**SECTION 12.** ORS 314.752 is amended to read:

19 “314.752. (1) Except as provided in ORS 314.740 (5)(b), the tax credits allowed or allowable to
20 a C corporation for purposes of ORS chapter 317 or 318 shall not be allowed to an S corporation.
21 The business tax credits allowed or allowable for purposes of ORS chapter 316 shall be allowed or
22 are allowable to the shareholders of the S corporation.

23 “(2) In determining the tax imposed under ORS chapter 316, as provided under ORS 314.734, on

36 taxpayers to encourage certain investment, to create employment, economic opportunity or incentive

39 ment of Revenue by rule and includes but is not limited to the following credits: ORS 285C.309

45 ORS 315.304 (pollution control facility), ORS 315.324 (plastics recycling), ORS 315.354 and ORS

32 1994. A grant made under this paragraph may not exceed \$10,000 per replaced bus.**

37 so that older buses are retrofitted before newer buses are retrofitted.**

38 **“(c) To help school districts meet federal grant matching requirements to perform
39 retrofits of school buses. A grant made under this paragraph may not exceed \$10,000 per
40 school district per year.**

41 **“(d) To provide funding to school districts for pilot projects utilizing biodiesel fuel in
42 school bus applications.**

43 **“(2) For purposes of the State School Fund distribution, the State Board of Education
44 shall consider expenditures by a school district made for the purposes described in subsection
45 (1) of this section to be approved transportation costs.**

2 “(2) When production of ethanol in this state reaches a level of at least 90 million gallons
3 on an annualized basis for at least three months, the department shall notify all retail deal-
4 ers, nonretail dealers and wholesale dealers in this state, as described in subsection (3) of

6 “(3) The notice under subsection (2) of this section shall inform retail dealers, nonretail
7 dealers and wholesale dealers that:

8 “(a) The production of ethanol has reached the levels described in subsection (2) of this

11 wholesale dealer may only sell or offer for sale gasoline described in section 26 of this 2005

13 “**SECTION 26.** (1) A retail dealer, nonretail dealer or wholesale dealer may not sell or
14 offer for sale gasoline unless the gasoline contains at least 10 percent ethanol by volume.

15 “(2) Gasoline containing ethanol that is sold or offered for sale meets the requirements
16 of this section if the gasoline, exclusive of denaturants and permitted contaminants, contains
17 not less than 9.2 percent and not more than 10 percent by volume of agriculturally derived,
18 denatured ethanol that complies with the standards for ethanol adopted by the State De-
19 partment of Agriculture.

20 “(3) The department shall adopt standards for ethanol blended with gasoline sold in this
21 state. The standards adopted shall require that the gasoline blended with ethanol:

22 “(a) Contains ethanol that is agriculturally derived;

23 “(b) Contains ethanol denatured as specified in 27 C.F.R. parts 20 and 21;

24 “(c) Complies with volatility requirements specified in 40 C.F.R. part 80;

25 “(d) Complies with or is produced from a gasoline base stock that complies with the
26 American Society for Testing and Materials International specification D4814-04b, or an
27 equivalent standard;

28 “(e) Is not blended with casinghead gasoline, absorption gasoline, drip gasoline or natural
29 gasoline after it has been sold, transferred or otherwise removed from a refinery or terminal;
30 and

31 “(f) Complies with American Society for Testing and Materials International specification
32 D4806-04a, or an equivalent standard.

33 “(4) The department may review specifications adopted by the American Society for
34 Testing and Materials International, or equivalent organizations, and federal regulations and
35 revise the standards adopted pursuant to this section as necessary.

36 “**SECTION 27.** Section 26 of this 2005 Act becomes operative on a date that is three
37 months following the date of the notice required under section 25 of this 2005 Act.

38 “**SECTION 28.** ORS 646.905 is amended to read:

39 “646.905. As used in ORS 646.910 to 646.920:

40 “(1) ‘Alcohol’ means a volatile flammable liquid having the general formula $C_nH_{(2n+1)}OH$ used
41 or sold for the purpose of blending or mixing with gasoline for use in propelling motor vehicles, and
42 commonly or commercially known or sold as an alcohol, and includes ethanol or methanol.

43 “(2) ‘Biodiesel’ means a monoalkyl ester of long-chain fatty acids derived from vegetable
44 oils or animal fats for use in compression-ignition engines.

45 “[2] (3) ‘Co-solvent’ means an alcohol other than methanol which is blended with either

1 methanol or ethanol or both to minimize phase separation in gasoline.

2 “[3] (4) ‘Ethanol’ means ethyl alcohol, a flammable liquid having the formula C₂H₅OH used or
3 sold for the purpose of blending or mixing with gasoline for use in motor vehicles.

4 “[4] (5) ‘Gasoline’ means any fuel sold for use in spark ignition engines whether leaded or un-
5 leaded.

6 “[5] (6) ‘Methanol’ means methyl alcohol, a flammable liquid having the formula CH₃OH used
7 or sold for the purpose of blending or mixing with gasoline for use in motor vehicles.

8 “[6] (7) ‘Motor vehicles’ means all vehicles, vessels, watercraft, engines, machines or mechan-
9 ical contrivances that are propelled by internal combustion engines or motors.

10 “[7] (8) ‘Nonretail dealer’ means any person who owns, operates, controls or supervises an es-
11 tablishment at which motor vehicle fuel is dispensed through a card- or key-activated fuel dispensing
12 device to nonretail customers.

13 “[8] (9) ‘Retail dealer’ means any person who owns, operates, controls or supervises an estab-
14 lishment at which gasoline is sold or offered for sale to the public.

15 “[9] (10) ‘Wholesale dealer’ means any person engaged in the sale of gasoline if the seller
16 knows or has reasonable cause to believe the buyer intends to resell the gasoline in the same or
17 an altered form to another.

18 **“SECTION 29. (1) The State Department of Agriculture shall study and monitor diesel

7 “(c) An energy facility, except coal and nuclear power plants, if the energy facility:

8 “(A) Sequentially produces electrical energy and useful thermal energy from the same fuel
9 source; and

10 “(B) Under normal operating conditions, has a useful thermal energy output of no less than 33
11 percent of the total energy output or the fuel chargeable to power heat rate value is not greater
12 than 6,000 Btu per kilowatt hour.

13 “(d) Temporary storage, at the site of a nuclear-fueled thermal power plant for which a site
14 certificate has been issued by the State of Oregon, of radioactive waste from the plant.

15 “(e) An energy facility as defined in ORS 469.300 (11)(a)(G), if the plant also produces a sec-
16 ondary fuel used on site for the production of heat or electricity, if the output of the primary fuel
17 is less than six billion Btu of heat a day.

18 “(f) An energy facility as defined in ORS 469.300 (11)(a)(G), if the facility:

19 “(A) **Exclusively** uses [*biomass exclusively from*] grain, whey [*or*], potatoes, **oil seeds, waste**
20 **vegetable oil or cellulosic biomass** as the source of material for conversion to a liquid fuel, **the**
21 **production of electric energy, the generation of heat, the creation of transportation fuels or**
22 **the creation of substitutes for petroleum-based products;**

23 “(B) Has received local land use approval under the applicable acknowledged comprehensive
24 plan and land use regulations of the affected local government and the facility complies with any
25 statewide planning goals or rules of the Land Conservation and Development Commission that are
26 directly applicable to the facility;

27 “(C) Requires no new electric transmission lines or gas or petroleum product pipelines that
28 would require a site certificate under subsection (1) of this section; and

29 “(D) Produces synthetic fuel, at least 90 percent of which is used in an industrial or refueling
30 facility located within one mile of the facility or is transported from the facility by rail or barge.

31 “(g) A temporary energy generating facility, if the facility complies with all applicable carbon
32 dioxide emissions standards adopted by the Energy Facility Siting Council or enacted by statute and
33 the applicant agrees to provide funds to a qualified organization in an amount determined by the
34 council to be sufficient to produce any required reductions in carbon dioxide as specified in ORS
35 469.501. To support the council’s finding that the facility complies with all applicable carbon dioxide
36 emissions standards, the applicant shall provide proof acceptable to the council that shows the
37 contracted nominal electric generating capacity of the facility and the contracted heat rate in
38 higher heating value. The applicant shall pay the funds to the qualified organization before com-
39 mencing construction on the temporary facility. The amount of the carbon dioxide offset funds for
40 a temporary facility shall be subject to adjustment as provided in subsection (7)(c) of this section.

41 “(h) A standby generation facility, if the facility complies with all of the following:

42 “(A) The facility has received local land use approval under the applicable acknowledged com-
43 prehensive plan and land use regulations of the affected local government and the facility complies
44 with all statewide planning goals and applicable rules of the Land Conservation and Development
45 Commission;

1 “(B) The standby generators have been approved by the Department of Environmental Quality
2 as having complied with all applicable air and water quality requirements. For an applicant that
3 proposes to provide the physical facilities for the installation of standby generators, the requirement
4 of this subparagraph may be met by agreeing to require such a term in the lease contract for the
5 facility; and

6 “(C) The standby generators are electrically incapable of being interconnected to the trans-
7 mission grid. For an applicant that proposes to provide the physical facilities for the installation of
8 standby generators, the requirement of this subparagraph may be met by agreeing to require such
9 a term in the lease contract for the facility.

10 “(3) The Energy Facility Siting Council may review and, if necessary, revise the fuel chargeable
11 to power heat rate value set forth in subsection (2)(c)(B) of this section. In making its determination,
12 the council shall ensure that the fuel chargeable to power heat rate value for facilities set forth in
13 subsection (2)(c)(B) of this section remains significantly lower than the fuel chargeable to power
14 heat rate value for the best available, commercially viable thermal power plant technology at the
15 time of the revision.

16 “(4) Any person who proposes to construct or enlarge an energy facility and who claims an ex-
17 emption under subsection (2)(a), (c), (f) or (h) of this section from the requirement to obtain a site
18 certificate shall request the Energy Facility Siting Council to determine whether the proposed fa-
19 cility qualifies for the claimed exemption. The council shall make its determination within 60 days
20 after the request for exemption is filed. An appeal from the council’s determination on a request for
21 exemption shall be made under ORS 469.403, except that the scope of review by the Supreme Court
22 shall be the same as a review by a circuit court under ORS 183.484. The record on review by the
23 Supreme Court shall be the record established in the council proceeding on the exemption.

24 “(5) Notwithstanding subsection (1) of this section, a separate site certificate shall not be re-
25 quired for:

37 section, the electric generating facility shall cease to operate one year after the substantial loss of
38 the steam host unless an application for a site certificate has been filed in accordance with the
39 provisions of ORS 469.300 to 469.563.

40 “(7)(a) Any person who proposes to construct or enlarge a temporary energy generating facility
41 and who claims an exemption under subsection (2)(g) of this section from the requirement to obtain
42 a site certificate shall request the Energy Facility Siting Council to determine whether the proposed
43 facility qualifies for the claimed exemption. The council shall make its determination within 30 days
44 of receiving all of the information necessary to support the determination. Such exemption shall
45 provide that the applicant may not begin construction of the temporary energy generating facility

1 until the facility has received the required local land use approval under the applicable acknowl-
2 edged comprehensive plan and land use regulations of the affected local government and the facility
3 complies with all statewide planning goals and applicable rules of the Land Conservation and De-
4 velopment Commission. The exemption shall also require that the temporary energy generating fa-
5 cility cease operation no later than 24 months after the date of first commercial operation or
6 January 2, 2006, whichever is earlier. An appeal from the council's determination on a request for
7 exemption shall be made under ORS 469.403, except that the order may not be stayed and review
8 by the Supreme Court is limited to the record made by the council.

9 “(b) The council may not grant an exemption for a temporary energy generating facility pursu-
10 ant to subsection (2)(g) of this section after July 1, 2003.

11 “(c) Within 30 days of ceasing operation of a temporary energy generating facility, the applicant
12 shall report the total actual fuel used during commercial operation of the temporary energy gener-
13 ating facility. Based on the total actual fuel used during commercial operation, the council shall
14 determine whether additional offset funds, as defined in ORS 469.503, and contracting and selection
15 funds are owed to the qualified organization. If the council determines that additional offset funds
16 are owed to the qualified organization, the applicant shall pay such amounts within 60 days of the
17 council's order determining the amount of additional funds.

18 “(d) Notwithstanding the provisions of paragraph (a) of this subsection that require a temporary
19 energy generating facility granted an exemption pursuant to subsection (2)(g) of this section to cease
20 operation within 24 months of first commercial operation, if the owner of a temporary energy gen-

22 stituting the exemption or January 1, 2005, whichever date is earlier, the council shall extend the
23 period constituting the exemption and shall allow the temporary energy generating facility to con-

26 by the date specified by the council, or is rejected by the council, the energy facility shall cease

41 “[c] (d) ‘Total energy output’ means the sum of useful thermal energy output and useful elec-
42 trical energy output.

43 “[d] (e) ‘Useful thermal energy’ means the verifiable thermal energy used in any viable indus-
44 trial or commercial process, heating or cooling application.

45 “(9) Notwithstanding the definition of ‘energy facility’ in ORS 469.300 (11)(a)(J), an electric

1 power generating plant with an average electric generating capacity of less than 35 megawatts
2 produced from wind energy at a single energy facility or within a single energy generation area may
3 elect to obtain a site certificate in the manner provided in ORS 469.300 to 469.563, 469.590 to
4 469.619, 469.930 and 469.992. An election to obtain a site certificate under this subsection shall be
5 final upon submission of an application for a site certificate.

6 **“SECTION 34.** ORS 469.320, as amended by section 8, chapter 683, Oregon Laws 2001, and
7 section 77, chapter 186, Oregon Laws 2003, is amended to read:

8 “469.320. (1) Except as provided in subsections (2) and (5) of this section, no facility shall be
9 constructed or expanded unless a site certificate has been issued for the site thereof in the manner
10 provided in ORS 469.300 to 469.563, 469.590 to 469.619, 469.930 and 469.992. No facility shall be
11 constructed or operated except in conformity with the requirements of ORS 469.300 to 469.563,
12 469.590 to 469.619, 469.930 and 469.992.

13 “(2) [No] A site certificate [shall be] **is not** required for:

14 “(a) An energy facility for which no site certificate has been issued that, on August 2, 1993, had
15 operable electric generating equipment for a modification that uses the same fuel type and increases
16 electric generating capacity, if:

17 “(A) The site is not enlarged; and

18 “(B) The ability of the energy facility to use fuel for electricity production under peak steady
19 state operating conditions is not more than 200 million Btu per hour greater than it was on August
20 2, 1993, or the energy facility expansion is called for in the short-term plan of action of an energy
21 resource plan that has been acknowledged by the Public Utility Commission of Oregon.

22 “(b) Construction or expansion of any interstate natural gas pipeline or associated underground
23 natural gas storage facility authorized by and subject to the continuing regulation of the Federal
24 Energy Regulatory Commission or successor agency.

25 “(c) An energy facility, except coal and nuclear power plants, if the energy facility:

26 “(A) Sequentially produces electrical energy and useful thermal energy from the same fuel
27 source; and

28 “(B) Under normal operating conditions, has a useful thermal energy output of no less than 33
29 percent of the total energy output or the fuel chargeable to power heat rate value is not greater
30 than 6,000 Btu per kilowatt hour.

31 “(d) Temporary storage, at the site of a nuclear-fueled thermal power plant for which a site
32 certificate has been issued by the State of Oregon, of radioactive waste from the plant.

33 “(e) An energy facility as defined in ORS 469.300 (11)(a)(G), if the plant also produces a sec-
34 ondary fuel used on site for the production of heat or electricity, if the output of the primary fuel
35 is less than six billion Btu of heat a day.

40 **the creation of substitutes for petroleum-based products;**

41 “(B) Has received local land use approval under the applicable acknowledged comprehensive
42 plan and land use regulations of the affected local government and the facility complies with any
43 statewide planning goals or rules of the Land Conservation and Development Commission that are
44 directly applicable to the facility;

45 “(C) Requires no new electric transmission lines or gas or petroleum product pipelines that

1 would require a site certificate under subsection (1) of this section; and

2 “(D) Produces synthetic fuel, at least 90 percent of which is used in an industrial or refueling
3 facility located within one mile of the facility or is transported from the facility by rail or barge.

4 “(g) A standby generation facility, if the facility complies with all of the following:

5 “(A) The facility has received local land use approval under the applicable acknowledged com-
6 prehensive plan and land use regulations of the affected local government and the facility complies
7 with all statewide planning goals and applicable rules of the Land Conservation and Development
8 Commission;

9 “(B) The standby generators have been approved by the Department of Environmental Quality
10 as having complied with all applicable air and water quality requirements. For an applicant that
11 proposes to provide the physical facilities for the installation of standby generators, the requirement
12 of this subparagraph may be met by agreeing to require such a term in the lease contract for the
13 facility; and

14 “(C) The standby generators are electrically incapable of being interconnected to the trans-
15 mission grid. For an applicant that proposes to provide the physical facilities for the installation of
16 standby generators, the requirement of this subparagraph may be met by agreeing to require such
17 a term in the lease contract for the facility.

18 “(3) The Energy Facility Siting Council may review and, if necessary, revise the fuel chargeable
19 to power heat rate value set forth in subsection (2)(c)(B) of this section. In making its determination,
20 the council shall ensure that the fuel chargeable to power heat rate value for facilities set forth in

2 supplies, parts and equipment for the operation, maintenance or repair of such motor vehicles.

3 “(4) ‘Official state business’ means activity conducted by a state agency that advances the lawful
4 policies of the agency as specified by the Oregon Department of Administrative Services by rule.

5 “(5) ‘Standard passenger vehicle’ means a motor vehicle that is commonly known as a sedan or
6 a station wagon and that is not equipped with special or unusual equipment.

16 statement by the applicant indicating the amount of fuel for which a refund is claimed, and the way
17 in which the fuel was used which qualifies the applicant for a refund. If the fuel upon which the

1 **“SECTION 55.** Section 56 of this 2005 Act is added to and made a part of ORS 279C.005
2 to 279C.670.

3 **“SECTION 56.** (1) If a public contract for the construction of a public building, or for the
4 reconstruction or major renovation of a public building if the cost of the reconstruction or
5 major renovation exceeds 50 percent of the value of the public building, uses funds from the
6 State Department of Energy, the contract is considered to contain an amount equal to at
7 least one percent of the total contract price for the inclusion of cost-effective solar energy
8 design and technology in the public building. Solar energy design and technology may include
9 daylighting, passive or active strategies.

10 **“(2)(a)** If a public contract described in subsection (1) of this section does not use funds
11 from the State Department of Energy, the contract is considered to contain an amount equal
12 to at least one percent of the total contract price for the inclusion of cost-effective solar
13 energy design and technology in the public building unless the contracting agency determines
14 that it would be inappropriate to include solar energy design and technology in the con-
15 struction, reconstruction or major renovation of the public building.

16 **“(b)** If the contracting agency determines, under paragraph (a) of this subsection, that
17 it would be inappropriate to include solar energy design and technology in the construction,
18 reconstruction or major renovation of the public building, the contracting agency shall
19 promptly submit a written report to the department explaining the reasons for the determi-
20 nation.

21 **“SECTION 57.** Section 56 of this 2005 Act applies only to public contracts first advertised,
22 but if not advertised then entered into, on or after the effective date of this 2005 Act.

24 **“COMMUNITY RENEWABLE ENERGY PROJECTS**

25
26 **“SECTION 58.** (1) For the biennium beginning July 1, 2005, pursuant to ORS 286.560 to
27 286.580, the State Treasurer, at the request of the State Department of Energy, may issue
28 lottery bonds to provide financial and other assistance for which the Community Renewable
29 Energy Project Fund established in section 60 of this 2005 Act may be used.

30 **“(2)** The use of lottery bond proceeds is authorized based on the following findings:

31 **“(a)** Financial and other assistance to local governments will enable the governments to
32 conduct feasibility studies of community renewable energy projects and small scale local
33 energy projects.

34 **“(b)** Community renewable energy projects and small scale local energy projects that
35 contain renewable energy elements promote job growth, family wage jobs and sustainability.

36 **“(c)** Without the ability to conduct feasibility studies, many small scale local and com-
37 munity renewable energy projects will not be developed.

38 **“(d)** Financial and other assistance to local governments will therefore further economic
39 development by allowing feasibility studies to be completed and spurring job growth in
40 Oregon through the creation of small scale local and community renewable energy projects.

41 **“(3)** The aggregate principal amount of lottery bonds issued pursuant to this section may
42 not exceed \$1 million, plus an additional amount established by the State Treasurer to be
43 necessary to pay bond-related costs.

44 **“(4)** The net proceeds of lottery bonds issued pursuant to this section must be deposited
45 in the Community Renewable Energy Project Fund established in section 60 of this 2005 Act.

2 “(2) An agency of state government, as defined in ORS 174.111, that generates electricity
3 may sell the electricity. However, the electricity may not be sold directly to a retail cus-
4 tomer of a publicly owned or investor-owned utility.

5 “(3) Revenues from the sale of electricity by an agency of state government, as defined
6 in ORS 174.111, shall be deposited in the State Treasury and are continuously appropriated
7 to the agency that sells the electricity.

8 “(4) As used in this section, ‘state buildings or grounds’ means the works, buildings,
9 lands and grounds that are:

10 “(a) Owned or leased by the state;

11 “(b) Situated in this state;

12 “(c) Governed, managed or administered by the state; and

13 “(d) Used by the state.

14 “**SECTION 63.** ORS 276.212 is amended to read:

15 “276.212. (1) The Oregon Department of Administrative Services may, as it deems necessary,
16 suitable or expedient, acquire, design, erect, complete, maintain and operate:

17 “(a) Steam heating systems, power systems, machines, engines and equipment, with necessary
18 transmission poles and lines, pipes or conduits for the purpose of generating and furnishing steam
19 heat, electric energy, current, light, heat and power for the public buildings and grounds.

20 “(b) Systems for the purpose of transmitting and receiving messages by radio, telephone, tele-
21 graph or other device or system in the transaction of business of the state or in which the state is
22 interested.

23 “(2) The department may do all things necessary for:

24 “(a) The delivery of steam heat, electrical current, energy, light, heat and power to the public
25 buildings and grounds.

26 “(b) The transmitting and receiving of messages by radio, telephone, telegraph or other device
27 or system in the transaction of business of the state or in which the state is interested.

28 “(3) The department may, provided the department has received specific approval to ex-
29 pend moneys for that purpose and has received land use or other state and local government
30 siting approval:

31 “(a) Construct and operate facilities at or on state buildings or grounds for the gener-
32 ation of electricity using renewable energy resources or cogeneration facilities.

33 “(b) Sell electricity generated at or on state buildings or grounds. However, the electric-
34 ity may not be sold directly to a retail customer of a publicly owned or investor-owned util-
35 ity.

36 “(4) Revenues from the sale of electricity by the department shall be deposited in the
37 State Treasury and are continuously appropriated to the department.

38 “(5) As used in this section, ‘state buildings or grounds’ means the works, buildings,
39 lands and grounds that are:

40 “(a) Owned or leased by the state;

41 “(b) Situated in this state;

42 “(c) Governed, managed or administered by the state; and

43 “(d) Used by the state.

4 **“SECTION 68.** Section 9, chapter 918, Oregon Laws 2001, is amended to read:

5 **“Sec. 9.** (1) The Sustainability Board Fund is established in the State Treasury, separate and
6 distinct from the General Fund. Interest earned by the Sustainability Board Fund shall be credited
7 to the fund.

8 **“(2)** All moneys received by the Sustainability Board under section 3, **chapter 918, Oregon**
9 **Laws 2001,** *[of this 2001 Act]* shall be paid into the State Treasury *[and deposited into the General*
10 *Fund to the credit of]* **and credited to** the Sustainability Board Fund. Such moneys are continuously
11 appropriated to the Sustainability Board for the purposes of administering **ORS 184.421 and 184.423**
12 **and sections 2, 3 and 5 to 9, chapter 918, Oregon Laws 2001** *[sections 1 to 9 of this 2001 Act].*

13 **“SECTION 69.** Section 15, chapter 918, Oregon Laws 2001, is amended to read:

14 **“Sec. 15.** (1) Sections 2, 3 and 5 to 10, **chapter 918, Oregon Laws 2001,** *[of this 2001 Act]* are
15 repealed January 2, *[2006]* **2012.**

16 **“(2) Any balance in the Sustainability Board Fund that is unexpended and unobligated on**
17 **January 2, 2012, and all moneys that would have been credited to the Sustainability Board**
18 **Fund had the fund continued to exist but for the repeal effected by this section, shall be**
19 **transferred to and deposited in the General Fund and shall be available for general govern-**
20 **mental expenses.**

21 **“SECTION 70.** Section 17, chapter 918, Oregon Laws 2001, is amended to read:

22 **“Sec. 17. The amendments to ORS 184.421 by section 16, chapter 918, Oregon Laws 2001,**
23 **become** *[of this 2001 Act becomes]* operative January 2, *[2006]* **2012.**
