

Senate Bill 23

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of State Treasurer Randall Edwards for Oregon Municipal Debt Advisory Commission)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Makes numerous technical changes to procedures for issuing, selling and maintaining bonds issued by public issuers.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 223.235 is amended to read:

8 223.235. (1) When in any local government a bond lien docket is made up, as provided in ORS
9 223.230, as to the final assessments for any local improvement, the local government shall by ordi-
10 nance or resolution of the governing body authorize the issue of its bonds pursuant to the applicable
11 provisions of ORS chapter 288 and in accordance with this section.

12 (2) The bonds authorized to be issued under this section [*shall*] **must** be issued in an amount
13 that does not exceed the unpaid balance of all final assessments for the related local improvements,
14 plus the amounts necessary to fund any debt service reserve and to pay any other financing costs
15 associated with the bonds.

16 (3)(a) If the question of the issuance of the specific bonds has been approved by the electors of
17 the local government and the bonds are issued as general obligation bonds, the local government
18 shall each year assess, levy and collect a tax on all taxable property within its boundaries. The
19 amount of the tax [*shall*] **must** be sufficient to pay all principal of and interest on the bonds that
20 are due and payable in that year and to replenish any debt service reserves required for the bonds.
21 In computing the amount of taxes to impose, the local government shall:

22 (A) Deduct from the total amount otherwise required the amount of final installment payments
23 [*which*] **that** are pledged to the payment of the bonds and [*which*] **that** are due and payable in that
24 year[, and *shall*]; **and**

25 (B) Add to this net amount the amount of reasonably anticipated delinquencies in the payments
26 of the installments or the taxes.

27 (b) The taxes [*shall*] **must** be levied in each year and returned to the county officer whose duty
28 it is to extend the tax roll within the time and in the manner provided in ORS 310.060.

29 (c) The taxes [*shall*] become payable at the same time and [*be*] **are** collected by the same officer
30 who collects county taxes and [*shall*] **must** be turned over to the local government according to law.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.
New sections are in **boldfaced** type.

1 (d) The county officer whose duty it is to extend the county levy shall extend the levy of the
 2 local government in the same manner as city taxes are extended. Property *[shall be subject to sale]*
 3 **may be sold** for nonpayment of the taxes levied by a local government in like manner and with like
 4 effect as in the case of county and state taxes.

5 (4) If the question of the issuance of the specific bonds has not been approved by the electors
 6 of the local government *[and the bonds are issued]*, **the local government may issue the bonds**
 7 as limited tax *[obligation]* bonds, **as defined in ORS 288.150** *[the local government may, subject only*
 8 *to the limitations of section 11b (1), Article XI of the Oregon Constitution, calculate, assess, levy and*
 9 *collect a tax on all taxable property within its boundaries in the manner provided in subsection (3) of*
 10 *this section. The amount of such tax shall be sufficient to pay all principal of and interest on such*
 11 *bonds which is due and payable in that year and to replenish any debt service reserves required for*
 12 *such bonds, provided that if such bonds are issued as limited tax obligation bonds the amount of such*
 13 *tax shall not exceed the amount permitted under section 11b (1), Article XI of the Oregon*
 14 *Constitution]*.

15 (5)(a) All bonds issued pursuant to this section, including general obligation bonds, *[shall be]*
 16 **are** secured by and *[be]* payable from the installments of final assessments with respect to which the
 17 bonds were issued.

18 (b) In the ordinance or resolution authorizing the issuance of the bonds, the governing body of
 19 the issuing local government may:

20 (A) Provide that installments of final assessments levied with respect to two or more local im-
 21 provements shall secure a single issue of bonds.

22 (B) Reserve the right to pledge, as security for any bonds thereafter issued pursuant to this
 23 section, any installments of final assessments previously pledged as security for other bonds issued
 24 pursuant to this section.

25 (c) All bonds *[shall]* **must** be secured by a lien on the installments of final assessments with
 26 respect to which they were issued. The lien *[shall be]* **is** valid, binding and fully perfected from the
 27 date of issuance of the bonds. The installments of final assessments *[shall be]* **are** immediately sub-
 28 ject to the lien without the physical delivery thereof, the filing of any notice or any further act. The
 29 lien *[shall be]* **is** valid, binding and fully perfected against all persons having claims of any kind
 30 against the local government or the property assessed whether in tort, contract or otherwise, and
 31 irrespective of whether *[such]* **the** persons have notice of the lien.

32 (6) As additional security for any bonds issued under this section, including general obligation
 33 bonds, the governing body of the issuing local government may pledge or mortgage, or grant security
 34 interests in, its revenues, assets and properties, and otherwise secure and enter into covenant with
 35 respect to the bonds, as provided in ORS 288.155.

36 (7)(a) A local government *[shall have the power, at any time and]* **may**, from time to time after
 37 the undertaking of a local improvement has been authorized, *[to]* borrow money and issue and sell
 38 notes for the purpose of providing interim financing for the actual costs of the local improvement.

39 (b) Notes authorized under this subsection may be issued in a single series for the purpose of
 40 providing interim financing for two or more local improvements.

41 (c) Notes authorized under this subsection *[shall mature not]* **may not mature** later than one
 42 year after the date upon which the issuing local government expects to issue bonds for the purpose
 43 of providing permanent financing with respect to installment payments of the final assessments for
 44 the local improvements.

45 (d) Any notes authorized under this subsection may be refunded from time to time by the issu-

1 ance of additional notes or out of the proceeds of bonds issued pursuant to this section. The notes
 2 may be made payable from the proceeds of any bonds to be issued under this section to provide
 3 permanent financing or from any other sources from which the bonds are payable.

4 (e) The governing body of the issuing local government may pledge to the payment of the notes
 5 any revenues that may be pledged to the payment of bonds authorized to be issued under this section
 6 with respect to the local improvements for which the notes provide interim financing.

7 **SECTION 2.** ORS 238.694 is amended to read:

8 238.694. (1) The Legislative Assembly finds that authorizing issuance of limited tax bonds or
 9 revenue bonds to finance pension liabilities may reduce the cost of public pensions to taxpayers and
 10 that the reduction of those costs to taxpayers is a matter of statewide concern.

11 (2) Notwithstanding **the limitation on indebtedness in ORS 287.053 or any other** limitation
 12 on indebtedness or borrowing under state or local law, for the purpose of obtaining funds to pay the
 13 pension liability of a governmental unit, the governing body of a governmental unit may authorize
 14 and cause the issuance of limited tax bonds as defined in ORS 288.150, revenue bonds authorized
 15 by charter or pursuant to ORS 288.805 to 288.945, or any combination of those bonds.

16 (3) The governing body of a governmental unit may pledge the full faith and credit and taxing
 17 power of the governmental unit to the payment of the principal and interest on bonds issued under
 18 ORS 238.692 to 238.698, and any premium on those bonds.

19 [(3)] (4) **Except as otherwise provided in this section,** limited tax bonds authorized under this
 20 section must be issued in the manner prescribed by **the applicable provisions of** ORS chapters 287
 21 and 288 for the issuance of limited tax bonds.

22 (5) **Unless the charter of a county provides a lower limit,** a county may not issue limited
 23 tax bonds under this section [for] **in** an amount that exceeds five percent of the real market value
 24 of the taxable property within the boundaries of the county.

25 [(4)] (6) Revenue bonds authorized under this section need not comply with the procedure spec-
 26 ified in ORS 288.815.

27 [(5)] (7) A governmental unit that issues limited tax bonds or revenue bonds under this section
 28 may also issue limited tax bonds or revenue bonds for the purpose of refunding the bonds.

29 [(6)] (8) A governmental unit may enter into indentures or other agreements with trustees or
 30 escrow agents for the issuance, administration or payment of bonds authorized under this section.

31 **SECTION 3.** ORS 271.390 is amended to read:

32 271.390. (1) As used in this section:

33 (a) "Council of governments" means a council of governments or other similar entity created
 34 prior to the enactment of ORS 190.010 (5) on September 29, 1991.

35 (b) ["Municipality"] **"Governmental unit"** has the meaning given that term in ORS [288.515]
 36 **288.150.**

37 (c) "Real or personal property" means land, improvements to land, structures, fixtures, personal
 38 property, including furnishings, equipment and computer software purchases and licenses, and any
 39 costs that may be capitalized under generally accepted accounting principles and treated as costs
 40 of personal property.

41 (2) A [municipality] **governmental unit** or a council of governments may enter into contracts
 42 for the leasing, rental or financing of any real or personal property that the governing body **of the**
 43 **governmental unit or council of governments** determines is needed, including contracts for
 44 rental, long term leases under an optional contract for purchase, financing agreements with vendors,
 45 financial institutions or others, or for purchase of any property. [Leases or] Contracts made by a

1 [municipality] **governmental unit** or a council of governments [shall be made] **are** subject to the
 2 terms of its charter, intergovernmental agreement or other organizing document, if applicable. If
 3 authorized by the governing body, [such] **the** contracts may:

4 (a) Provide that the obligations of the [municipality] **governmental unit** or council of govern-
 5 ments under the contract [shall be] **is** secured by a mortgage on or other security interest in the
 6 property to be leased, rented, purchased or financed under the contract.

7 (b) Provide that the obligations of the [municipality] **governmental unit** or council of govern-
 8 ments under the contract [shall be] **are** payable out of all or any [designated] portion of the lawfully
 9 available [revenues of the municipality] **funds, as defined in ORS 288.162, of the governmental**
 10 **unit** or council of governments, [which revenues] **and lawfully available funds** may be pledged to
 11 the payment of those obligations.

12 (c) If authorized by the charter, intergovernmental agreement or other organizing document of
 13 the [municipality] **governmental unit** or council of governments, contain a covenant on the part of
 14 the [municipality] **governmental unit** or council of governments to budget and appropriate in each
 15 fiscal year, in accordance with law, sums sufficient to pay when due the amounts owing under the
 16 contract.

17 (d) Provide for the issuance of certificates of participation in the payment obligations of the
 18 [municipality] **governmental unit** or council of governments under the contract and contain [such]
 19 other covenants, agreements and provisions [as are] determined to be necessary or appropriate in
 20 order to better secure the obligations of the [municipality] **governmental unit** or council of gov-
 21 ernments.

22 (3) The lien of the pledge, mortgage or security interest is valid and binding from the time of
 23 entering into the contract. The revenue or property is immediately subject to the lien without
 24 physical delivery, filing or other act, and the lien is superior to all other claims and liens of any
 25 kind whatsoever. Subject to the terms, provisions and limitations of the contract, the lien may be
 26 foreclosed by a proceeding brought in the circuit court of the county in which the [municipality]
 27 **governmental unit**, or the greater part thereof, or the main office of the council of governments
 28 is located, and any tangible real or personal property subject to the lien may be sold upon the order
 29 of the court. The proceeds of the sale [shall first] **must** be applied **first** to the payment of the costs
 30 of foreclosure and then to the amounts owing under the contract, with any balance being paid to
 31 the [municipality] **governmental unit** or council of governments. The authority granted by this
 32 section is in addition to, and not in lieu of, any other statutory or charter authority.

33 (4) A [municipality] **governmental unit** or council of governments that has entered into a lease
 34 purchase or installment purchase agreement may enter into a financing agreement to refinance the
 35 obligations of the [municipality] **governmental unit** or council of governments under the lease
 36 purchase or installment purchase agreement.

37 (5) The estimated weighted average life of a financing contract executed under this section may
 38 not exceed the estimated dollar weighted average life of the real or personal property that is fi-
 39 nanced with the contract.

40 **SECTION 4.** ORS 287.018 is amended to read:

41 287.018. [For general obligation issues:]

42 (1) For **general obligation** bonds [which are sold at public competitive bid] **offered for public**
 43 **sale**, the issuer shall prepare and make available [upon request to bidders and investors], **for use in**
 44 **connection with the initial offering and sale**, a preliminary official statement that **discloses the**
 45 **material information that the issuer determines is relevant to a potential investor in the**

1 **bonds.** *[includes the following:]*

2 *[(a) Past and current financing and estimated future financing of the issuer;]*

3 *[(b) A brief description of the financial administration and organization of the issuer;]*

4 *[(c) A brief description of the economic and social characteristics of the issuer which will permit*
5 *bidders and investors to appraise the issuer's ability to assume and service adequately the debt obli-*
6 *gation; and]*

7 *[(d) Any other information the issuer may provide or which the Oregon Municipal Debt Advisory*
8 *Commission may require by rule of any issuer other than the state.]*

9 *[(2) The preliminary official statement described in subsection (1) of this section shall be available*
10 *not fewer than 10 calendar days preceding the date of the bond sale.]*

11 *[(3) The preliminary official statement shall contain the best available information which shall be*
12 *accurate to the best knowledge of the issuer. However, any errors or omissions in the preliminary of-*
13 *ficial statement shall not affect the validity of the bond issue.]*

14 *[(4)]* **(2)** The **preliminary official** statement required by this section of state agencies *[shall]*
15 **must** be submitted to the State Treasurer for approval. If not approved, the State Treasurer shall
16 note the revision required. The issuer shall make the noted revisions.

17 **SECTION 5.** ORS 287.025 is amended to read:

18 287.025. (1) As used in this section:

19 (a) "Agreement for exchange of interest rates" or "agreement" means a contract, or an option
20 or forward commitment to enter into a contract, for the exchange of interest rates that provides for:

21 (A) Payments based on levels of or changes in interest rates; or

22 (B) Provisions to hedge payment, rate, spread or similar exposure including, but not limited to,
23 an interest rate floor or cap or an option, put or call.

24 (b) "Issuer" means a public body as defined in ORS 288.605~~, the~~ **or** Oregon Health and Science
25 University *[or the Master Settlement Asset Corporation established in section 3, chapter 2, Oregon*
26 *Laws 2002 (fifth special session)].*

27 (c) "Obligation" means a bond, note, bond anticipation note, commercial paper, certificate of
28 participation or other agreement made in exercise of the borrowing powers of the issuer.

29 **(d) "Related obligation" means the underlying obligation for which the issuer, or the**
30 **State Treasurer on behalf of a state issuer, enters into an agreement under this section.**

31 **(e) "Termination payment" means the amount payable under an agreement for exchange**
32 **of interest rates by one party to another party as a result of termination of the agreement**
33 **prior to the expiration of the stated term.**

34 (2) If the issuer is a state issuer, including the State of Oregon or an agency, department, board
35 or commission of the State of Oregon, the State Treasurer may exercise the authority granted by
36 this section on behalf of the state issuer or the state issuer, with the approval of the State Treas-
37 urer, may exercise that authority directly.

38 (3) Subject to subsection (2) of this section, an issuer, or the State Treasurer on behalf of a state
39 issuer, may enter into an agreement for exchange of interest rates *[related to an obligation]* **for one**
40 **or more related obligations** the issuer has issued or will issue **or for different obligations des-**
41 **ignated during the term of the agreement by the issuer as a result of prepayment, refunding,**
42 **conversion, ratings changes, redemption, defeasance or other similar event related to a**
43 **particular obligation. An agreement may be made** to manage payment, interest rate, spread or
44 similar exposure undertaken in connection with the **related or designated different** obligation
45 upon a finding by the issuer, or the State Treasurer on behalf of a state issuer, that the agreement

1 benefits the issuer.

2 (4) The issuer, or the State Treasurer on behalf of a state issuer, shall include in an agreement
3 for exchange of interest rates provisions related to payment, term, security, collateralization, ter-
4 mination, default and remedy that the issuer, or the State Treasurer on behalf of a state issuer,
5 determines necessary or appropriate upon consideration of the covenants applicable to the **related**
6 obligation and the creditworthiness of the parties.

7 (5) The issuer, or the State Treasurer on behalf of a state issuer, may enter into an agreement
8 for exchange of interest rates only if:

9 (a) The long-term, senior, unsecured, unenhanced, unsubordinated debt obligations of the party,
10 or the guarantors of the party, with whom the issuer, or the State Treasurer on behalf of a state
11 issuer, enters the agreement are rated in one of the top three rating categories without gradation
12 by at least two nationally recognized rating agencies **as determined by the Oregon Municipal**
13 **Debt Advisory Commission or the State Treasurer, as applicable, under and subject to sub-**
14 **section (13) of this section;** or

15 (b) The **termination payment** obligations of the party, or the guarantors of the party, with
16 whom the issuer, or the State Treasurer on behalf of a state issuer, enters the agreement are
17 collateralized by cash or obligations:

18 (A) **That are** rated in one of the top three rating categories without gradation by at least two
19 nationally recognized rating agencies [*and:*] **as determined by the Oregon Municipal Debt Advi-**
20 **sory Commission or the State Treasurer, as applicable, under and subject to subsection (13)**
21 **of this section;**

22 [(A)] (B) [*The cash or obligations*] **That** are deposited with the issuer, or the State Treasurer
23 on behalf of a state issuer, or with an agent of the issuer;

24 [(B)] (C) [*The cash or obligations*] **That** have a market value sufficient to fully collateralize the
25 **termination payment** obligations of the party under the agreement as determined at the discretion
26 of the issuer, or the State Treasurer on behalf of a state issuer; and

27 [(C)] (D) [*The collateral obligations are valued*] **That are revalued** at least quarterly.

28 (6) With respect to an obligation that [*the issuer, or the State Treasurer on behalf of a state*
29 *issuer,*] has **been** issued or will [*issue*] **be issued**, the issuer, or the State Treasurer on behalf of a
30 state issuer, may, **based on the issuer's reasonable expectations at the time the agreement is**
31 **executed**, agree:

32 (a) If the obligation bears interest at one or more variable rates, to pay sums equal to interest
33 at one or more fixed rates or one or more different variable rates determined under a formula set
34 forth in the agreement for exchange of interest rates on an amount not to exceed the outstanding
35 principal amount of the obligation **when the agreement is entered into or, if the obligation has**
36 **not been issued, the principal amount of the obligation reasonably anticipated to be out-**
37 **standing when payments are required to commence under the agreement** in exchange for an
38 agreement for the issuer, or the State Treasurer on behalf of a state issuer, to be paid sums equal
39 to interest on the same principal amount at a variable rate determined under a formula set forth in
40 the agreement.

41 (b) If the obligation bears interest at one or more fixed rates, to pay sums equal to interest at
42 one or more variable rates or one or more different fixed rates determined under a formula set forth
43 in the agreement for exchange of interest rates on an amount not to exceed the outstanding prin-
44 cipal amount of the obligation **when the agreement is entered into or, if the obligation has not**
45 **been issued, the principal amount of the obligation reasonably anticipated to be outstanding**

1 **when payments are required to commence under the agreement** in exchange for an agreement
 2 for the issuer, or the State Treasurer on behalf of a state issuer, to be paid sums equal to interest
 3 on the same principal amount at a fixed rate or rates set forth in the agreement.

4 (7) The issuer, or the State Treasurer on behalf of a state issuer, may not enter into an agree-
 5 ment under this section that:

6 (a) Has a term that exceeds the original term of the **related** obligation for which the agreement
 7 for exchange of interest rates is made or, in the case of an option or a forward commitment, has a
 8 term that exceeds the reasonably expected term of the **related** obligation for which the agreement
 9 is made; or

10 (b) Is for a purpose other than to manage payment, interest rate, spread or similar exposure in
 11 connection with the **related** obligation of the issuer.

12 (8) The limitation on interest on an obligation in ORS 286.036, or any other similar limitation,
 13 does not apply to interest paid under an agreement for exchange of interest rates entered into under
 14 this section.

15 (9) Upon entering into an agreement for exchange of interest rates under this section and con-
 16 tinuing until the agreement is satisfied, terminated or otherwise no longer in effect, as long as no
 17 payment default has occurred, the issuer, or the State Treasurer on behalf of a state issuer, shall
 18 treat the amount or rate of interest on the **related** obligation [*related to*] **for which** the agreement
 19 **is made** as the amount or rate of interest payable after giving effect to the agreement for the pur-
 20 pose of calculating:

21 (a) Tax levies, if any, to pay bond debt service; or

22 (b) Other amounts that are based upon the rate of interest of the obligation.

23 (10) Subject to covenants applicable to [*the*] **a related obligation and the limitation described**
 24 **in subsection (12) of this section**, payments required [*to be made*] under the agreement by the
 25 issuer, or the State Treasurer on behalf of a state issuer, **may**:

26 (a) **Be treated as interest payments on the related obligation;**

27 [(a)] (b) [*May*] Be made from revenues or other moneys committed to or legally available to pay
 28 the [*underlying debt*] **related** obligation; and

29 [(b)] (c) [*May*] Rank in an order of priority of payment relative to the payment of the [*underlying*
 30 *debt*] **related** obligation as the issuer, or the State Treasurer on behalf of a state issuer, determines.
 31 In connection with entering into an agreement, the issuer, or the State Treasurer on behalf of a
 32 state issuer, may enter into an agreement that enhances or supports the credit of the issuer in the
 33 agreement or enhances or supports the liquidity of the agreement.

34 (11) An agreement entered into under this section:

35 (a) Is not a debt or other obligation of the [*state*] issuer for purposes of any limitation upon the
 36 indebtedness of the [*state*] issuer.

37 (b) **Is subject only to the limitations of this section and is not subject to other limitations**
 38 **applicable to the related obligation.**

39 (12) **A termination payment required to be paid by a public body that is not a state issuer**
 40 **under an agreement for exchange of interest rates may not be paid from taxes that the**
 41 **public body may levy that are exempt from the limitations of sections 11 and 11b, Article**
 42 **XI of the Oregon Constitution.**

43 [(12)(a)] (13)(a) The Oregon Municipal Debt Advisory Commission:

44 (A) Shall promulgate administrative rules establishing required terms, conditions, annual or pe-
 45 riodic reporting requirements and other requirements for an agreement for exchange of interest

1 rates entered into by an issuer other than a state issuer; **and**

2 **(B) May promulgate administrative rules:**

3 **(i) Requiring a party to an agreement, the party's guarantor or the collateral securing**
 4 **the obligation of a party or the party's guarantor to meet specific credit rating standards**
 5 **or other conditions; or**

6 **(ii) If the commission determines that restrictions are necessary or appropriate to pro-**
 7 **tect the interests of issuers, requiring the agreement to contain terms and conditions that**
 8 **are more restrictive than the terms and conditions established in subsection (5) of this sec-**
 9 **tion.**

10 (b) The State Treasurer may promulgate administrative rules:

11 **(A) Establishing required terms, conditions, annual or periodic reporting requirements and other**
 12 **requirements for an agreement for exchange of interest rates entered into by a state issuer acting**
 13 **with the approval of the State Treasurer under subsection (2) of this section;**

14 **(B) Requiring a party to an agreement, the party's guarantor or the collateral securing**
 15 **the obligation of a party or the party's guarantor to meet specific credit rating standards**
 16 **or other conditions; or**

17 **(C) If the State Treasurer determines that conditions and restrictions are necessary or**
 18 **appropriate to protect the interests of issuers, requiring the agreement to contain terms and**
 19 **conditions that are more restrictive than the terms and conditions established in subsection**
 20 **(5) of this section.**

21 ~~[(13)(a)]~~ **(14)(a)** Before an agreement for exchange of interest rates may be entered into under
 22 this section, the issuer, or the State Treasurer on behalf of a state issuer, shall determine whether:

23 **(A) The agreement for exchange of interest rates is being executed for a permitted purpose and**
 24 **benefits the issuer; and**

25 **(B) The requirements of this section have been met.**

26 (b) In addition to the determinations required under paragraph (a) of this subsection, an issuer
 27 other than a state issuer shall also determine whether the issuer has complied with the requirements
 28 of the administrative rules promulgated by the Oregon Municipal Debt Advisory Commission under
 29 subsection ~~[(12)]~~ **(13)** of this section.

30 ~~[(14)]~~ **(15)** An issuer other than a state issuer shall notify the State Treasurer of the execution
 31 by the issuer of an agreement for exchange of interest rates under this section.

 45 in banker's acceptances of any qualified financial institution.

1 [(9)(a)] **(i)(A)** Corporate indebtedness subject to a valid registration statement on file with the
 2 Securities and Exchange Commission or issued under the authority of section 3(a)(2) or 3(a)(3) of the
 3 Securities Act of 1933, as amended. Corporate indebtedness described in this *[subsection]* **paragraph**
 4 does not include banker’s acceptances. The corporate indebtedness must be issued by a commercial,
 5 industrial or utility business enterprise, or by or on behalf of a financial institution, including a
 6 holding company owning a majority interest in a qualified financial institution.

7 [(b)] **(B)** Corporate indebtedness must be rated on the settlement date P-1 or Aa or better by
 8 Moody’s Investors Service or A-1 or AA or better by Standard & Poor’s Corporation or equivalent
 9 rating by any nationally recognized statistical rating organization.

10 [(c)] **(C)** Notwithstanding *[paragraph (b) of this subsection]* **subparagraph (B) of this**
 11 **paragraph**, the corporate indebtedness must be rated on the settlement date P-2 or A or better by
 12 Moody’s Investors Service or A-2 or A or better by Standard & Poor’s Corporation or equivalent
 13 rating by any nationally recognized statistical rating organization when the corporate indebtedness
 14 is:

15 [(A)] **(i)** Issued by a business enterprise that has its headquarters in Oregon, employs more than
 16 50 percent of its permanent workforce in Oregon or has more than 50 percent of its tangible assets
 17 in Oregon; or

18 [(B)] **(ii)** Issued by a holding company owning not less than a majority interest in a qualified
 19 financial institution, as defined in *[subsection (8) of this section]* **paragraph (h) of this subsection**,
 20 located and licensed to do banking business in Oregon or by a holding company owning not less than
 21 a majority interest in a business enterprise described in *[subparagraph (A) of this paragraph]* **sub-**
 22 **subparagraph (i) of this subparagraph.**

23 [(d)] **(D)** A custodial officer *[shall]* **may** not permit more than 35 percent of the moneys of a
 24 local government that are available for investment, as determined on the settlement date, to be in-
 25 vested in corporate indebtedness, and *[shall]* **may** not permit more than five percent of the moneys
 26 of a local government that are available for investment to be invested in corporate indebtedness of
 27 any single corporate entity and its affiliates or subsidiaries.

28 [(10)] **(j)** Securities of any open-end or closed-end management investment company or invest-
 29 ment trust, if the securities are of the types specified in *[subsections (1) to (3), (8) and (9) of this*
 30 *section]* **paragraphs (a) to (c), (h) and (i) of this subsection** and if the investment does not cause
 31 the county, municipality, political subdivision or school district to become a stockholder in a joint
 32 company, corporation or association. A trust company or trust department of a national bank while
 33 acting as indenture trustee may invest funds held by it as indenture trustee in any open-end or
 34 closed-end management investment company or investment trust for which the trust company or
 35 trust department of a national bank or an affiliate of the trust company or trust department of a
 36 national bank acts as investment adviser or custodian or provides other services. However, the se-
 37 curities of the investment company or investment trust in which *[such]* **the** funds are invested must
 38 be of the types specified in *[subsections (1) to (3), (8) and (9) of this section]* **paragraphs (a) to (c),**
 39 **(h) and (i) of this subsection** and the investment must not cause the county, municipality, political
 40 subdivision or school district whose funds are invested to become a stockholder in a joint company,

44 [(11)] **(k)** Repurchase agreements whereby the custodial officer purchases securities from a fi-
 45 nancial institution or securities dealer subject to an agreement by the seller to repurchase the se-

1 curities. The repurchase agreement must be in writing and executed in advance of the initial
 2 purchase of the securities that are the subject of the repurchase agreement. Only securities de-
 3 scribed in [subsection (1) of this section shall] **paragraph (a) of this subsection may** be used in
 4 conjunction with a repurchase agreement and such securities shall have a maturity of not longer
