SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Abolishes Capitol Planning Commission. Transfers duties to Oregon Department of Administrative Services. Abolishes Capitol Planning Commission Account. Transfers moneys in account to department for deposit in Oregon Department of Administrative Services Operating Fund.

Acknowledges that special relationship exists between City of Salem and state government. Directs Oregon Department of Administrative Services to coordinate development plans and projects for capitol area with city governing bodies and to adopt rules establishing public review process for plans and projects.

Declares emergency, effective June 30, 2005.

(1) The Capitol Planning Commission is abolished. On the operative date of 9 this section, the tenure of office of the members of the commission ceases. 10 (2) The duties, functions and powers of the commission are imposed upon, transferred to and vested in the Oregon Department of Administrative Services as provided in sections 11 121 to 9 of this 2005 Act and the amendments to and the repeal of statutes by sections 10 to 13 26 and 30 of this 2005 Act.
