SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Short title [Uniform Trust Code Section 101]. Sections 1 to 95 of this 2005 15 Act may be cited as the Oregon Uniform Trust Code. 16 17SECTION 2. Scope [Uniform Trust Code Section 102]. (1) Except as provided in subsection (2) of this section, sections 1 to 95 of this 2005 Act apply to express trusts, whether chari-18 19 table or noncharitable, and to trusts created pursuant to a statute or a judgment that re-20 quires that the trust be administered in the manner of an express trust. 21(2) Sections 1 to 95 of this 2005 Act do not apply to: (a) A trust that is part of an employee benefit arrangement or an individual retirement 22 23account. 18	SECTION 3. Definitions [Uniform Trust Code Section 103]. For the purposes of sections
19	1 to 95 of this 2005 Act:
20	(1) "Ascertainable standard" means an ascertainable standard relating to an individual's
21	health, education, support or maintenance within the meaning of section 2041(b)(1)(A) or
22	2514(c)(1) of the Internal Revenue Code, as in effect on the effective date of this 2005 Act.
23	(2) "Beneficiary" means a person that:
24	(a) Has a present or future beneficial interest in a trust, whether vested or contingent;
25	or
26	(b) Holds a power of appointment over trust property in a capacity other than that of
27	trustee.
28	(3) "Charitable trust" means a trust, or portion of a trust, created for a charitable pur-
29	pose described in section 25 (1) of this 2005 Act.
30	(4) "Conservator" means a person appointed by a court to administer the estate of a
31	minor or adult individual.
32	(5) "Environmental law" means a federal, state or local law, rule, regulation or ordinance
33	relating to protection of the environment.
34	(6) "Financial institution" has the meaning given that term in ORS 706.008.
35	(7) "Financially incapable" has the meaning given that term in ORS 125.005. "Financially
36	capable" means not financially incapable.
37	(8) "Guardian" means a person appointed by a court to make decisions regarding the
38	support, care, education, health and welfare of a minor or adult individual. "Guardian" does
39	not include a guardian ad litem.
40	(9) "Interests of the beneficiaries" means the beneficial interests provided in the terms
41	of a trust.
42	(10) "Permissible distributee" means a beneficiary who is currently eligible to receive
43	distributions of trust income or principal, whether the distribution is mandatory or discre-
44	tionary.
45	(11) "Person" means an individual, corporation, business trust, estate, trust, partnership,

1 limited liability company, association, joint venture, public body as defined in ORS 174.109 or

2 any other legal or commercial entity.

3 (12) "Power of withdrawal" means a presently exercisable general power of appointment, 4 other than a power exercisable by a trustee that is limited by an ascertainable standard or 5 that is exercisable by another person only upon consent of the trustee or a person holding 6 an adverse interest.

7 (13) "Property" means anything that may be the subject of ownership, whether real or
8 personal, legal or equitable, or any interest therein.

(14) "Qualified beneficiary" means a beneficiary who:

(a) Is a permissible distributee on the date the beneficiary's qualification is determined;

(b) Would be a permissible distributee if the interests of all permissible distributees de scribed in paragraph (a) of this subsection terminated on the date the beneficiary's quali fication is determined; or

14 (c) Would be a permissible distributee if the trust terminated on the date the benefici-15 ary's qualification is determined.

16 (15) "Revocable trust" means a trust that can be revoked by the settlor without the 17 consent of the trustee or a person holding an adverse interest.

(16) "Settlor" means a person, including a testator, who creates a trust or contributes property to a trust. If more than one person creates or contributes property to a trust, each person is a settlor of the portion of the trust property attributable to that person's contribution and of the portion as to which that person has the power to revoke or withdraw.

(17) "Spendthrift provision" means a term of a trust that restrains both voluntary and
 involuntary transfer of a beneficiary's interest.

(18) "State" means a state of the United States, the District of Columbia, Puerto Rico,
the United States Virgin Islands or any territory or insular possession subject to the jurisdiction of the United States. "State" includes an Indian tribe or band recognized by federal
law or formally acknowledged by a state.

(19) "Terms of a trust" means the manifestation of the settlor's intent regarding a trust's provisions as expressed in the trust instrument or as may be established by other evidence that would be admissible in a judicial proceeding.

(20) "Trust instrument" means an instrument executed by a settlor that contains terms
 of the trust, including any amendments to the instrument.

(21) "Trustee" means an original trustee, an additional trustee, a successor trustee or a
 cotrustee.

35 <u>SECTION 4.</u> <u>Knowledge [Uniform Trust Code Section 104].</u> (1) Subject to subsection (2) 36 of this section, a person has knowledge of a fact if the person:

37 (a) Has actual knowledge of the fact;

38 (b) Has received a notice or notification of the fact; or

(c) From all the facts and circumstances known to the person at the time in question,
 has reason to know the fact.

(2) An organization that conducts activities through employees has notice or knowledge of a fact involving a trust only from the time the information was received by an employee having responsibility to act for the trust, or would have been brought to the employee's attention if the organization had exercised reasonable diligence. An organization exercises reasonable diligence if the organization maintains reasonable routines for communicating

significant information to the employee having responsibility to act for the trust and there 1 is reasonable compliance with the routines. Reasonable diligence does not require an em-2 ployee of the organization to communicate information unless the communication is part of 3 the employee's regular duties or the employee knows a matter involving the trust would be 4 materially affected by the information. 5 SECTION 5. Default and mandatory rules [Uniform Trust Code Section 105]. (1) Except 6 as otherwise provided in the terms of the trust, sections 1 to 95 of this 2005 Act govern the 7 duties and powers of a trustee, relations among trustees, and the rights and interests of a 8 9 beneficiary. 10 (2) The terms of a trust prevail over the provisions of sections 1 to 95 of this 2005 Act 11 except: 12(a) The requirements of sections 21 to 29 of this 2005 Act governing the creation of a 13 trust. (b) The duty of a trustee to act in good faith and in accordance with the purposes of the 14 15 trust. SECTION 7. Governing law [Uniform Trust Code Section 107]. The meaning and effect 10 of the terms of a trust are determined by: 11 12(1) The law of the state, country or other jurisdiction designated in the terms of the trust 13 unless the designation of the law of that state, country or other jurisdiction is contrary to a strong public policy of the state, country or other jurisdiction having the most significant 14 15 relationship to the matter at issue; or 16 (2) In the absence of a controlling designation in the terms of the trust, the law of the state, country or other jurisdiction having the most significant relationship to the matter 17 at issue. 18 SECTION 8. Principal place of administration [Uniform Trust Code Section 108]. (1) 19 Terms of a trust designating the principal place of administration are valid and controlling 20 if: 21 22(a) A trustee's principal place of business is located in the designated state, country or 23other jurisdiction, or the trustee is a resident of the designated state, country or other ju-24 risdiction; (b) All or part of the administration occurs in the designated state, country or other ju-25risdiction; or 2627(c) Other means exist for establishing a sufficient connection with the designated state, country or other jurisdiction. 28(2) A trustee is under a continuing duty to administer the trust at a place appropriate 2930 to the trust's purposes, the trust's administration and the interests of the beneficiaries. 31 Absent a substantial change of circumstances, the trustee may assume that the original place of administration is also the appropriate place of administration. The duty to adminis-32ter the trust at an appropriate place may prevent a trustee from moving the place of ad-33 34 ministration. 35 (3)(a) A trustee may transfer the trust's principal place of administration to another state, country or other jurisdiction if the transfer is in furtherance of the duty imposed by 36 37 subsection (2) of this section. 38 (b) A trustee shall notify qualified beneficiaries of the trust of a proposed transfer of the trust's principal place of administration not fewer than 60 days before initiating the transfer. 39 The notice of proposed transfer must include all of the following: 40 (A) The name of the state, country or other jurisdiction to which the principal place of 41 administration is to be transferred. 42 (B) The address and telephone number at the new location at which the trustee can be 43 contacted. 44 (C) An explanation of the reasons for the proposed transfer. 45

1 (D) The date on which the proposed transfer is anticipated to occur.

2 (E) The date by which the qualified beneficiary must notify the trustee of an objection 3 to the proposed transfer. The date for notifying a trustee of an objection may not be fewer 4 than 60 days after the date on which the notice is given.

5 (c) The authority of a trustee under this subsection to transfer a trust's principal place 6 of administration terminates if a qualified beneficiary notifies the trustee of an objection to 7 the proposed transfer on or before the date specified in the notice.

8 (d) The trustee may transfer some or all of the trust property to a successor trustee 9 designated in the terms of the trust or appointed pursuant to section 53 of this 2005 Act in 10 connection with a transfer of the trust's principal place of administration.

SECTION 9. Methods of giving notice; waiver of notice [Uniform Trust Code Section 109]. 11 12(1) If any provision of sections 1 to 95 of this 2005 Act requires that a trustee or other person 13 give notice or requires that the trustee or other person send a document, the trustee or other person must give the notice or send the document in a manner reasonably suitable 14 15 under the circumstances and likely to result in receipt of the notice or document. Permissible methods of giving notice and sending documents under sections 1 to 95 of this 2005 Act 16 include first class mail, personal delivery, delivery to a person's last known place of residence 17 18 or place of business, or properly directed electronic mail.

19 (2) If any provision of sections 1 to 95 of this 2005 Act requires that a trustee or other person give notice or requires that the trustee or other person send a document to another 20person, the trustee or other person need not give the notice or send the document to any 2122person whose identity or location is unknown and not reasonably ascertainable. If the trustee 23or other person cannot give notice or send a document, the trustee or other person shall prepare an affidavit setting forth the efforts made to find the person. The trustee must file 24 the affidavit in any pending court proceeding or hold the affidavit as part of the trust records 25if a court proceeding is not pending. 26

(3) Any person entitled to receive a notice or a document under sections 1 to 95 of this
2005 Act may waive receipt of the notice or document.

(4) Except as provided in subsection (5) of this section, notice of a judicial proceeding
shall be given in the manner required by statute for the approval of the final account in a
decedent's estate. Notice of a judicial proceeding must be given by the petitioner to the following persons:

(a) To the trustee and all persons whose interests are affected by the requested action
 or relief.

(b) If a person who is entitled to notice is a minor, to the minor's conservator or to another appropriate representative under sections 16 to 20 of this 2005 Act if the minor does not have a conservator. If the minor is 14 years of age or older, notice must also be given to the minor.

(c) If a person who is entitled to notice is financially incapable, to the person and the
person's conservator or to another appropriate representative under sections 16 to 20 of this
2005 Act if the person does not have a conservator.

42 (d) To any other person the court requires.

(5) A judicial proceeding to contest the validity of a trust must be commenced by the
 service of a summons in the manner required by ORCP 7. Notice of any other judicial pro ceeding must be given in the manner prescribed by subsection (4) of this section.

SECTION 10. Other persons treated as qualified beneficiaries [Uniform Trust Code Sec-

18 (2) Except as otherwise provided in subsection (3) of this section, interested persons may enter into a binding nonjudicial settlement agreement with respect to any matter involving 19 a trust. 20

(3) A nonjudicial settlement agreement is valid only to the extent the agreement does 21 22not violate a material purpose of the trust and includes terms and conditions that could be 23properly approved by the court under sections 1 to 95 of this 2005 Act or other applicable law.

(4) Matters that may be resolved by a nonjudicial settlement agreement include: 24

(a) The interpretation or construction of the terms of the trust or other writings that 25affect the trust. 26

(b) The approval of a trustee's report or accounting.

(c) Direction to a trustee to refrain from performing a particular act or the grant to a 28trustee of any necessary or desirable power. 29

30 (d) The resignation or appointment of a trustee and the determination of a trustee's 31 compensation.

(e) Transfer of a trust's principal place of administration. 32

(f) Liability of a trustee for an action or failure to act relating to the trust. 33

34 (g) Determining classes of creditors, beneficiaries, heirs, next of kin or other persons.

35(h) Resolving disputes arising out of the administration or distribution of the trust.

(5) Any interested person may petition the court to approve a nonjudicial settlement 36 37 agreement, to determine whether the representation as provided in sections 16 to 20 of this 2005 Act was adequate and to determine whether the agreement contains terms and condi-38 tions the court could have properly approved. 39

(6) Modification or termination of an irrevocable trust by nonjudicial settlement agree-40 ment is governed by section 31 of this 2005 Act. 41

SECTION 12. Role of court in administration of trust [Uniform Trust Code Section 201]. 42

(1) A court may intervene in the administration of a trust to the extent the court's juris-43 diction is invoked by an interested person or as provided by law. 44

(2) A trust is not subject to continuing judicial supervision unless ordered by a court. 45

1 (3) A judicial proceeding may relate to any matter involving a trust's administration, 2 including a request for instructions or a declaratory judgment action.

3 <u>SECTION 13.</u> Jurisdiction over trustee and beneficiary [Uniform Trust Code Section 202].

4 (1) By accepting the trusteeship of a trust having its principal place of administration in
5 Oregon or by moving the principal place of administration to this state, the trustee submits
6 personally to the jurisdiction of the courts of this state regarding any matter involving the
7 trust.

8 (2) The beneficiaries of a trust having its principal place of administration in Oregon are 9 subject to the jurisdiction of the courts of Oregon regarding any matter involving the bene-10 ficiaries' interests in the trust. By accepting a distribution from such a trust, the recipient 11 submits personally to the jurisdiction of the courts of this state regarding any matter in-12 volving the trust.

(3) This section does not preclude other methods of obtaining jurisdiction over a trustee,
 beneficiary or other person receiving property from the trust.

<u>SECTION 14.</u> Subject-matter jurisdiction [Uniform Trust Code Section 203]. The circuit
 court has jurisdiction of proceedings in this state concerning the administration of a trust.

17 <u>SECTION 15. Venue [Uniform Trust Code Section 204].</u> (1) Except as otherwise provided 18 in this section, venue for a judicial proceeding involving a trust is in the county in which the 19 trust's principal place of administration is or will be located.

(2) If a trust is created by will and the estate is not yet closed, venue for a judicial pro ceeding involving a trust is in the county in which the decedent's estate is being adminis tered.

(3) If a trust has no trustee, venue for a judicial proceeding for the appointment of a
trustee is in a county in which a beneficiary resides, in a county in which any trust property
is located and, if the trust is created by will, in the county in which the decedent's estate
was or is being administered.

27 <u>SECTION 16.</u> Representation; basic effect [Uniform Trust Code Section 301]. (1) Notice 28 to a person who may represent and bind another person under sections 16 to 20 of this 2005 29 Act has the same effect as if notice were given directly to the other person. Notice to a 30 representative must comply with section 9 (4) of this 2005 Act.

(2) The consent of a person who may represent and bind another person under sections
16 to 20 of this 2005 Act is binding on the person represented unless the person represented
objects to the representation before the consent would otherwise have become effective.

(3) Except as otherwise provided in sections 31 and 46 of this 2005 Act, a person who is
 authorized to represent a financially incapable settlor under sections 16 to 20 of this 2005
 Act may receive notice and give binding consent on the settlor's behalf.

(4) A settlor may not represent and bind a beneficiary under sections 16 to 20 of this 2005
Act with respect to the termination or modification of an irrevocable trust under section 31
(1) of this 2005 Act.

40 <u>SECTION 17.</u> Representation by holder of general testamentary power of appointment 41 <u>[Uniform Trust Code Section 302].</u> To the extent there is no conflict of interest between the 42 holder of a general testamentary power of appointment and the persons represented with 43 respect to the particular question or dispute, the holder may represent and bind persons 44 whose interests are subject to the power as permissible appointees, as takers in default or 45 by other reason.

SECTION 18. Representation by fiduciaries and parents [Uniform Trust Code Section 1 2 303]. To the extent there is no conflict of interest between the representative and the person represented or among those being represented with respect to a particular question or dis-3 4 pute: $\mathbf{5}$ (1) A conservator may represent and bind the estate that the conservator controls;

(2) An agent having authority to act with respect to the particular question or dispute 6 may represent and bind the principal; 7

8

(3) A trustee may represent and bind the beneficiaries of the trust;

9 (4) A personal representative of a decedent's estate may represent and bind persons in-10 terested in the estate; and

11 12

(5) A parent may represent and bind the parent's minor or unborn child if a conservator for the child has not been appointed.

SECTION 19. Representation by person having substantially identical interest [Uniform 13 Trust Code Section 304]. Unless otherwise represented, a minor, financially incapable indi-14 15 vidual or unborn individual, or a person whose identity or location is unknown and not reasonably ascertainable, may be represented by and bound by another person having a 16 substantially identical interest with respect to the particular question or dispute, but only 17 18 to the extent there is no conflict of interest between the representative and the person re-19 presented.

SECTION 20. Appointment of special representative [Uniform Trust Code Section 305]. 20(1) If the court determines that the interest of a person is not represented under sections 21 2216 to 20 of this 2005 Act, or that the otherwise available representation might be inadequate, 23the court may appoint a special representative to receive notice, give consent and otherwise represent, bind and act on behalf of a minor, financially incapable individual or unborn indi-94 25vidual, or a person whose identity or location is unknown and not reasonably ascertainable. A special representative may be appointed to represent several persons or interests, if the 2627interests of the persons represented do not conflict.

(2) A special representative may act on behalf of the individual represented with respect 28to any matter that the court has authorized, whether or not a judicial proceeding concerning 2930 the trust is pending.

31 (3) In making decisions, a special representative may consider general benefit accruing to the living members of the individual's family. 32

(4) A person appointed as special representative must have appropriate skills and expe-33 34 rience necessary to adequately represent the individual in the matter for which the special 35representative is appointed. A special representative may not have an interest in the trust that is the subject of the appointment of the special representative. A special representative 36 37 may not be related to a personal representative of an estate with an interest in the trust, 38 or to a trustee, beneficiary or other person with an interest in the trust.

(5) A person requesting the appointment of a special representative must file a petition 39 with the court describing the proposed special representative, the need for a special repre-40 sentative, the qualifications of the special representative, the person or persons who will be 41 represented, the actions that the special representative will take and the approximate date 42 or event when the authority of the special representative will terminate. The person seeking 43 to serve as special representative must file a consent to serve. 44

(6) A special representative appointed under this section is entitled to reasonable com-45

1	pensation for services. The trustee shall pay compensation to the special representative from
2	the principal of the trust that is attributable to those beneficiaries who are represented. If
3	the beneficiaries who are represented do not have principal that is attributable to them,

38	designator, or if satisfactory evidence is furnished within the one-year period showing that
39	a trustee cannot qualify to receive the death benefits. The obligor is discharged from any
40	liability for the death benefits upon making the payment.
41	(c) Death benefits received by the trustee are not subject to the debts of the designator
42	or to inheritance or estate taxes to any greater extent than if the death benefits were pay-
43	able to the beneficiaries named in the trust and not to the estate of the designator.
44	(d) Death benefits held in trust may be commingled with any other assets that may

by fraud, duress or undue influence.

7 <u>SECTION 27.</u> Evidence of oral trust [Uniform Trust Code Section 407]. Except as required 8 by a statute other than sections 1 to 95 of this 2005 Act, a trust need not be evidenced by a 9 trust instrument. The creation of an oral trust, and the terms of an oral trust, must be es-10 tablished by clear and convincing evidence.

11 SECTION 28. Pet trust [Uniform Trust Code Section 408]. (1) A trust may be created to 12 provide for the care of one or more animals that are alive during the settlor's lifetime. The 13 trust terminates upon the death of the animal or, if the trust was created to provide for the 14 care of more than one animal, upon the death of the last surviving animal. In the absence of a designation, the property shall be distributed to the settlor if the settlor is living when the distribution is made, or to the settlor's successors in interest if the settlor is not living when the distribution is made.

(4) Except as ordered by a circuit court or required by the trust instrument, a trustee
for a trust authorized under this section need not pay any fee or make any filing, report,
registration, periodic accounting, separate maintenance of funds or appointment by reason
of the existence of the fiduciary relationship of the trustee. A person appointed to enforce
the trust may request a report under section 71 (3) of this 2005 Act.

SECTION 29. Noncharitable trust without ascertainable beneficiary [Uniform Trust Code
 Section 409]. Except as otherwise provided in section 28 of this 2005 Act or by another stat ute:

(1) A trust may be created for a noncharitable purpose without a definite or definitely

19 SECTION 31. Modification or termination of irrevocable trust by consent [Uniform Trust Code Section-411]. (1) An irrevocable trust may be modified or terminated upon consent of 20the settlor and all beneficiaries, even if the modification or termination is inconsistent with 21 22a material purpose of the trust. The Attorney General must consent to any modification or 23termination of a charitable trust, unless contingencies make the charitable interest negligible. fiduciary acting on behalf of a protected person under the provisions of ORS chapter 125, a

CREDITOR'S CLAIMS; SPENDTHRIFT AND DISCRETIONARY TRUSTS

5 <u>SECTION 39.</u> <u>Rights of beneficiary's creditor or assignee [Uniform Trust Code Section</u> 6 <u>501].</u> To the extent a beneficiary's interest is not protected by a spendthrift provision, the 7 court may authorize a creditor or assignee of the beneficiary to reach the beneficiary's in-8 terest by garnishment or other execution against present or future distributions to or for 9 the benefit of the beneficiary or by other means. The court may limit such relief as is ap-10 propriate under the circumstances.

11 <u>SECTION 40.</u> Spendthrift provision [Uniform Trust Code Section 502]. (1) A spendthrift 12 provision is valid only if the provision restrains both voluntary and involuntary transfer of 13 a beneficiary's interest.

(2) A term of a trust providing that the interest of a beneficiary is held subject to a
 spendthrift trust, or words of similar import, is sufficient to restrain both voluntary and
 involuntary transfer of the beneficiary's interest.

(3) A beneficiary may not transfer an interest in a trust in violation of a valid spendthrift provision. Except as otherwise provided in sections 39 to 44 of this 2005 Act, a creditor or assignee of a beneficiary may not reach the interest of a beneficiary or a distribution by the trustee before the distribution is received by the beneficiary.

21 <u>SECTION 41.</u> Exceptions to spendthrift provisions [Uniform Trust Code Section 503]. (1) 22 As used in this section, "child" means any individual for whose benefit a judgment, court 23 order or administrative order for child support has been entered in any state, country or 24 other jurisdiction.

(2) Even if a trust contains a spendthrift provision, the holder of a judgment, court order 25or administrative order against a beneficiary for support or maintenance of the beneficiary's 2627child, spouse or former spouse or a judgment creditor who has provided services for the protection of a beneficiary's interest in the trust, may obtain an order from a court of this 28state authorizing garnishment or other execution against present or future distributions to 2930 or for the benefit of the beneficiary. The court may issue an order authorizing execution 31 against such amount as the court determines to be equitable under the circumstances but not more than the amount the trustee would have been required to distribute to or for the 32benefit of the beneficiary. Distributions subject to execution under this subsection include 33 34 distributions required by the express terms of the trust, such as mandatory payments of 35income, and distributions the trustee has otherwise decided to make, such as through the exercise of discretion. 36

(3) A spendthrift provision is unenforceable against a claim of this state or the United
States to the extent a statute of this state or federal law so provides.

39 <u>SECTION 42.</u> <u>Creditor's claim against settlor [Uniform Trust Code Section 505].</u> (1)
 40 Whether or not the terms of a trust contain a spendthrift provision:

(a) During the lifetime of the settlor, the property of a revocable trust is subject to
 claims of the settlor's creditors.

(b) A creditor or assignee of the settlor of an irrevocable trust may reach the maximum
amount that can be distributed to or for the settlor's benefit. If an irrevocable trust has
more than one settlor, the amount the creditor or assignee of a particular settlor may reach

1 may not exceed the settlor's interest in the portion of the trust attributable to that settlor's 2 contribution.

3 (c) If a trust remains revocable until the death of the settlor, the property of the trust 4 becomes subject to creditors' claims as provided in ORS 128.256 to 128.300 when the settlor 5 dies. The payment of claims is subject to the settlor's right to direct the priority of the 6 sources from which liabilities of the settlor are to be paid.

7 (2) For the purpose of creditors' claims, the holder of a power of withdrawal is treated 8 in the same manner as the settlor of a revocable trust to the extent property of the trust 9 is subject to the power. The provisions of this subsection apply to the holder of a power of 10 withdrawal only during the period that the power may be exercised.

(3) Upon the lapse, release or waiver of a power of withdrawal, the property of the trust that is the subject of the lapse, release or waiver becomes subject to claims of creditors of the holder of the power only to the extent the value of the property exceeds the greater of the amount specified in section 2041(b)(2) or 2514(e) of the Internal Revenue Code, as in effect on the effective date of sections 1 to 95 of this 2005 Act, or section 2503(b) of the Internal Revenue Code, as in effect on the effective date of sections 1 to 95 of this 2005 Act.

(4) Subsections (2) and (3) of this section do not apply to a person other than a settlor
who is a beneficiary of a revocable or irrevocable trust and who is also a trustee of the trust,
if the power to withdraw for the person's own benefit is limited by an ascertainable standard.

20 <u>SECTION 43.</u> Overdue distribution [Uniform Trust Code Section 506]. Whether or not a 21 trust contains a spendthrift provision, a creditor or assignee of a beneficiary may reach a 22 mandatory distribution of income or principal, including a distribution upon termination of 23 the trust, if the trustee has not made the distribution to the beneficiary within a reasonable 24 time after the designated distribution date.

25 <u>SECTION 44.</u> Personal obligations of trustee [Uniform Trust Code Section 507]. Trust 26 property is not subject to personal obligations of the trustee, even if the trustee becomes 27 insolvent or bankrupt.

REVOCABLE TRUSTS

31 <u>SECTION 45.</u> Capacity of settlor of revocable trust [Uniform Trust Code Section 601]. A 32 person who has capacity to make a will has capacity to create, amend, revoke or add prop-33 erty to a revocable trust, or to direct the actions of the trustee of a revocable trust.

34 <u>SECTION 46.</u> Revocation or amendment of revocable trust [Uniform Trust Code Section 35 <u>602].</u> (1) Unless the terms of a trust expressly provide that the trust is irrevocable, the 36 settlor of the trust may revoke or amend the trust.

(2) Unless the trust expressly provides otherwise, if a revocable trust is created or funded
 by more than one settlor:

(a) To the extent the trust consists of community property, the trust may be revoked
 by either spouse acting alone but may be amended only by joint action of both spouses;

(b) To the extent the trust consists of property other than community property, each
settlor may revoke or amend the trust as to the portion of the trust property attributable
to that settlor's contribution; and

44 (c) Upon the revocation or amendment of the trust by fewer than all of the settlors, the
 45 trustee shall promptly notify the other settlors of the revocation or amendment.

1 (3) The settlor may revoke or amend a revocable trust:

2 (a) By substantial compliance with a method provided in the terms of the trust; or

3 (b) If the terms of the trust do not provide a method, by any other method, except for
4 execution of a will or codicil, manifesting clear and convincing evidence of the settlor's in5 tent.

6 (4) Upon revocation of a revocable trust, the trustee shall deliver the trust property as 7 the settlor directs.

8 (5) A settlor's powers with respect to revocation, amendment or distribution of trust 9 property may be exercised by an agent or attorney-in-fact under a power of attorney only 10 to the extent expressly authorized by the terms of the trust.

(6) The settlor's conservator, or the settlor's guardian if a conservator has not been appointed for the settlor, may exercise a settlor's powers relating to revocation, amendment or distribution of trust property only with the approval of the court supervising the conservatorship or guardianship.

15 (7) A trustee who does not know that a trust has been revoked or amended is not liable 16 to the settlor or settlor's successors in interest for distributions made and other actions 17 taken on the assumption that the trust had not been amended or revoked.

18 <u>SECTION 47.</u> Section 46 (1) of this 2005 Act does not apply to a trust created under an
 19 instrument executed before the effective date of this 2005 Act.

20 <u>SECTION 48.</u> Settlor's powers; powers of withdrawal [Uniform Trust Code Section 603]. 21 (1) While the settlor of a revocable trust is alive, rights of the beneficiaries are subject to 22 the control of the settlor, and the duties of the trustee are owed exclusively to the settlor. 23 Beneficiaries other than the settlor have no right to receive notice, information or reports 24 under section 71 of this 2005 Act.

(2) The rights of the beneficiaries with respect to property that is subject to a power of withdrawal are subject to the control of the holder of the power during the period that the power may be exercised, and the duties of the trustee are owed exclusively to the holder of a power of withdrawal with respect to the property that is subject to the power.

<u>SECTION 49.</u> Limitation on action contesting validity of revocable trust; distribution of trust property [Uniform Trust Code Section 604]. SECTION 62. Prudent administration [Uniform Trust Code Section 804]. A trustee shall 28administer the trust as a prudent person would, by considering the purposes, terms, 2930 distributional requirements and other circumstances of the trust. In satisfying this standard, 31 the trustee shall exercise reasonable care, skill and caution.

SECTION 63. Costs of administration [Uniform Trust Code Section 805]. In administering 32a trust, the trustee may incur only costs that are reasonable in relation to the trust prop-33 34 erty, the purposes of the trust and the skills of the trustee.

35 SECTION 64. Trustee's skills [Uniform Trust Code Section 806]. A trustee who has special skills or expertise, or is named trustee in reliance upon the trustee's representation that 36 37 the trustee has special skills or expertise, shall use those special skills or expertise in ad-38 ministering the trust.

SECTION 65. Delegation by trustee [Uniform Trust Code Section 807]. (1) A trustee may 39 delegate duties and powers that a prudent trustee of comparable skills could properly dele-40 gate under the circumstances. The trustee shall exercise reasonable care, skill and caution 41 in: 42

43 (a) Selecting an agent;

(b) Establishing the scope and terms of the delegation, consistent with the purposes and 44 terms of the trust; and 45

(c) Periodically reviewing the agent's actions in order to monitor the agent's perform-1 2 ance and compliance with the terms of the delegation.

3 (2) In performing a delegated function, an agent owes a duty to the trust to exercise reasonable care to comply with the terms of the delegation. 4

(3) A trustee who complies with subsection (1) of this section is not liable to the benefi-5 ciaries or to the trust for an action of the agent. 6

(4) By accepting a delegation of powers or duties from the trustee of a trust that is 7 subject to this state's law, an agent submits to the jurisdiction of the courts of this state. 8

9 SECTION 66. Powers to direct [Uniform Trust Code Section 808]. (1) While a trust is revocable, the trustee may follow a direction of the settlor that is contrary to the terms of 10 the trust. 11

12(2) If the terms of a trust confer upon a person other than the settlor of a revocable 13 trust power to direct certain actions of the trustee, the trustee shall act in accordance with the directions given by the person unless the action is manifestly contrary to the terms of 14 15 the trust or the trustee knows the action would constitute a serious breach of a fiduciary duty that the person holding the power owes to the beneficiaries of the trust. 16

17(3) The terms of a trust may confer upon a trustee or other person a power to direct the 18 modification or termination of the trust.

19 (4) A person other than a beneficiary who holds a power to direct is rebuttably presumed to be a fiduciary and is required to act in good faith with regard to the purposes of the trust 20and the interests of the beneficiaries. The holder of a power to direct is liable for any loss 2122that results from breach of a fiduciary duty.

23SECTION 67. Control and protection of trust property [Uniform Trust Code Section 809]. A trustee shall take reasonable steps to take control of and protect the trust property. 24

25SECTION 68. Recordkeeping and identification of trust property [Uniform Trust Code Section 810]. (1) A trustee shall keep adequate records of the administration of the trust. 2627

(2) A trustee shall keep trust property separate from the trustee's own property.

(3) Except as otherwise provided in subsection (4) of this section, a trustee shall cause 28 the trust property to be designated so that the interest of the trust, to the extent feasible, 2930 appears in records maintained by a party other than a trustee or beneficiary.

31 (4) If the trustee maintains records clearly indicating the respective interests of the different trusts, a trustee may invest as a whole the property of two or more separate trusts. 32SECTION 69. Enforcement and defense of claims [Uniform Trust Code Section 811]. A 33 34 trustee shall take reasonable steps to enforce claims of the trust and to defend claims 35against the trust.

SECTION 70. Collecting trust property [Uniform Trust Code Section 812]. A trustee shall 36 37 take reasonable steps to compel a former trustee or other person to deliver trust property 38 to the trustee, and to remedy a breach of trust known to the trustee to have been committed by a former trustee. 39

SECTION 71. Duty to inform and report [Uniform Trust Code Section 813]. (1) A trustee 40 shall keep the qualified beneficiaries of the trust reasonably informed about the adminis-41 tration of the trust and of the material facts necessary for those beneficiaries to protect 42 their interests. If reasonable under the circumstances, a trustee may respond to a request 43 for information related to the administration of the trust from a beneficiary who is not a 44 qualified beneficiary. 45

The report must include a listing of trust property and 16 liabilities, and must show the market values of trust assets, if feasible. The report must re-17 18 flect all receipts and disbursements of the trust, including the source and amount of the trustee's compensation. Upon a vacancy in a trusteeship, unless a cotrustee remains in of-19 20fice, a trustee report must be sent to the qualified beneficiaries by the former trustee. A personal representative, conservator or guardian may send the qualified beneficiaries a 2122trustee report on behalf of a deceased or financially incapable trustee.

23(4) A qualified beneficiary may waive the right to a trustee report or other information otherwise required to be furnished under this section. A qualified beneficiary may withdraw 94 a waiver at any time for the purpose of future reports and other information. 25

(5) A trustee may charge a reasonable fee to a beneficiary for providing information un-2627der this section.

(6) A beneficiary's request for any information under this section must be with respect 28to a single trust that is sufficiently identified to enable the trustee to locate the trust's re-2930 cords.

31 (7) If the trustee is bound by any confidentiality restrictions regarding a trust asset, any beneficiary eligible under this section to receive information about that asset must agree to 32be bound by the same confidentiality restrictions before receiving the information. 33

34 (8) Despite any other provision of this section, information, notice and reports required 35by this section shall be given only to the settlor's spouse if:

(a) The spouse survives the settlor; 36

37 (b) The spouse is financially capable;

(c) The spouse is the only permissible distributee of the trust; and 38

(d) All of the other qualified beneficiaries of the trust are descendants of the spouse.

(9) Despite any other provision of this section, while the settlor of a revocable trust is 40 alive, beneficiaries other than the settlor have no right to receive notice, information or re-41 ports under this section. 42

SECTION 72. (1) Section 71 (2)(b) of this 2005 Act applies only to a trustee who accepts 43 a trusteeship on or after the effective date of this 2005 Act. 44

(2) Section 71 (2)(c) of this 2005 Act applies only to irrevocable trusts created on or after 45

the effective date of this 2005 Act and to revocable trusts that become irrevocable on or after the effective date of this 2005 Act.
<u>SECTION 73.</u> Discretionary powers; tax savings [Uniform Trust Code Section 814]. (1) A trustee shall exercise a discretionary power in good faith and in a manner that is in accordance with the terms and purposes of the trust and the interests of the beneficiaries. The duty imposed by this subsection is not affected by the grant of discretion in the terms of the trust, even though the terms of the trust provide that the trustee has absolute, sole or uncontrolled discretion or use other words purporting to convey broad discretion.
(2) Subject to subsection (4) of this section, and unless the terms of the trust expressly

10 provide otherwise:

(a) A person other than a settlor who is a beneficiary and trustee of a trust that confers
on the trustee a power to make discretionary distributions to or for the trustee's personal
benefit may exercise the power only in accordance with an ascertainable standard; and

(b) A trustee may not exercise a power to make discretionary distributions to satisfy a
 legal obligation of support that the trustee personally owes another person.

(3) A power the exercise of which is limited or prohibited by subsection (2) of this section may be exercised by a majority of the remaining trustees whose exercise of the power is not so limited or prohibited. If the power of all trustees is so limited or prohibited, the court may appoint a special fiduciary with authority to exercise the power.

(4) Subsection (2) of this section does not apply to:

(a) A power held by the settlor's spouse who is the trustee of a trust for which a marital
deduction, as described in section 2056(b)(5) or 2523(e) of the Internal Revenue Code, as in

(b) Any trust during any period that the trust may be revoked or amended by its settlor;
 or

(9) Enter into a lease for any purpose as lessor or lessee, including a lease or other ar-28 29rangement for exploration and removal of natural resources, with or without the option to 30 purchase or renew, even though the period of the lease extends beyond the duration of the 31 trust.

(10) Grant an option involving a sale, lease or other disposition of trust property or ac-32quire an option for the acquisition of property, even though the option is exercisable after 33 34 the trust is terminated, and exercise an option so acquired.

35 (11) Insure the property of the trust against damage or loss and insure the trustee, the trustee's agents, and beneficiaries against liability arising from the administration of the 36 37 trust.

38 (12) Abandon or decline to administer property of no value or property of a value that is not adequate to justify its collection or continued administration. 39

(13) Avoid possible liability for violation of environmental law by:

(a) Inspecting or investigating property the trustee holds or has been asked to hold, or 41 property owned or operated by an organization in which the trustee holds or has been asked 42 to hold an interest, for the purpose of determining the application of environmental law with 43 respect to the property; 44

(b) Taking action to prevent, abate or otherwise remedy any actual or potential violation

The trustee may make a loan to a beneficiary on 20terms and conditions the trustee considers to be fair and reasonable under the circumstances. The trustee may collect loans made to a beneficiary by making deductions from fu-2122ture distributions to the beneficiary. 23(19) Pledge trust property to guarantee loans made by others to the beneficiary. (20) Appoint a trustee to act in another state, country or other jurisdiction with respect 94 to trust property located in the other state, country or other jurisdiction, confer upon the 25appointed trustee all of the powers and duties of the appointing trustee, require that the 2627appointed trustee furnish security and remove any trustee so appointed. (28) Employ persons, including attorneys, auditors, investment advisors or agents, to advise or assist the trustee in the performance of administrative duties. A trustee may act based on the recommendations of professionals without independently investigating the recommendations.

(29) Apply for and qualify all or part of the property in the trust estate for special gov ernmental tax programs or other programs that may benefit the trust estate or any of the
 beneficiaries.

(30) Deposit securities in a clearing corporation as provided in ORS 128.100.

23 <u>SECTION 76.</u> Distribution upon termination [Uniform Trust Code Section 817]. (1) Upon 24 termination or partial termination of a trust, the trustee may send to the beneficiaries a 25 proposal for distribution. The right of any beneficiary to object to the proposal terminates 26 if the beneficiary does not notify the trustee of an objection within 30 days after the proposal 27 was sent, but only if the proposal informed the beneficiary of the right to object and the time 28 allowed for objection.

<u>SECTION 77.</u> <u>Trustee's duty to comply with prudent investor rule [Uniform Trust Code</u> <u>Section 901].</u> (1) Except as otherwise provided in subsection (2) of this section, a trustee who invests and manages trust assets owes a duty to the beneficiaries of the trust to comply with the prudent investor rule set forth in section 78 of this 2005 Act.

UNIFORM PRUDENT INVESTOR ACT

45 (2) The prudent investor rule is a default rule that may be expanded, restricted, elimi-

nated or otherwise altered by the provisions of a trust. A trustee is not liable to a beneficiary 1 2 to the extent that the trustee acted in reasonable reliance on the provisions of the trust. SECTION 78. Prudent investor rule [Uniform Trust Code Section 902]. (1) A trustee shall 3 invest and manage trust assets as a prudent investor would, by considering the purposes, 4 terms, distribution requirements and other circumstances of the trust. In satisfying this 5 standard, the trustee shall exercise reasonable care, skill and caution. 6 (2) A trustee's investment and management decisions respecting individual assets are not $\mathbf{7}$ evaluated in isolation, but in the context of the trust portfolio as a whole and as a part of 8 9 the overall investment strategy having risk and return objectives reasonably suited to the 10 trust. (3) A trustee shall consider all relevant circumstances in investing and managing trust 11 12assets, including any of the following that are relevant to the trust or the beneficiaries of 13 the trust: (a) General economic conditions; 14 15 (b) The possible effect of inflation or deflation; (c) The expected tax consequences of investment decisions or strategies; 16 (d) The role that each investment or course of action plays within an overall trust port-17folio, which may include financial assets, interests in closely held enterprises, tangible and 18 intangible personal property, and real property; 19 (e) The expected total return from income and the appreciation of capital; 20(f) Other resources of the beneficiaries; 21 22(g) Needs for liquidity, regularity of income and preservation or appreciation of capital; and 23(h) An asset's special relationship or special value, if any, to the purposes of the trust 24 or to one or more of the beneficiaries. 25(4) A trustee shall make a reasonable effort to verify facts relevant to the investment 2627and management of trust assets. (5) A trustee may invest in any kind of property or type of investment consistent with 28 the standards of sections 77 to 82 of this 2005 Act. 2930 (6) A trustee who has special skills or expertise, or is named trustee in reliance upon the 31 trustee's representation that the trustee has special skills or expertise, has a duty to use those special skills or expertise in administering the trust. 32SECTION 79. Diversification of trust investments [Uniform Trust Code Section 903]. A 33 34 trustee shall diversify the investments of the trust unless the trustee reasonably determines 35that, because of special circumstances, the purposes of the trust are better served without diversifying. 36 SECTION 80. Trustee duty [Uniform Trust Code Section 904]. Within a reasonable time 37 38 after accepting a trusteeship or receiving trust assets, a trustee shall review the trust assets and make and implement decisions concerning the retention and disposition of assets in or-39 der to bring the trust portfolio into compliance with the requirements of sections 77 to 82 40 of this 2005 Act and with the purposes, terms, distribution requirements and other circum-41 stances of the trust. 42 SECTION 81. Determination of compliance with prudent investor rule [Uniform Trust 43 Code Section 905]. 19	(2) To remedy a breach of trust that has occurred or to prevent a breach of trust, the

27	(f) Suspend the trustee;
28	(g) Remove the trustee as provided in section 55 of this 2005 Act;
29	(h) Reduce or deny compensation to the trustee;
30	(i) Subject to section 94 of this 2005 Act, void an act of the trustee, impose a lien or a
31	constructive trust on trust property, or trace trust property wrongfully disposed of and re-
32	cover the property or its proceeds; or
33	(j) Order any other appropriate relief.
34	SECTION 84. Damages for breach of trust [Uniform Trust Code Section 1002]. (1) A
35	trustee who commits a breach of trust is liable to the beneficiaries affected for the greater
36	of:
37	(a) The amount of damages caused by the breach;
38	(b) The amount required to restore the value of the trust property and trust distributions
39	to what they would have been had the breach not occurred; or
40	(c) The profit the trustee made by reason of the breach.
41	(2) Except as otherwise provided in this subsection, if more than one trustee is liable to
42	the beneficiaries for a breach of trust, a trustee is entitled to contribution from the other
43	trustee or trustees. In determining the amount of contribution, the court shall consider the
44	degree of fault of each trustee and whether any trustee or trustees acted in bad faith or with
45	reckless indifference to the purposes of the trust or the interests of the beneficiaries. A

trustee who received a benefit from the breach of trust is not entitled to contribution from 1

2 another trustee to the extent of the benefit received.

SECTION 85. Damages in absence of breach [Uniform Trust Code Section 1003]. (1) Ex-3 cept as provided by ORS 709.175 or section 75 (4) and (15) of this 2005 Act or other law of this 4 state, a trustee is accountable to an affected beneficiary for any profit made by the trustee 5 arising from the administration of the trust, without regard to whether the profit resulted 6 from a breach of trust. 7

(2) Unless there is a breach of trust, a trustee is not liable to a beneficiary for a loss or 9 depreciation in the value of trust property or for not having made a profit.

SECTION 86. Attorney fees and costs [Uniform Trust Code Section 1004]. In a judicial 10 proceeding involving the validity or administration of a trust, the court may award costs and 11 12expenses and reasonable attorney's fees to any party, to be paid by another party or from 13 the trust.

SECTION 87. Limitation of action against trustee [Uniform Trust Code Section 1005]. (1) 14 15 Notwithstanding ORS chapter 12 or any other provision of law, but subject to subsection (2) of this section, a civil action against a trustee based on any act or omission of the trustee, 16 whether based in tort, contract or other theory of recovery, must be commenced within six 17 years after the date the act or omission is discovered, or six years after the date the act or 18 omission should have been discovered, whichever is later. 19

(2) A beneficiary may not commence a proceeding against a trustee more than one year 20after the date the beneficiary or a representative of the beneficiary is sent a report by cer-2122tified or regular mail that adequately discloses the existence of a potential claim and that 23informs the beneficiary of the time allowed for commencing a proceeding. A copy of this section must be attached to the report. The report must provide sufficient information so 94 that the beneficiary or representative knows of the potential claim or should have inquired 25into its existence. 26

(3) If subsections (1) and (2) of this section do not apply, a judicial proceeding against a 27trustee must be commenced within 10 years from the date of the act or omission complained 28of, or two years from the termination of any fiduciary account established under the trust, 2930 whichever is later.

31 SECTION 88. Reliance on trust instrument [Uniform Trust Code Section 1006]. A trustee who acts in reasonable reliance on the terms of the trust as expressed in the trust instru-32ment is not liable to a beneficiary for a breach of trust to the extent the breach resulted 33 34 from the reliance.

SECTION 89. Event affecting administration or distribution [Uniform Trust Code Section 351007]. If the administration or distribution of a trust is affected by the occurrence of a 36 37 marriage, a divorce, a death, the performance of educational requirements or other event, 38 a trustee is not liable for a loss resulting from the trustee's failure to determine whether the event has occurred if the trustee has exercised reasonable care in attempting to deter-39 mine whether the event has occurred. 40

SECTION 90. Exculpation of trustee [Uniform Trust Code Section 1008]. (1) A term of a 41 trust relieving a trustee of liability for breach of trust is unenforceable to the extent that 42 43 the term:

(a) Relieves the trustee of liability for breach of trust committed in bad faith or with 44 reckless indifference to the purposes of the trust or the interests of the beneficiaries; or 45

(b) Was inserted as the result of an abuse by the trustee of a fiduciary or confidential 1 2 relationship to the settlor. (2) An exculpatory term drafted or caused to be drafted by the trustee is invalid as an 3 abuse of a fiduciary or confidential relationship unless: 4 (a) The settlor is represented by an independent counsel who reviewed the term; or 5 (b) The trustee proves that the exculpatory term is fair under the circumstances and 6 that the term's existence and contents were adequately communicated to the settlor. 7 SECTION 91. Beneficiary's consent, release or ratification [Uniform Trust Code Section 8 9 1009]. If a beneficiary consents to conduct of a trustee that constitutes a breach of trust, releases a trustee from liability for a breach of trust or ratifies a transaction entered into 10 by a trustee that constitutes a breach of trust, the trustee is not liable to a beneficiary for 11 12the breach of trust unless: 13 (1) The consent, release or ratification of the beneficiary was induced by improper conduct of the trustee; or 14 15 (2) At the time of the consent, release or ratification, the beneficiary did not know of the beneficiary's rights or know of the material facts relating to the breach. 16 SECTION 92. Limitation on personal liability of trustee [Uniform Trust Code Section 17 1010]. (1) Except as otherwise provided in the contract, a trustee is not personally liable on 18 a contract properly entered into in the trustee's fiduciary capacity in the course of admin-19 istering the trust if the trustee disclosed the trustee's fiduciary capacity in the contract. 20(2) A trustee is personally liable for torts committed in the course of administering a 2122trust or for obligations arising from ownership or control of trust property, including liability 23for violation of environmental law, only if the trustee is personally at fault. (3) The following claims may be asserted in a judicial proceeding against the trustee in 24 the trustee's fiduciary capacity, whether or not the trustee is personally liable for the claim: 25(a) A claim based on a contract entered into by a trustee in the trustee's fiduciary ca-2627pacity. (b) A claim based on an obligation arising from ownership or control of trust property. 28(c) A claim based on a tort committed in the course of administering a trust. 2930 (4) This section does not impose personal liability on a trustee solely because the trustee 31 holds property under an instrument that shows title in the name of the trustee but does not state that the trustee holds the property in a representative capacity. 32SECTION 93. Interest as general partner [Uniform Trust Code Section 1011]. (1) Except 33 34 as otherwise provided in subsection (3) of this section or unless personal liability is imposed 35in the contract, a trustee who holds an interest as a general partner in a general or limited partnership is not personally liable on a contract entered into by the partnership after the 36 37 trust's acquisition of the interest if the trustee's fiduciary capacity is disclosed. 38 (2) Except as otherwise provided in subsection (3) of this section, a trustee who holds an interest as a general partner is not personally liable for torts committed by the partnership 39 or for obligations arising from ownership or control of the interest unless the trustee is 40 personally at fault. 41 (3) The immunity provided by this section does not apply if an interest in a partnership 42 is held by the trustee in a capacity other than that of trustee. 43

44 (4) If the trustee of a revocable trust holds an interest as a general partner, the settlor 45 is personally liable for contracts and other obligations of the partnership to the same extent

that the settlor would be liable if the settlor were a general partner. 1 2 SECTION 94. Protection of person dealing with trustee [Uniform Trust Code Section 1012]. (1) A person other than a beneficiary who in good faith assists a trustee, or who in 3 good faith and for value deals with a trustee, is not liable for acts of the trustee that exceed 4 the trustee's powers or for the improper exercise of the trustee's powers, unless the person 5 knows that the trustee has exceeded the trustee's powers or improperly exercised those 6 7 powers. (2) A person other than a beneficiary who deals with a trustee in good faith is not re-8 9 quired to inquire about the extent of the trustee's powers or about the propriety of the trustee's exercise of those powers. 10 (3) A person who in good faith delivers assets to a trustee need not ensure that the as-11 12sets are properly applied. 13 (4) Any person other than a beneficiary who in good faith assists a former trustee, or who in good faith and for value deals with a former trustee without knowledge that the 14 15 trusteeship has terminated, is not liable solely because the former trustee is no longer a trustee. 16 17(5) Comparable protective provisions of other laws relating to commercial transactions or transfer of securities by fiduciaries prevail over the protection provided by this section. 18 SECTION 95. Certification of trust [Uniform Trust Code Section 1013]. (1) A person who 19 is not a beneficiary and who proposes to deal with the trustee of a trust may require that 20all trustees execute and furnish to the person a certification of trust. 21 22(2) The certification of trust shall contain the following information: (a) That the trust exists and the date the trust instrument was executed; 23(b) The identity of the settlor; 94 (c) The identity and address of the currently acting trustee; 25(d) The powers of the trustee; 2627(e) The revocability or irrevocability of the trust and the identity of any person holding a power to revoke the trust; 28(f) The existence or nonexistence of any power to modify or amend the trust and the 2930 identity of any person holding a power to modify or amend the trust; 31 (g) The authority of cotrustees to sign or otherwise authenticate and whether all cotrustees or fewer than all are required in order to exercise powers of the trustee; 32(h) The trust's taxpayer identification number, whether the settlor's Social Security 33 34 number or an employer identification number; 35(i) The manner of taking title to trust property; and (j) The state, country or other jurisdiction under the laws of which the trust was estab-36 37 lished. 38 (3) A certification of trust must be signed or otherwise authenticated by all the trustees. (4) A certification of trust must state that the trust has not been revoked, modified or 39 amended in any manner that would cause the representations contained in the certification 40 of trust to be incorrect. 41 (5) A certification of trust need not contain the dispositive terms of a trust. 42 (6) A recipient of a certification of trust may not require the trustee to furnish the entire 43 trust instrument, but may require the trustee to furnish copies of excerpts from the original 44 trust instrument and later amendments that designate the trustee and confer upon the 45

(b) A decision regarding the factors that are relevant to the trust and its beneficiaries, the extent to which the factors are relevant and the weight, if any, to be given to those factors in deciding
whether and to what extent to exercise the discretionary power conferred by ORS 129.215 (1).

(3) If the court determines that a fiduciary has abused the fiduciary's discretion, the court may
place the income and remainder beneficiaries in the positions they would have occupied if the discretion had not been abused, according to the following rules:

(14) Advance or borrow money with or without security.

(15) Compromise, extend, renew or otherwise modify an obligation owing to the estate. A personal representative who holds a mortgage, pledge, lien or other security interest may accept a conveyance or transfer of the encumbered asset in lieu of foreclosure in full or partial satisfaction of the indebtedness.

(16) Accept other real property in part payment of the purchase price of real property sold bythe personal representative.

(17) Pay taxes, assessments and expenses incident to the administration of the estate.

(18) Employ qualified persons, including attorneys, accountants and investment advisers, to advise and assist the personal representative and to perform acts of administration, whether or not discretionary, on behalf of the personal representative.

(19) Prosecute or defend actions, claims or proceedings in any jurisdiction for the protection of the estate and of the personal representative in the performance of duties as personal representative.
