

# Senate Bill 1098

Sponsored by COMMITTEE ON RULES

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Revises provisions relating to state financial assistance or other assistance available to municipalities for certain economic and community development projects.

## A BILL FOR AN ACT

6 pealing ORS 285B.416, 285B.425, 285B.431, 285B.434, 285B.438, 285B.443, 285B.446, 285B.452,  
7 285B.461 and 285B.464; and prescribing an effective date.

### Be It Enacted by the People of the State of Oregon:

#### **SECTION 1.** ORS 285B.280 is amended to read:

10 285B.280. As used in ORS 285B.280 to 285B.286, unless the context requires otherwise[:],

11 [(1) "*Flexible networks*" means groups of three or more private sector firms working cooperatively  
12 to manufacture, sell or market products, develop technologies or create or disseminate information.]

13 [(2) "*High performance manufacturing practices*" means methods for organizing work which  
14 devolve greater decision-making responsibility onto front-line workers, including but not limited to em-  
15 ployee involvement, total quality control, just-in-time production and other related innovations.]

16 [(3) "*Key industries*" means traded sector industries that make a major contribution to the economy  
17 of Oregon, including but not limited to, forest products, agricultural products, high technology, primary  
18 and fabricated metals, fisheries, interstate and international tourism, film and video production, graphic  
19 communications, biotechnology, software, environmental services, plastics and aerospace.]

20 [(4) "*Network brokers*" means persons who are trained to assist private sector firms to form flexible  
21 networks and make other similar efforts to provide for joint manufacturing, marketing, technology de-  
22 velopment, information dissemination and other activities.]

23 [(5)] "traded sector" means industries in which member firms sell their goods or services into  
24 markets for which national or international competition exists.

#### **SECTION 2.** ORS 285B.410 is amended to read:

26 285B.410. As used in ORS 285B.410 to 285B.482, unless the context requires otherwise:

27 [(1) "*Community facilities*" means municipal facilities that assist the economic and community de-  
28 velopment of the municipality, as specified in rules adopted by the Economic and Community Develop-  
29 ment Department, whether operated by the municipality or by a person under a management contract  
30 or an operating agreement with the municipality.]

31 [(2) "*Community facilities project*" means a project for the acquisition, construction or development

1 of community facilities, including the acquisition of land, the mitigation of environmental conditions on  
 2 industrial lands, the construction, acquisition, renovation or reconstruction of buildings, structures and  
 3 other real property, and the acquisition or construction of related equipment and fixtures.]

4 [(3) "Direct project management costs" means new expenses incurred by a municipality solely to  
 5 support, plan for and manage an infrastructure or community facilities project, funded in whole or in  
 6 part through financial assistance under ORS 285B.410 to 285B.482, during the planning and con-  
 7 struction phases of the project.]

8 [(4) "Infrastructure project" means:]

9 [(a) A project for the construction of sewage treatment works, solid waste disposal sites, water  
 10 supply works, roads, public transportation, railroad industrial spurs or sidings, telecommunications  
 11 infrastructure, storm drainage systems or other facilities that comprise the physical foundation for in-  
 12 dustrial and commercial activity. The costs of property acquisition directly related to the infrastructure  
 13 project and acquisition of easements or rights of way necessary to accomplish construction of the  
 14 infrastructure project are eligible for assistance under ORS 285B.410 to 285B.482. The costs of activ-  
 15 ities related to performing an environmental action on a brownfield are eligible for assistance under  
 16 ORS 285B.416 (2) and 285B.455 (5). Purchases of off-site property for project-related purposes such as  
 17 wetland mitigation or other uses not directly related to the infrastructure are not eligible for assistance.  
 18 As used in this paragraph, "brownfield" and "environmental action" have the meanings given those  
 19 terms respectively in ORS 285A.185 and 285A.188.]

20 [(b) A project, in consultation with the Department of Transportation and other affected agencies,  
 21 for the acquisition, reconstruction or rehabilitation of an abandoned railroad line or railroad line that  
 22 has been designated by the owner and operator thereof as subject to abandonment within a three-year  
 23 period pursuant to federal law and regulations governing abandonment of common carrier railroad  
 24 lines. The project may include operation or maintenance costs if the project also includes acquisition,  
 25 reconstruction or rehabilitation.]

26 [(c) A safe drinking water project, in consultation with the Water Resources Department, the De-  
 27 partment of Human Services or the Department of Land Conservation and Development, for improving  
 28 a drinking water system for the purpose of achieving or maintaining compliance with applicable state  
 29 or federal drinking water quality regulations.]

30 [(d) A project, as specified by rule of the Economic and Community Development Department, re-  
 31 sulting from an emergency as defined in ORS 401.025.]

32 [(5) "Municipality" means a city, a county, the Port of Portland created by ORS 778.010, a county  
 33 service district organized under ORS chapter 451, a tribal council of an Indian tribe in this state or  
 34 a district as defined in ORS 198.010.]

35 [(6) "Nonurban infrastructure projects" includes all those infrastructure projects which do not meet  
 36 the definition of urban infrastructure projects.]

37 [(7) "Public transportation" includes public depots, public parking, public docks, public wharves,  
 38 railroads and airport facilities.]

39 [(8) "Roads" includes:]

40 [(a) Ways described as streets, highways, throughways or alleys;]

41 [(b) Road related structures that are in the right of way such as tunnels, culverts or similar  
 42 structures; and]

43 [(c) Structures that provide for continuity of the right of way such as bridges.]

44 [(9) "Sewage treatment works" includes all facilities necessary for collecting, pumping, treating and  
 45 disposing of sanitary or storm sewage.]

1       [(10) “Solid waste disposal site” has the meaning given to the term “disposal site” by ORS  
2 459.005.]

3       [(11) “Storm drainage systems” means facilities necessary for collecting, controlling, conveying,  
4 treating and disposing of storm water runoff.]

5       [(12) “Telecommunications infrastructure” means real or personal property, structures or equipment  
6 constructed, used or configured for the electronic transmission or receipt of voice, data, text, images or  
7 video between sites and facilities.]

8       [(13) “Urban infrastructure projects” includes all those infrastructure projects located in whole or  
9 in part within the acknowledged Portland Metropolitan Area Regional Urban Growth Boundary, and  
10 the acknowledged urban growth boundaries of the cities of Eugene, Springfield, Salem, Keizer or  
11 Medford or projects that will principally benefit these areas. The Director of the Economic and Com-  
12 munity Development Department is authorized to resolve situations left in question by this definition.]

13       [(14) “Water supply works” includes all facilities necessary for tapping natural sources of domestic  
14 and industrial water, treating and protecting the quality of the water and transmitting it to the point  
15 of sale to any public or private agency for domestic, municipal and industrial water supply service.]

16       **(1) “Airport” means:**

17       **(a) A runway, taxiway, aircraft parking apron, ramp, auto parking area, access road,  
18 safety area or runway protection zone;**

19       **(b) An airport-related facility, including a hangar, terminal, air traffic control tower or  
20 other building;**

21       **(c) A signal, navigational aid or traffic control system; or**

22       **(d) A fuel tank or other physical airport improvement.**

23       **(2) “Development project” means a project for the acquisition, improvement, con-  
24 struction, demolition, or redevelopment of municipally owned utilities, buildings, land,  
25 transportation facilities or other facilities that assist the economic and community develop-  
26 ment of the municipality, including planning project activities that are necessary or useful  
27 as determined by the Economic and Community Development Department.**

28       **(3) “Direct project management costs” means expenses directly related to a project that  
29 are incurred by a municipality solely to support or manage a project eligible for assistance  
30 under ORS 285B.410 to 285B.482. “Direct project management costs” does not include routine  
31 or ongoing expenses of the municipality.**

32       **(4) “Emergency project” means a development project resulting from an emergency as  
33 defined in ORS 401.025, to which federal disaster relief has been committed.**

34       **(5) “Energy system” means a facility necessary for the distribution, transmission or  
35 generation of energy, including but not limited to facilities powered by wind, solar energy or  
36 biofuel and facilities for the collection, storage, transmission or distribution of a fuel, in-  
37 cluding natural gas, methane or hydrogen.**

38       **(6) “Marine facility” means:**

39       **(a) A wharf, dock, freight handling or passenger facility;**

40       **(b) A navigation channel or structure, including a project funded under ORS 777.267; or**

41       **(c) Any other physical marine facility improvement.**

42       **(7) “Municipality” means an Oregon city or county, the Port of Portland created by ORS  
43 778.010, a county service district organized under ORS chapter 451, a district as defined in  
44 ORS 198.010, a tribal council of a federally recognized Indian tribe in this state or an airport  
45 district organized under ORS chapter 838.**

- 1 (8) “Planning project” means:
- 2 (a) A project related to a potential development project for preliminary, final or con-
- 3 struction engineering;
- 4 (b) A survey, site investigation or environmental action;
- 5 (c) A financial, technical or other feasibility report, study or plan; or
- 6 (d) An activity that the department determines to be necessary or useful in planning for
- 7 a potential development project.
- 8 (9) “Project” means a development, planning or emergency project.
- 9 (10) “Railroad” means:
- 10 (a) A main line, siding, yard, connecting or auxiliary track, right of way or easement;
- 11 (b) An industrial spur or related facility, including a depot, shop, maintenance building
- 12 or other building;
- 13 (c) A signal or traffic control system;
- 14 (d) A bridge or tunnel;
- 15 (e) A dock, pit, conveyor, bin, crane, piping system, tank or pavement for unloading,
- 16 loading or transfer of freight, trailers or containers; or
- 17 (f) Any other physical railroad improvement.
- 18 (11) “Road” means a street, highway or thruway or a road-related structure that provides
- 19 for continuity of a right of way, including a bridge, tunnel, culvert or similar structure or
- 20 other physical road-related improvement.
- 21 (12) “Rural area” has the meaning given that term in ORS 285A.010.
- 22 (13) “Sewage system” means a facility necessary for collecting, pumping, treating or
- 23 disposing of sanitary sewage.
- 24 (14) “Solid waste disposal site” has the meaning given the term “disposal site” in ORS
- 25 459.005.
- 26 (15) “Storm water drainage system” means a facility necessary for collecting, controlling,
- 27 conveying, treating or disposing of storm water runoff.
- 28 (16) “Telecommunications system” means equipment or a facility for the electronic
- 29 transmission of voice, data, text, image or video.
- 30 (17) “Transportation” means a system for movement of freight or passengers.
- 31 (18) “Utilities” means a solid waste disposal site or a water, sewage, storm water drain-
- 32 age, energy or telecommunications system.
- 33 (19) “Water system” means a facility for supplying, treating or protecting the quality of
- 34 water and transmitting water to a point of sale or to any public or private agency for do-
- 35 mestic, municipal, commercial or industrial use.
- 36 **SECTION 3.** ORS 285B.413 is amended to read:
- 37 285B.413. (1) The Legislative Assembly finds that:
- 38 (a) The improvement, expansion and new construction of the state’s [*sewage treatment works,*
- 39 *water supply works*] **water and sewage systems**, telecommunications [*infrastructure*] **systems**,
- 40 roads and public transportation provide the basic framework for continuing and expanding economic
- 41 activity in this state, thereby providing jobs and economic opportunity for the people of Oregon.
- 42 (b) It is essential to maintain usable and developable industrial and commercial lands in Oregon.
- 43 (2) [*Since*] **Because** municipalities in this state often suffer from a lack of available financing
- 44 and technical capacity for [*such*] **these** projects, it is the purpose of ORS 285B.410 to 285B.482 to
- 45 provide financial or other assistance [*in order that they may*] **to enable municipalities to** construct,

1 improve and repair those facilities that are essential for supporting continuing and expanded eco-  
 2 nomic activity. It is the intent of the Legislative Assembly, by providing that assistance, to stimulate  
 3 industrial growth and commercial enterprise and to promote employment opportunities in Oregon.

4 (3) *[The money]* **Moneys** in the Special Public Works Fund shall be used primarily to provide  
 5 loans to municipalities for *[infrastructure and community facilities]* **development and planning**  
 6 projects. Grants shall be given only when loans are not feasible due to the *[economic]* **financial** need  
 7 of the *[applicant]* municipality *[and]* **or** special circumstances of the project. The *[Director of the]*  
 8 Economic and Community Development Department is authorized to determine the level of grant or  
 9 loan funding, if any, on a case-by-case basis.

10 **SECTION 4.** ORS 285B.455 is amended to read:

11 285B.455. (1) There is created the Special Public Works Fund, separate and distinct from the  
 12 General Fund. All moneys credited to the Special Public Works Fund are appropriated continuously  
 13 **to the Economic and Community Development Department.** *[and shall be used for the purposes*  
 14 *outlined in ORS 285A.075 (9) and 285B.410 to 285B.482. There shall be credited to the Special Public*  
 15 *Works Fund, money appropriated to the fund by the Legislative Assembly, earnings on the fund, re-*  
 16 *payment of financial assistance and bond proceeds as authorized under ORS 285B.410 to 285B.482.]*

17 **(2) The fund shall consist of all moneys credited to the fund, including:**

18 **(a) Moneys appropriated to the fund by the Legislative Assembly or transferred to the**  
 19 **fund by the Oregon Economic and Community Development Commission;**

20 **(b) Earnings on the fund;**

21 **(c) Repayment of financial assistance, including interest;**

22 **(d) Moneys received from the federal government, other state agencies or local govern-**  
 23 **ments;**

24 **(e) Bond proceeds as authorized under ORS 285B.410 to 285B.482 or other law; and**

25 **(f) Moneys from any other source, including but not limited to grants and gifts.**

26 *[(2)]* **(3)** Moneys in the Special Public Works Fund, with the approval of the State Treasurer,  
 27 may be invested as provided by ORS 293.701 to 293.820 and the earnings from *[such]* **the** investments  
 28 shall be credited to the account in the Special Public Works Fund designated by the *[Economic and*  
 29 *Community Development]* department.

30 *[(3)]* **(4)** The *[Economic and Community Development]* department shall *[be the agency for the State*  
 31 *of Oregon for the administration of]* **administer** the Special Public Works Fund.

32 *[(4)]* **(5)** The department may establish *[such]* other accounts within the Special Public Works  
 33 Fund for the payment of project costs, reserves, debt service payments, credit enhancement, *[ad-*  
 34 *ministration]* **administrative costs** and operation expenses or any other purpose necessary to carry  
 35 out ORS 285B.410 to 285B.482.

36 *[(5) Out of moneys in the Special Public Works Fund, the department may:]*

37 *[(a) Make technical assistance grants and loans to municipalities. The department may not expend*  
 38 *more than one percent of the value of the Special Public Works Fund for technical assistance grants*  
 39 *and loans to municipalities in a biennium.]*

40 *[(b) Make grants to municipalities to provide local matching funds for the purposes of a project*  
 41 *described in ORS 285B.410 (4)(d) in an amount that does not exceed \$2.5 million in any biennium.]*

42 **(6) The department may grant, expend or loan moneys in the fund to:**

43 **(a) Provide financial or other assistance to municipalities for projects determined by the**  
 44 **department to be appropriate.**

45 **(b) Purchase goods or services related to a project on behalf of the municipality.**

1 (c) Provide state funds as a match for federal funds available for the administration of  
2 the Community Development Block Grant program.

3 (d) Finance administrative costs of the department pursuant to ORS 285B.410 to 285B.482.

4 (e) Provide annual grants on behalf of a municipality in the form of partial repayment  
5 to bondholders of amounts owed.

6 (f) Cover contracts that are issued to guaranty any portion of the obligation of a  
7 municipality to finance a development project and that are not sold to the State of Oregon.  
8 Guaranty contracts under this paragraph shall be payable solely from moneys in the Special  
9 Public Works Fund, and shall not constitute a debt or obligation of the State of Oregon. The  
10 department may, on behalf of the state, establish a special account in the fund and commit  
11 to deposit into the account specified portions of existing and future allocations to the fund.  
12 The commitments shall be made by rule of the department and shall constitute covenants  
13 of the state for the benefit of the owners of obligations guaranteed by the state pursuant to  
14 this section.

15 (7) As used in this section, "administrative costs" includes the department's direct and  
16 indirect costs for investigating and processing an application, developing a contract, moni-  
17 toring the use of funds by a municipality, investigating and resolving budget discrepancies,  
18 closing a project and providing financial or other assistance to a municipality.

19 **SECTION 5.** ORS 285B.419 is amended to read:

20 285B.419. (1) The Economic and Community Development Department shall adopt rules and  
21 policies for the administration of the Special Public Works Fund. [*Insofar as practicable, the depart-*  
22 *ment's rules shall provide that infrastructure projects that meet the following criteria receive priority*  
23 *for assistance:]* **All forms of assistance are subject to the rules and policies of the department.**

24 [(a) Provide for the establishment or enlargement of economically viable industries, with reasonable  
25 long term growth prospects, including opportunities for innovative new industries or for continuance  
26 of existing basic industries.]

27 [(b) Result in a net benefit to the state in the long term and not require continuing state  
28 subsidies.]

29 [(c) Utilize existing public and private assets, including infrastructure, human resources and plant  
30 and equipment.]

31 [(d) Improve the conditions of the economically disadvantaged and increase the number of jobs that  
32 increase average incomes.]

33 [(e) Support the development of businesses owned by women and members of minority groups.]

34 [(f) Harness Oregon's comparative advantage with emphasis on the growth and development of ex-  
35 isting, in-state businesses, especially small businesses.]

36 [(g) Direct assistance to infrastructure projects that assist businesses selling goods and services in  
37 markets for which national or international competition exists and prohibit assistance to infrastructure  
38 projects that primarily focus on relocating business or economic activity from one part of the state to  
39 another.]

40 [(h) Result in the economic revitalization of communities.]

41 [(i) Are funded and otherwise supported to the maximum extent possible by private resources.]

42 [(j) Result in business growth or expansion which would not occur in Oregon without an invest-  
43 ment from the Special Public Works Fund.]

44 (2)[(a)] The [Economic and Community Development] department shall manage the Special Public  
45 Works Fund and any expenditures from its accounts and transfers between its accounts so that the

1 fund [value shall be equal to at least 50 percent of lottery revenues actually transferred to the fund plus  
2 interest on such amounts compounded annually at five percent] **provides a continuing source of fi-**  
3 **nancing for development or planning projects consistent with ORS 285B.413.**

4 [(b) If necessary to ensure repayment of bonds issued under ORS 285B.410 to 285B.482, the Eco-  
5 nomic and Community Development Department is authorized to reduce the value of the fund to less  
6 than the limit provided in paragraph (a) of this subsection if the department:]

7 [(A) Finds that without such a reduction in fund value, bonds secured by the fund are likely to  
8 be in default; and]

9 [(B) Imposes a moratorium on grants until the requirements of paragraph (a) of this subsection are  
10 met.]

11 [(3)(a) Not more than 100 percent of The total cost of any infrastructure or community facilities  
12 project shall be financed from the Special Public Works Fund.]

13 [(b) For purposes of a project described in ORS 285B.410 (4)(d), the total cost described in para-  
14 graph (a) of this subsection is the total local matching funds requirement for the federal disaster relief  
15 assistance committed to the project.]

16 [(4)] (3) The department may commit moneys in the Special Public Works Fund or reserve future  
17 income to the fund for disbursement in future years under ORS 285B.440 [(4)]. The department shall  
18 commit or reserve moneys under this subsection only after:

19 (a) Allowing for contingencies;

20 (b) Finding that there will be sufficient unobligated net income to the fund to make [such] **the**  
21 future payments[. Such a finding shall be based on financial plans which are], consistent with the  
22 financial requirements of subsections (2) and [(4)] (3) of this section; and

23 (c) Providing in any contract for [such] **the** commitment that the liability of the state to make  
24 [such] **the** annual payments shall be contingent on the availability of moneys in the Special Public  
25 Works Fund.

26 [(5)] (4) In assisting [local governments with infrastructure and community facilities] **municipi-**  
27 **palities with** projects, the department shall cooperate to the maximum extent possible with other  
28 state [agencies financing similar projects, including but not limited to the Department of Environmental  
29 Quality, the Water Resources Department and the Department of Transportation] **and federal agen-**  
30 **cies.**

31 [(6) The department shall notify the Housing and Community Services Department of any proposed  
32 Special Public Works Fund project with a related workforce increase at the time the department re-  
33 ceives the completed application for the project.]

34 **SECTION 6.** ORS 285B.422 is amended to read:

35 285B.422. (1) The Economic and Community Development Department may provide financial or  
36 other assistance to [municipalities] **a municipality** for [community facilities projects as described] **a**  
37 **development project as defined** in ORS 285B.410.

38 [(2) Before providing financial assistance for a community facilities project, the Economic and  
39 Community Development Department must find that:]

40 [(a) The municipality has demonstrated that the community facilities project will provide long term  
41 benefits to the municipality;]

42 [(b) The community facilities project will benefit a broad cross-section of the municipality or im-  
43 prove the local economy;]

44 [(c) There is a substantial local commitment to the community facilities to be financed; and]

45 [(d) There is a need for the proposed community facilities project, and the municipality's financial

1 *resources are adequate to provide the working capital needed to ensure success of the project.]*

2 *[(3)(a) Except as provided in this subsection and ORS 285B.455 (5), and notwithstanding any other*  
 3 *provision of ORS 285B.410 to 285B.482, community facilities projects are not eligible for grants made*  
 4 *from the Special Public Works Fund.]*

5 *[(b) Grants from the Special Public Works Fund may be made for a community facilities project*  
 6 *that is an essential community facilities project, as determined in accordance with rules adopted by the*  
 7 *department after consultation with the League of Oregon Cities, the Association of Oregon Counties, the*  
 8 *Oregon Public Ports Association and Special Districts Association of Oregon. Loans or grants from*  
 9 *the Special Public Works Fund and loans from the proceeds of revenue bonds issued under ORS*  
 10 *285B.467 may be used to pay issuance costs and for the funding of any debt service reserve for any*  
 11 *revenue bonds issued under ORS 285B.467 to finance essential community facilities.]*

12 *[(c) The department shall determine the maximum amount of a grant to a municipality from the*  
 13 *Special Public Works Fund for an essential community facilities project. However, a grant may not*  
 14 *exceed 85 percent of the total project costs.]*

15 *[(4) ORS 285B.413 (1) and (2), 285B.419 (1), 285B.434, 285B.443 (1)(b) and 285B.467 (2) and (8)*  
 16 *do not apply to a municipality applying for financial assistance for a community facilities project.]*

17 **(2) The project must be municipally owned and operated either by the municipality or**  
 18 **under a management contract or an operating agreement with the municipality. If the**  
 19 **project consists:**

20 **(a) Solely of the purchase or acquisition of land by the municipality, the land must be**  
 21 **identified in the applicable land use or capital plan as necessary for a potential development**  
 22 **project or be zoned solely for commercial or industrial use.**

23 **(b) Of a privately owned railroad, the railroad must be designated by the owner and op-**  
 24 **erator as subject to abandonment within three years, pursuant to federal law governing**  
 25 **abandonment of common carrier railroad lines.**

26 **(c) Of a telecommunications system, the governing body of the municipality shall adopt**  
 27 **a resolution, after a public hearing, finding that the proposed telecommunications system**  
 28 **project is necessary and would not otherwise be provided by a for-profit entity within a rea-**  
 29 **sonable time and for a reasonable cost.**

30 **(3) If the project is an energy system, the municipality and the serving utility must ex-**  
 31 **ecute an ownership and operating agreement for the proposed energy system. This sub-**  
 32 **section does not apply when the energy system will be located within the recognized service**  
 33 **territory of the municipality.**

34 **(4) The department may not use funds to provide assistance for:**

35 **(a) Projects that primarily focus on relocating business or economic activity from one**  
 36 **part of the state to another, except in cases where the business or economic activity would**  
 37 **otherwise locate outside of Oregon; or**

38 **(b) Ongoing operations or maintenance expenses.**

39 **SECTION 7. Sections 8 to 10 of this 2005 Act are added to and made a part of ORS**  
 40 **285B.410 to 285B.482.**

18 (2)(a) Moneys in the Water Fund may be obligated to water projects.

19 (b) Moneys shall be used primarily to make loans to municipalities. The department may make  
20 a loan only if:

21 (A) The municipality applying for the loan certifies to the department that adequate funds will  
22 be available to repay the loan; and

23 (B) The department determines that the amount of the loan applied for is based on a reasonable  
24 and prudent expectation of the municipality's ability to repay the loan.

25 (c) The department may award a grant only if a loan is not feasible due to:

26 (A) Financial hardship to the municipality, as determined by the department, based on consid-  
27 eration of anticipated water service charges or anticipated waste water service charges that exceed  
28 the statewide average for *[such]* **the** charges, the per capita income of the municipality and *[such]*  
29 **any** other factors as the department by rule may establish; and

44 (e) Proceeds of revenue bonds issued under ORS 285B.575.

45 (f) Earnings on the **Water** Fund.



1 (6) The department shall administer the fund.

2 (7) The department shall adopt rules and policies for the administration of the fund. The de-  
3 partment shall coordinate its rulemaking regarding safe drinking water projects with the Water  
4 Resources Department and the Department of Human Services. The rules adopted under this sub-  
5 section for safe drinking water projects shall:

6 (a) Require the installation of meters on all new **active** service connections [*to*] **from** any dis-

7 **285B.452, 285B.461 and 285B.464 are repealed.**

8 **SECTION 36. This 2005 Act takes effect on the 91st day after the date on which the**  
9 **regular session of the Seventy-third Legislative Assembly adjourns sine die.**
