NOTES OF DECISIONS

The description of that part of Union County annexed to Baker County in 1901 can be upheld, if it is construed in the light of surrounding circumstances. *Baker County v. Benson*, (1901) 40 Or 207, 66 P 815.

NOTES OF DECISIONS

The Supreme Court takes judicial notice of fact that property in the northeast quarter of section 3, township 2 north, range 6 east of the Willamette meridian, is not in Clackamas County, but is many miles distant therefrom. *Sammons v. Paterson*, (1928) 127 Or 11, 270 P 499.

NOTES OF DECISIONS

The amendment of 1901 did not repeal 1898 p 27 §1 [now ORS 201.340] defining the boundaries of Washington County which detached a strip of territory from the southwest corner of Columbia County and attached it to Washington County. *Allison v. Hatton*, (1905) 46 Or 370, 80 P 101.

Some doubt exists as to the original location of the western boundary of this county. *State v. Branton*, (1899) 33 Or 533, 56 P 267.

NOTES OF DECISIONS

This section is not void for failure of its title sufficiently to disclose its subject matter. *Allison v. Hatton*, (1905) 46 Or 370, 80 P 101.

The amendment of 1898 was not repealed by enactment of 1901 p 126 §1 amending H §2251 [now ORS 201.050], which changed the boundaries of Columbia County to include at the southeast corner a small area which previously had not been included in any county, where the 1901 amendment merely restated or republished such area as it existed prior to the 1898 amendment. *Id.*
