NOTES OF DECISIONS

Under a former similar section, the voters were without authority to vote the tax if the approval of the county court was not indorsed upon the petition. *Stevens v. Tillamook County*, (1929) 128 Or 339, 273 P 716.

Under a former similar section, preparation by the county court of notices of meeting and signing them by a county judge was not equivalent to the approval and indorsement thereof on the petition. *Id.*
