NOTES OF DECISIONS

Under a former similar statute, ejection to recover possession of rooms in the capitol building was properly brought in the name of the state on relation of the Secretary of State instead of in the name of the Secretary of State, since the statute did not give him exclusive possession of such building. *State v.
