##### NOTES OF DECISIONS

School districts are bodies corporate, and as such authorized to hold and dispose of property in their name and corporate capacity. *Vestal v. Pickering*, (1928) 125 Or 553, 267 P 821.

The power to receive property by will is included in the authority of a school district. *Id.*

A school district is an agency of the state, created by law for the purpose of promoting education. *Antin v. Union High Sch. Dist. 2*, (1929) 130 Or 461, 280 P 664, 66 ALR 1271.

##### NOTES OF DECISIONS

In performing its statutory duties a school district acts wholly as a governmental agency. *Antin v. Union High Sch. Dist. 2*, (1929) 130 Or 461, 280 P 664, 66 ALR 1271.

Provision of a school building, and heat, light and water for pupils is the performance of the governmental function of a school district. *Id.*
