Dear Representative Gomberg,

This letter of advice is provided in response to your request received on September 2, 2025, which presented a question regarding the application of Oregon Government Ethics Law to a public official accepting payment of international travel and related expenses. This analysis and advice is being offered under the authority provided in ORS 244.284 as guidance on how the current provisions of Oregon Government Ethics Law may apply to the specific circumstances that have been presented.

In your request for advice, you explain that you have been asked to participate in the "50 States, One Israel," a bipartisan delegation to Israel from September 13<sup>th</sup> to September 18<sup>th</sup>, 2025. The trip is being sponsored by the Consulate General of Israel, which is covering the costs of transit, lodging, and meals. The trip aims to connect legislators with communities and prominent Israeli leadership to learn more about potential trade opportunities. Your request for guidance asks whether you could accept the invitation and the paid travel expenses under one of the gift exceptions in ORS 244.020(7)(b).

Under most circumstances when a public official is offered food, lodging and travel expenses at no cost to the public official, it would be considered a gift as defined in ORS 244.010(7)(a); however, ORS 244.020(7)(b)(H) provides a gift exception for reasonable food, travel or lodging expenses provided to a public official, or to a relative, household member or staff member accompanying the public official, when the public official represents state government, a local government or a special government body, in: (i) an officially sanctioned trade-promotion or fact-finding mission; or (ii) officially designated negotiations, or economic development activities, where receipt of the expenses is approved in advance.

In order for the gift exception in ORS 244.020(7)(b)(H) to apply, there are three criteria that must be met. First, the public official must be representing state government, a local government or a special government body. Second, the purpose of the trip must be for trade promotion or a fact-finding mission, or for negotiations or economic development activities, where receipt of expenses is approved in advance. A fact-finding mission or trip is defined as "any activity related to a cultural or educational purpose, or any activity aimed at providing intergovernmental assistance, such as for the purpose of international aid or sharing best practices, or developing intergovernmental relationships directly related to the public official's duties." 0001(2)]. In this case, it appears that you and your staff would be representing state government on this trip. Based on the information provided, it appears that the trip has an educational and intergovernmental purpose. The trip appears to provide a cultural exchange and opportunity to strengthen intergovernmental relationship between Isreal and members of the Legislative Assembly. Therefore, the trip appears to meet the definition of a "fact finding mission or trip".

The third criteria under ORS 244.020(7)(b)(H) is that the trip and your receipt of the paid expenses be officially sanctioned or designated. This requires written approval in advance by a state or local public body or by a person authorized by the public body to provide that approval. For members of the Legislative Assembly, the written approval must be provided by the President of the Senate, Speaker of the House, the designated majority or minority leaders of either chamber or appointed committees of the Legislative Assembly, unless the public body determines otherwise. [OAR 199-005-0020(3)(b)(C)]. For legislative staff members, the written approval must be provided by the staffer's supervisor (i.e., Representative Gomberg). [ORS 199-005-0020(3)(b)(A)].

Thus, ORS 244.020(7)(b)(H)(i) would allow you to accept the offer from the Consulate General of Isreal to cover the cost of food, travel, and lodging expenses for the fact-finding trip to Israel, so long as you obtain advance written approval that the trip is "officially sanctioned" or "officially designated" from the appropriate authorities within the Legislative Assembly, in accordance with rules adopted by that body.

Finally, as a legislator required to file an annual Statement of Economic Interest (SEI), you will be required to report the aggregate value of any paid expenses provided under ORS 244.020(7)(b)(H) on your 2025 SEI. As the source of the paid travel expenses, the Consulate General of Isreal should provide you with a notice or a summary of the expenses paid.
