### **Mission, Vision, and Objectives**

The mission of Oregon Commission for the Blind is to *Empower Oregonians who are Blind to Fully Engage in Life*. The agency provides vocational rehabilitation and independent living services to individuals who are blind, in partnership and collaboration with the Department of Human Services, Office of Vocational Rehabilitation Services (OVRs). We specialize in education for individuals who are blind (or have conditions which will progress to blindness) or those who have low vision (often due to age-related vision loss) to live independently and find and secure employment. Our consumers range in age from young adults to seniors.

Our vision is “Blindness without barriers: A state of inclusion for Oregonians with vision loss.”

### **Communication between the state agency and the tribes:**

Oregon Commission for the Blind is committed to ensuring equity in accessing services across Oregon, including among our citizens who are tribal members. As a part of our efforts, in collaboration with DHS/OVRs, we have established partnerships and/or cooperative agreements with the following tribes:

Confederated Tribes of Grand Ronde  
Klamath Tribes

Confederated Tribes of Siletz Indians of Oregon  
Confederated Tribes of the Umatilla Indian Reservation  
Confederated Tribes of the Warm Springs

In the past, we have provided an orientation and tour of our agency headquarters to the directors of Tribal Vocational Rehabilitation (TVR) for each tribe. The director of the Klamath Tribe toured our agency most recently.


In our Vocational Rehabilitation Program, we will share resources and case management services with our partners in Tribal Vocational Rehabilitation (TVR) Programs. This includes gaining access to specialized services available at the agency's Orientation and Career Center for the Blind where individuals gain skills such as cane travel, Braille, techniques of daily living, technology, and adaptive devices. We also have been able to offer work experience opportunities to assist individuals in preparing for employment in their home communities. The restrictions brought about by the COVID-19 pandemic have curtailed provision of face-to-face services, although services that can be provided remotely are readily available.

The following are some examples of our collaborations currently underway:

- Working with a pre-transition youth to provide career exploration services.
- Siletz: Some Pre-ETS outreach was provided with VRC and BRC at Chemawa Indian School. This was in collaboration with Siletz TVR. Students were presented with career exploration tools and exercises, and guest speakers.
- Warm Springs: Two shared clients engaged in separate work experiences. One client was a receptionist at the Office for Victims of Crimes and the other client is currently performing a work experience as a Janitor in response to the COVID-19 pandemic.

Thank you for the opportunity to provide this information. The Commission for the Blind looks forward to continued development of these important tribal relationships.
