15.1.2.3 CONCEALED HANDGUN HIT HANDLING PROCEDURES

If no criminal action is being initiated, no further action is necessary/authorized. However, pursuant to ORS 166.293 (4) the concealed handgun permit should be seized when the permit holder is being arrested or cited for a crime that can or would otherwise disqualify the person from being issued a concealed handgun license; such crimes are identified in ORS 166.291. Seized licenses must be returned to the issuing sheriff's office.
