<p>Statement of Need</p>	<p>The Oregon Lottery Commission has authorized, under its constitutional authority, a new Lottery game called Scoreboard. This game is scheduled to be offered to the public in the fall of 2019. Oregon law requires that the Lottery adopt rules governing all the games it offers including, but not limited to, rules about the type of games offered, the method for determining winners, how the game is distributed to the public, etc. (See, for example, ORS 461.210, 461.220, 461.230, 461.240, 461.250, and 461.260.)</p> <p>In addition to statutory requirements, Lottery needs to adopt rules to inform the public about the eligibility requirements to play Scoreboard, including, but not limited to, how to create a player account, how to access and play Scoreboard through a player account, and how Lottery pays prizes in games played digitally through a player account. Lottery also needs the public to be aware of prohibited practices and circumstances under which access to the player account or Scoreboard might be suspended or terminated.</p> <p>These rules provide the framework of all those processes and therefore are needed to ensure compliance with Oregon law and inform the public about player accounts and Scoreboard. This includes adopting new rules, amending current rules, and repealing rules about previous sports wagering games that are no longer offered.</p>

<p>Explanation and Justification of Temporary Rule</p>	<p>These rules needed to be in place when the Lottery's newest game, Scoreboard, and player accounts were offered to the public in mid-October 2019. Failure to act promptly and have rules about Scoreboard and player accounts in place would have resulted in serious prejudice to the public interest because the public would not be fully informed about the game and the respective rights and responsibilities of players and Lottery with respect to player accounts and Scoreboard. For example, critical issues such as eligibility for a player account or how to win a prize in Scoreboard would not be addressed in rule leading to uncertainty for players, the public, and Lottery. Therefore, Lottery needed to take immediate action to adopt temporary rules in time for the launch of Scoreboard and player accounts.</p> <p>Proceeding under ORS 183.335(5) was the most appropriate method for adopting, amending, and suspending the rules cited above because the Scoreboard game was developed and launched under a short timeline that did not provide enough lead time to send out draft rules for public comment. However, Lottery did share the temporary rules at public Lottery Commission meetings and with certain interested parties. Lottery looks forward to the public rulemaking process on these rules before the Commission considers permanent adoption.</p>
