**RE:** 2019 Report on Rulemaking

House Bill 4106 (2016) requires states agencies to report annually on permanent and temporary rulemaking actions. In 2019, the Oregon Watershed Enhancement Board conducted rulemaking on six agency rule divisions that permanently adopted, amended, or repealed a total of 75 rules. The table below provides details on what was accomplished in those rulemaking efforts. The Oregon Watershed Enhancement Board did not engage in any temporary rulemaking in 2019.
