## Oregon House Passes Senate Bill 426B After 2.5 Hours of Debate

**Salem, Ore.** – Today, the Oregon House passed <u>Senate Bill 426B</u> which would make Oregon the only state in the nation that holds owners liable for wages they already paid. While proponents of the bill claim this legislation solves wage theft in construction, it simply shifts the liability from bad actors to unknowing upper tier contractors and small business owners.

"At a time when Oregon's unfriendly business climate is well-documented – why would we add another deterrent to businesses that does not even get the heart of the issue? Under this bill, businesses that own their own property can be held liable for unpaid wages by subcontractors for work done on their property," **said Representative Elmer on the House floor.** "Senate Bill 426B does not fix the problem, it simply shifts the blame."

After rejecting a series of common sense amendments in the House Labor & Workplace Standards Committee, House Republicans proposed a <u>Minority Report</u> as an alternative approach to addressing <u>the heart of the issue</u>. The Minority Report would have removed all owners from liability, aligning Oregon with all other states, and provided a pathway to target unlicensed construction labor brokers.

House Republicans made motions to refer the legislation back to the House Committee on Labor & Workplace Standards and to the House Rules Committee for further consideration. Both motions failed.
