## **Dear Neighbors**

It is because of our veterans that we have a chance to live the American Dream. So, it is of the utmost importance that we pass legislation that creates opportunities

which give veterans a fair chance to experience the American dream that they have fought to preserve. It is for these reasons that I have been tediously working to pass a number of bills relating to veteran issues. And, today, I have the privilege of informing you about two bills that just passed the House floor.



## First, HB 3303-A, which gives disabled veterans preferential priorities in public contracting by providing them with an

**expanded chance at securing employment**, passed the House floor on April 23, 2015. I am grateful for the successful passage of House Bill 3303-A. Representative Gomberg and I co-sponsored this measure to foster increased opportunity for disabled veterans' seeking to build new dreams with their new circumstances. This is a small but critical thing that we can do to help veterans reintegrate into our communities.

Second, HCR 22, which honors the ultimate sacrifice made Army Specialist Taylor Daniel



Army Specialist Taylor Daniel Marks **Marks**, was passed on April 23, 2015. Army Specialist Taylor Daniel Marks was born on November 9, 1989, in Salem, Oregon. He moved to Monmouth and graduated from Central High School in 2008. Shortly after graduation, he enlisted in the Oregon National Guard as a linguist specialist. He had planned to enroll in the University of Oregon to study finance and Japanese. He was deployed to Iraq on June 19, 2009 with the 41<sup>st</sup> Infantry Brigade Combat Team. Army Specialist Taylor Marks died on August 28, 2009, from wounds sustained in an attack by insurgents in Rashid, Iraq. "Therefore, be it resolved by the Legislative Assembly of the State of Oregon: That we, the members of the Seventy-eighth Legislative Assembly, recognize and honor Army Specialist Taylor
