Here are other bills we passed in the 2022 session

HB 4064 (wildfire housing)

Streamlines local regulations on manufactured housing and clarifies that Oregonians can place prefabricated homes in mobile home parks, breaking down a barrier to more innovative housing options. The bill will also help Oregonians in manufactured housing parks rebuild from the 2020 Labor Day wildfires.

HB 4092 (Broadband bill)

Allows Oregon to take advantage of more than \$250 million in federal broadband funding. The bill will create a framework for future investments, strengthen state oversight and help develop broadband access at libraries across the state

HB 4015 (small business loans)

Increases access to loans for small businesses from \$100,000 to \$1 million, allowing for greater investments in small businesses and aspiring entrepreneurs across the state.

HB 4045

HB 4035 (healthcare affordability)

Stabilizes health care coverage for approximately 300,000 Oregonians on the Oregon Health Plan after the end of the pandemic public health emergency to maintain access to affordable health care for low-income Oregonians.

HB 4075 (criminal restitution)

Makes it easier for victims of crime, including small businesses, to seek restitution and be repaid for economic damages.

Provides grants to local and nonprofit corporations that agree to create a coordinated homeless response system.

SB 1579 (equity investment)

Establishes a program in Business Oregon to award grants to organizations helping increase access to capital, entrepreneurship supports, and land/homeownership for disadvantaged Oregonians.

SB 1536

Provides cooling devices to people in need and makes their installation easier, in preparation for extreme heat events.

SB 1564

Strengthens cannabis task force and allows counties to pause issuance of new hemp growing licenses for 2022 and 2023 growing seasons.

HB 4026

Directs the Oregon Department of Education to award grants to qualified wildfire-impacted school districts to cover funding decreases resulting from the displacement of students due to wildfire. The bill includes \$25 million in one-time funding to stabilize certain school districts impacted by the 2020 wildfires. The largest recipient from this bill is the Phoenix-Talent School District.

Requires, on or after January 1, 2023, officials of public bodies to grant news media representatives access to scenes of wildfires or natural disasters on public lands that are otherwise closed to public.

Establishes the Universal Representation Fund in the State Treasury to provide a statewide, integrated, universal navigation and representation system for immigration matters.

Investment in job training, workforce supports and career pathways in key sectors like health care, manufacturing, and construction. The package makes a range of investments in workforce across the state, including building up community college career pathway training programs, developing apprenticeship programs in health care and manufacturing, increasing opportunities for students to receive academic credit for skills or prior experience, and creating wrap-around supports and job placement services for disadvantaged Oregonians.
