### Certificate

Pursuant to the provisions of ORS 291.328, and acting under the authority of ORS 291.326(1)(a), (b), (c), (d); ORS 291.371; and ORS 291.375; this hereby certifies that the Emergency Board, meeting on November 18, 2025, took the following actions:

#### 1. Department of Human Services

Increased the Federal Funds expenditure limitation established for the Department of Human Services by section 3(8), chapter 610, Oregon Laws 2023, Oregon Eligibility Partnership, by \$22,000,000; increased the Other Funds expenditure limitation established for the Department of Human Services by section 2(6), chapter 610, Oregon Laws 2023, Aging and people with disabilities programs, by \$8,000,000; and, authorized the transfer of \$5,835,672 General Fund from the appropriation established for the Department of Human Services by section 1(6), chapter 610, Oregon Laws 2023, Aging and people with disabilities programs to the appropriation established for the Department of Human Services by section 1(7), chapter 610, Oregon Laws 2023, Intellectual/developmental disabilities programs, to close out the 2023-25 biennium budget.

#### 2. Oregon Health Authority

Increased the Other Funds expenditure limitation established for the Oregon Health Authority by section 8, chapter 591, Oregon Laws 2023, Oregon Educators Benefit Board, by \$7,000,000, from the Oregon Educators Revolving Fund to accommodate the recording of the unanticipated remaining expenditures for health care benefits through the end of the 2023-25 biennium.

#### 3. Department of Corrections

Allocated \$8,320,364 from the Emergency Fund established by section 1, chapter 628, Oregon Laws 2025, to supplement the appropriation made to the Department of Corrections by section 1(1), chapter 377, Oregon Laws 2023, Operations and health services, to cover healthcare costs for the 2023-25 biennium; authorized the transfer of \$878,298 General Fund from the appropriation established for the Department of Corrections by section 1(3), chapter 377, Oregon Laws 2023, Correctional services, to the appropriation established for the Department of Corrections by section 1(1), chapter 377, Oregon Laws 2023, Operations and health services; authorized the transfer of \$88,853 General Fund from the appropriation established for the Department of Corrections by section 1(4), chapter 377, Oregon Laws 2023, Community corrections, to the appropriation established for the Department of Corrections by section 1(1), chapter 377, Oregon Laws

2023, Operations and health services; authorized the transfer of \$91,570 General Fund from the appropriation established for the Department of Corrections by section 1(6), chapter 377, Oregon Laws 2023, Capital improvements, to the appropriation established for the Department of Corrections by section 1(1), chapter 377, Oregon Laws 2023, Operations and health services; and authorized the transfer of \$51,147 General Fund from the appropriation established for the Department of Corrections by section 1(4), chapter 377, Oregon Laws 2023, Community corrections, to the appropriation established for the Department of Corrections by section 1(2), chapter 377, Oregon Laws 2023, Central administration and administrative services, to rebalance division budgets for the 2023-25 biennium.

**4. Department of Emergency Management**

Allocated \$2,500,000 from the special appropriation made to the Emergency Board by section 5(1), chapter 628, Oregon Laws 2025, to supplement the appropriation made to the Oregon Department of Emergency Management by section 1(3), chapter 423, Oregon Laws 2025, Mitigation and Recovery, for the 2025 Rowena wildfire cleanup.

**5. Oregon Health Authority**

Allocated \$6,750,000 from the Emergency Fund established by section 1, chapter 628, Oregon Laws 2025, to supplement the appropriation made to the Oregon Health Authority by section 1(1), chapter 587, Oregon Laws 2025, Medicaid; and allocated \$750,000 from the Emergency Fund established by section 1, chapter 628, Oregon Laws 2025, to supplement the appropriation made to the Oregon Health Authority by section 1(4), chapter 587, Oregon Laws 2025, Public health, to facilitate payments to Planned Parenthood affiliates in Oregon for reproductive health services.
