# Forestry

## Background

Oregon Revised Statutes (ORS) 527.610 to 527.770, 527.990(1) and 527.992 make up the Oregon Forest Practices Act. Passage of HOUSE BILL 1624 (1971) integrated the Act into the then current forestry laws (Ch. 316, Oregon Laws 1971). In 1972, the Board of Forestry developed and adopted the first implementing administrative rules for the Act.

The purpose of Oregon's Forest Practices Act is "to encourage economically efficient forest practices that ensure the continuous growing and harvesting of forest tree species and the maintenance of forestland for such purposes as the leading use on privately owned land, consistent with sound management of soil, air, water, fish and wildlife resources and scenic resources." The State Board of Forestry oversees the Forest Practices Act, establishes policy, and works with the Department of Forestry on implementation.

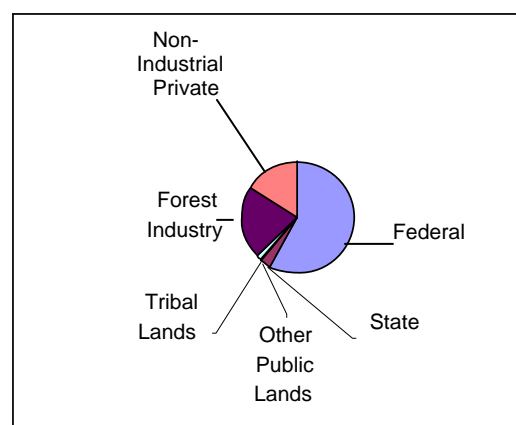
The State Board of Forestry is a seven-member citizen board, appointed by the Governor and confirmed by the Senate. No more than three members may receive any significant portion of their income from the forest products industry. At least one member must reside in each of the state's three major Department of Forestry administrative regions — east, south and northwest. The term of office is four years and no member may serve more than two consecutive full terms. The State Forester serves as Board Secretary.

There are five state forests within Oregon: the Clatsop, Tillamook, Santiam, Elliott, and Sun Pass. In order to manage these forests, the Board of Forestry created seven districts: Astoria (Clatsop State Forest); Tillamook (western part of the Tillamook State Forest); Forest Grove (eastern part of the Tillamook State Forest); Clackamas-Marion (Santiam State Forest); Western Oregon (scattered state forestland in Benton, Polk, and Lincoln Counties); Western Lane (scattered state forestland in Lane County); and the Southwest Oregon District (scattered state forestland in Josephine, Douglas, Jackson and Curry counties).
