

# 2026 Immigrant Justice Bills

---

## **HB 4114: Protect Your Door Act | Rep Muñoz**

Masked federal agents are conducting raids across Oregon—refusing to identify themselves, ordering residents to open doors at all hours, and targeting people at courthouses, hospitals, and in homes. This bill requires the federal government to register their operation in advance with the Oregon DOJ, mandates visible agency ID, and provides an ability to receive compensation (\$10,000–\$100,000) for victims of violations of this law.

## **HB 4138: LEAVA: Law Enforcement Accountability and Visibility Act | Rep Chaichi**

This bill bans masks on law enforcement during operations, ensuring Oregonians know who is detaining them. It will also create a firewall between public employees and the federal government and increase public transparency into joint federal task forces.

## **SJR 203\*: No Secret Police | Senator Manning, Rep Andersen, and Rep Javadi**

This constitutional amendment would ban the use of masks by law enforcement officers and would require law enforcement officers to wear uniforms with badge numbers, except for undercover operations and SWAT teams. If passed by the Legislature, the amendment will go before the voters in the 2026 November General Election.

## **HB 4079: Safeguarding Students and Families | Rep Finger McDonald**

This bill requires that Oregon's public schools, K-12 and higher ed, notify families, students, and staff when the presence of immigration agents is verified on school grounds or campuses. When our schools, colleges, and universities verify that ICE or other immigration agents are on their grounds, they let the school community know.

### **HB 4111: Anti-Discrimination Protections | Rep Chotzen**

This bill stops employer retaliation due to immigrant status, strengthens anti-profiling law, and blocks irrelevant immigration status from being used in civil cases like family court, wage theft, or discrimination cases.

### **SB 1587: Stop Data Brokers from Sharing Our Info | Senator Campos**

Private companies are selling Oregonians' personal data directly to the federal government, enabling targeted surveillance. The federal government then uses this information to target people for violations of civil law, often without obtaining a warrant to access this information. This bill closes this loophole and cuts off the pipeline.

### **HB 4150: Public Contracts Prohibitions | Rep Wise**

Oregon taxpayer dollars should not fund family separation. This bill requires companies seeking state contracts to certify that they do not conduct business with the federal government for deportation or immigration enforcement.

### **HB 4123: Landlord-Tenant Confidentiality | Rep Marsh**

There is currently no Oregon landlord-tenant law providing confidentiality protections for sensitive information, including immigration status. This bill adds a provision that personally identifying, financially sensitive, and other private information may not be disclosed without the written consent of the tenant, unless in response to a court order.

### **SB 1570: Protections in Health Care Settings | Sen Campos**

Federal Department of Homeland Security (DHS) Agents (e.g. CBP and ICE) currently have unregulated access to public hospitals in the state of Oregon. This bill aims to ensure all people can seek medical care without fear of unreasonable immigration enforcement inside protected parts of healthcare facilities, and to provide protective guidance and consistency for the healthcare workers treating their patients.
