

Notice of Work- Exterior Marble Investigation

To: Capitol Building

From: Oregon State Capitol Renovation (OSCR) Team

Date: May 30, 2014

The following OSCR project team members will be working throughout the building:

• Several representatives from Pioneer Waterproofing, JE Dunn, a representative from Capitol Facility Services and Architectural Resources Group (ARG)

Date and time of work:

- Tuesday, June 3rd, 2014 through Friday, June 6th, 2014
- Between the hours of 7:00 a.m. and 5:00 p.m. daily

Location of work:

• Roof of the Senate wing

Work to be performed:

- The team will be temporarily removing 4 pieces of marble from the roof of the Senate wing to allow ARG to investigate the marble staining, anchors and connections.
- On Tuesday, June 3rd <u>before</u> 8:00 a.m., 2-4 representatives from Pioneer Waterproofing and JE Dunn will install plywood and Styrofoam roof protection. These materials will be brought up to the roof using the path outlined in the diagrams below.
- On Wednesday, June 4th the team from Pioneer Waterproofing will be installing the scaffolding on the roof. The materials and equipment for this work will be brought up to the roof using the path outlined in the diagrams below.
- The marble pieces will be removed on June 4th and safely staged on Styrofoam blocks to protect the marble and roof until ARG has completed their investigation.
- The team is anticipating that investigations will be completed and the marble to be reinstalled by end of day on Friday, June 6th.

Impacts:

- There should be very minimal noise impacts from this work. Those working on the 4th floor of the Senate wing may hear footsteps from the work crews on the roof and possibly some cutting/ sawing sounds while the crews are removing the marble from the building.
- Those working on the 4th floor of the Senate Wing will likely see members of the team as they travel between the roof and the Capitol garage, where materials are being stored for this work. Please see the attached diagrams for more information the path they will be taking to get from the Capitol garage to the roof.
- The small Senate elevator will be padded to prevent damage from investigation materials/ equipment and a carpet mat system will be put down to prevent the team from spreading dirt and debris.

Purpose of work:

• This work is being done to get a better understanding of what is causing the staining on the exterior marble and potential remedies for the staining.


