The proposed amendments to Senate Rule 8.05 were read and distributed:

8.05 Committee Appointments.

(1) The President shall establish standing committees to operate during the Long Session, interim committees to operate during the interim periods, and standing committees to operate during the Short Session. ~~The President shall appoint a Special Committee on Conduct, pursuant to Legislative Branch Personnel Rule 27.~~ The President may establish ~~other~~ special committees and conference committees. The Senate Committee on Conduct shall be approved by a majority vote of the Senate.

(2) Members of all committees, and the chairs and vice chairs thereof, shall be appointed by the President. This provision does not apply to the Senate Committee on Conduct.

(3) The President shall appoint members to other committees as necessary or as required by law.

(4) The President shall be an *ex officio* member of each committee and have the power to vote. As an *ex officio* member on committees the President does not increase the size of the respective committees, but is counted for purposes of a quorum. *Ex officio* membership does not increase the number of members required to provide a quorum. This provision does not apply to the Senate Committee on Conduct.
