Democratic Legislators Dive Deep Next Week to Map Out Options for a Safe, Thriving Future in Oregon

Committees meet Nov. 17 to 19 on growing Oregon and defending the state amid federal turbulence

SALEM, OR – Oregon House and Senate Democrats will bring experts, advocates, and government professionals before legislative committees next week for problem-solving and accountability on issues that matter to all Oregonians. From stabilizing the state budget and maximizing the effectiveness of public services to examining housing production and child care options, legislators will use the November committee days to prepare for an upcoming 2026 legislative session that will require a focus on growing Oregon's economic future, as well as smart defenses against Trump administration attacks on the rights and freedoms of Oregonians.

"The Trump administration has destroyed an American tradition of partnership between national and state governments serving the public. Congressional Republicans have slashed Medicaid and SNAP, wrecking our economy and making life harder for everyday Oregonians," said **Oregon Senate Majority Leader Kayse Jama (D – East Portland, Boring & Damascus)**. "The testimony in next week's hearings will help us grow better jobs in our local economy; bring down costs for housing, health care, and food; and protect Oregonians from federal aggressions."

"While the federal government cuts access to health care, slashes food assistance, and increases costs with tariffs, Oregon is focused on delivering for working families and showing what responsible governance looks like," said **House Majority Leader Ben Bowman (D-Tigard, Metzger, & S. Beaverton)**. "Next week's hearings will be key to understanding the harmful impact of the Trump Administration's actions and guiding our work to shield families and working Oregonians from federal instability."
