Bi-Partisan Wildfire Mitigation Funding Package Gains Momentum

Legislators Join Together to Support the Oregon Forest Fire and Resilience Investment Package

Salem, OR. – As Oregon prepares for another wildfire season, state legislators from both parties are joining together to support a bipartisan, common-sense funding package that serves to create resilient landscapes and fire-adapted communities, while also providing a safe and effective wildfire response.

"The recent wildfires in Oregon have revealed a need for more firefighting resources and the development of community and landscape resiliency," explained Rep. Pam Marsh (D-Southern Jackson County). "We can greatly enhance fire protection capacity within the Oregon Department of Forestry and make smart investments for reducing fire risk and smoke impacts, while creating and sustaining healthy forests and communities. There are critical, near-term investments that will leverage partnerships between state and federal governments, community leaders, forest collaboratives, and diverse expertise in the nonprofit and business communities," she noted.

The bipartisan, four-part investment package: 1) invests in initial attack resources to keep fires small; 2) provides additional funding and staffing for the Oregon Department of Forestry to implement fire protection and preparedness in targeted, at-risk communities and landscapes, while investing in staff to protect forest resources and public safety; 3) funds and implements a "Community Resiliency and Smoke Impact Mitigation Grant Program" in at-risk communities; and 4) funds a landscape analysis of wildfire risk and develops mitigation strategies to help strategically target investments to reduce the risk to priority landscapes and associated communities. The package includes \$6.8 million to support these four components.

"Last summer, Southern Oregon suffered through six weeks of choking smoke and near misses," said Rep Pam Marsh. "A month later we all watched from a distance as Paradise, California, a town much like many communities in our region, burned to the ground. Smoke and fire threaten Oregon's health, economy, and future. We can and must act now to create more resilient communities and forests."

Recent wildfires in Oregon have revealed a need for more firefighting resources and the development of community and landscape resiliency. Oregon wildfires cost a record \$514M in 2018, exceeding the record \$447M in 2017. Trends and future projections indicate strong

likelihood of hotter summers and extended fire seasons, continuing a trend in more large wildfires and associated wildfire smoke. Increased fire frequency threatens the intersection between homes and forested landscapes, known as the "wildland-urban interface," and places human health and safety at risk.

"The Oregon Forest Fire and Resilience Investment Package mirrors the three goals of the National Cohesive Wildland Fire Management Strategy," said Rep David Brock Smith (R-Port Orford). "Those goals focus on creating resilient forest landscapes, fire adapted communities, and effective wildfire response to protect our residents. The package will also assist with implementation of our previous Good Neighbor Authority legislation. Oregon has a long way to go to achieve these objectives, but the Investment Package is a good step forward for our communities and their residents."

"We cannot change the risk our communities face from uncontrolled wildfire overnight," Rep. Marsh said. "But we can take science-based and solution-oriented steps now to restore our forests and reduce our communities' exposure to wildfire and smoke. I invite my colleagues in Salem to join us in supporting the Oregon Forest Fire and Resilience Investment Package."
